17	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:		
18	SECTION 1. NEW LAW A new section of law to be codified		
19	in the Oklahoma Statutes as Section 3-145.8 of Title 70, unless

21	A. It shall be the duty of each virtual charter school approved

to keep a full and complete record of the attendance of all students enrolled in the virtual charter school.

- B. By July 1, 2017, the governing body of each virtual charter school shall adopt an attendance policy. The attendance policy shall include the following provisions:
- 1. A student who attends a virtual charter school shall be considered in attendance for a quarter if the student:
 - a. completes instructional activities on no less than ninety percent (90%) of the days within the quarter, or
 - b. is on pace for on-time completion of the course as defined by the governing board of the virtual charter school.
- 2. For a student who does not meet either of the criteria set forth in paragraph 1 of this subsection, the number of recorded absences shall be the lesser of:
 - a. the number of school days during which the student did not complete the instructional activities during the quarter, and
 - b. the number of school days proportional to the percentage of the course that has not been completed.
- C. For the purposes of this section, "instructional activities" shall include but not be limited to online logins to curriculum or programs offered by the virtual charter school, offline activities,

- D. The virtual charter school shall submit a report to the parent or legal guardian of a student who has accumulated ten (10) absences.
- E. The Statewide Virtual Charter School Board shall promulgate rules to implement the provisions of this section.
- SECTION 2. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
