- SECTION 2. AMENDATORY Section 3, Chapter 40, O.S.L. 2013 8 9 (63 O.S. Supp. 2016, Section 1-1440.2), is amended to read as 10 follows:
- 11 Section 1-1440.2. A. A home food establishment may sell 12 prepared food on site, by delivery, at a farmers market, through a cooperative, or through a membership-based buying club. The 13 Oklahoma Department of Agriculture, Food, and Forestry may 14 15 promulgate rules to allow sales at other locations or by other 16 means.

- A person operating a home food establishment shall be exempt from the licensing and other requirements of the State Department of Health. The Department, however, shall be permitted to request written documentation in order to verify the gross annual sales of a home food establishment.
- C. The Oklahoma Department of Agriculture, Food, and Forestry 22 23 may, upon a consumer complaint, request written documentation to 24 verify the gross annual sales of a home food establishment.
