7 FLOOR SUBSTITUTE

8 An Act relating to schools; amending 70 O.S. 2011,
9 Section 1-116.2, which relates to administration of
10 medicine to students; allowing certain school
11 employees to assist in applying certain sunscreen;
12 requiring public schools to permit a student to apply
13 sunscreen without certain authorization; providing a
14 definition; requiring a school to keep certain
15 authorization on file; providing an effective date;
16 and declaring an emergency.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. AMENDATORY 70 O.S. 2011, Section 1-116.2, is
19 amended to read as follows:

20 Section 1-116.2. A. A school nurse, or in the absence of such
21 nurse, an administrator or designated school employees, pursuant to
22 the written authorization of the parent or guardian of the student,
23 may ~~administer~~:

- 24 1. A Administer a nonprescription medicine; and
2. Assist a student in applying sunscreen, a compound topically
applied to prevent a sunburn; and

1 ~~2.~~ 3. Administer a filled prescription medicine as that term
2 is defined by Section 353.1 of Title 59 of the Oklahoma Statutes
3 pursuant to the directions for the administration of the medicine
4 listed on the label or as otherwise authorized by a licensed
5 physician.

6 B. In addition to the persons authorized to administer
7 nonprescription medicine and filled prescription medicine pursuant
8 to the provisions of subsection A of this section, a nurse employed
9 by a county health department and subject to an agreement made
10 between the county health department and the school district for
11 medical services, may administer nonprescription medicine and filled
12 prescription medicine pursuant to the provisions of this section.

13 C. Each school in which any medicine is administered pursuant
14 to the provisions of subsection A of this section shall keep a
15 record of the name of the student to whom the medicine was
16 administered, the date the medicine was administered, the name of
17 the person who administered the medicine, and the type or name of
18 the medicine which was administered.

19 D. Medicine to be administered by the county or school nurse,
20 administrator or the designated persons and which is stored at the
21 school shall be properly stored and not readily accessible to
22 persons other than the persons who will administer the medication.

23 E. 1. A public school shall permit a student to possess and
24 self-apply sunscreen that is regulated by the Food and Drug

1 Administration without the written authorization of a parent, legal
2 guardian or physician.

3 2. As used in this subsection, "sunscreen" means a compound
4 topically applied to prevent sunburn.

5 F. The school shall keep on file the written authorization of
6 the parent or guardian of the student to administer medicine to the
7 student or to apply sunscreen on the student.

8 ~~F.~~ G. A school nurse, county nurse, administrator~~r~~ or the
9 designated school employees shall not be liable to the student or a
10 parent or guardian of the student for civil damages for any personal
11 injuries to the student which result from acts or omissions of the
12 school or county nurse, administrator~~r~~ or designated school
13 employees in administering any medicine pursuant to the provisions
14 of this section. This immunity shall not apply to acts or omissions
15 constituting gross, willful~~r~~ or wanton negligence.

16 SECTION 2. This act shall become effective July 1, 2018.

17 SECTION 3. It being immediately necessary for the preservation
18 of the public peace, health or safety, an emergency is hereby
19 declared to exist, by reason whereof this act shall take effect and
20 be in full force from and after its passage and approval.
