8 [Joint Resolution - proposed amendment to Article I
9 of the Oklahoma Constitution - proof of identity -
10 ballot title - filing - special election]

12 BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
13 1ST SESSION OF THE 56TH OKLAHOMA LEGISLATURE:

14 SECTION 1. The Secretary of State shall refer to the people for
15 their approval or rejection, as and in the manner provided by law,
16 the following proposed amendment to the Oklahoma Constitution by
17 adding a new Section 8 to Article I to read as follows:

18 Section 8. A. Each person appearing to vote shall provide
19 proof of identity, whereupon the appropriate election official shall
20 verify the person's eligibility to vote, as provided by law.

21 B. The Legislature shall have the authority to enact such laws
22 as may be necessary to implement the provisions of this section.

23 SECTION 2. A special election is hereby ordered to be held
24 throughout the State of Oklahoma on the date of the next statewide

1 primary election or special election, whichever occurs first, at
2 which time the proposed amendment to the Constitution of the State
3 of Oklahoma, as set forth in SECTION 1 of this resolution, shall be
4 submitted to the people of Oklahoma for their approval or rejection
5 as and in the manner provided by law.

6 SECTION 3. The Ballot Title for the proposed Constitutional
7 amendment as set forth in SECTION 1 of this resolution shall be in
8 the following form:

9 BALLOT TITLE

10 Legislative Referendum No. _____ State Question No. _____

11 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

12 This measure would enact a new Section 8 in Article 1 of the
13 Oklahoma Constitution. It would require each person appearing
14 to vote to provide proof of identity. The appropriate election
15 official would verify the person's eligibility to vote. The
16 Legislature would enact laws to implement the provisions of the
17 new section.
