14 BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
15 2ND SESSION OF THE 56TH OKLAHOMA LEGISLATURE:

16 SECTION 1. The Secretary of State shall refer to the people for
17 their approval or rejection, as and in the manner provided by law,
18 the question, pursuant specifically to Section 2 of Article XXIV of
19 the Oklahoma Constitution, of calling a Constitutional Convention
20 which shall be authorized to propose alterations, revisions or
21 amendments to the Oklahoma Constitution or to propose a new
22 Constitution for the State of Oklahoma.

2 amendment as set forth in SECTION 1 of this resolution shall be in
