8                                   AS INTRODUCED

9                   An Act relating to professions and occupations;  
10                   amending 59 O.S. 2011, Section 353.1a, which relates  
11                   to prescribing authority of advanced practice  
12                   registered nurse; removing supervisory physician  
13                   requirement; updating statutory references; removing  
14                   requirement that certain information be identified;  
15                   amending 59 O.S. 2011, Section 567.3a, which relates  
16                   to definitions used in the Oklahoma Nursing Practice  
17                   Act; modifying and deleting certain definitions;  
18                   amending 59 O.S. 2011, Section 567.4a, which relates  
19                   to prescriptive authority; permitting Oklahoma Board  
20                   of Nursing to grant and limit prescribing and  
21                   ordering authority to certain licensees; deleting  
22                   requirements of certain rules promulgated by the  
23                   Board; amending 59 O.S. 2011, Section 567.5a as  
24                   amended by Section 2, Chapter 228, O.S.L. 2013 (59  
O.S. Supp. 2016, Section 567.5a), which relates to  
license to practice as Advanced Practice Registered  
Nurse; removing requirement to submit certain  
statement from Oklahoma physician; amending 63 O.S.  
2011, Section 2-312, which relates to the authority  
to prescribe controlled dangerous substances;  
updating statutory references; providing advanced  
practice registered nurse may only dispense  
controlled dangerous substances pursuant to certain  
provisions; repealing 59 O.S. 2011, Section 567.4b,  
which relates to the Formulary Advisory Council; and  
providing an effective date.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 SECTION 1. AMENDATORY 59 O.S. 2011, Section 353.1a, is  
3 amended to read as follows:

4 Section 353.1a Prescribing authority shall be allowed, ~~under~~  
5 ~~the medical direction of a supervising physician,~~ for an advanced  
6 practice nurse recognized by the Oklahoma Board of Nursing in one of  
7 the following categories: ~~advanced registered~~ certified nurse  
8 practitioners, clinical nurse specialists, or certified nurse-  
9 midwives. The advanced practice nurse may write or sign, or  
10 transmit by word of mouth, telephone or other means of communication  
11 an order for drugs or medical supplies that is intended to be  
12 filled, compounded, or dispensed by a pharmacist. ~~The supervising~~  
13 ~~physician and the advanced practice nurse shall be identified at the~~  
14 ~~time of origination of the prescription and the name of the advanced~~  
15 ~~practice nurse shall be printed on the prescription label.~~

16 SECTION 2. AMENDATORY 59 O.S. 2011, Section 567.3a, is  
17 amended to read as follows:

18 Section 567.3a As used in the Oklahoma Nursing Practice Act:

- 19 1. "Board" means the Oklahoma Board of Nursing;
- 20 2. "The practice of nursing" means the performance of services  
21 provided for purposes of nursing diagnosis and treatment of human  
22 responses to actual or potential health problems consistent with  
23 educational preparation. Knowledge and skill are the basis for  
24 assessment, analysis, planning, intervention, and evaluation used in

1 the promotion and maintenance of health and nursing management of  
2 illness, injury, infirmity, restoration or optimal function, or  
3 death with dignity. Practice is based on understanding the human  
4 condition across the human lifespan and understanding the  
5 relationship of the individual within the environment. This  
6 practice includes execution of the medical regime including the  
7 administration of medications and treatments prescribed by any  
8 person authorized by state law to so prescribe;

9 3. "Registered nursing" means the practice of the full scope of  
10 nursing which includes, but is not limited to:

- 11 a. assessing the health status of individuals, families  
12 and groups,
- 13 b. analyzing assessment data to determine nursing care  
14 needs,
- 15 c. establishing goals to meet identified health care  
16 needs,
- 17 d. planning a strategy of care,
- 18 e. establishing priorities of nursing intervention to  
19 implement the strategy of care,
- 20 f. implementing the strategy of care,
- 21 g. delegating such tasks as may safely be performed by  
22 others, consistent with educational preparation and  
23 that do not conflict with the provisions of the  
24 Oklahoma Nursing Practice Act,

- 1           h. providing safe and effective nursing care rendered
- 2                 directly or indirectly,
- 3           i. evaluating responses to interventions,
- 4           j. teaching the principles and practice of nursing,
- 5           k. managing and supervising the practice of nursing,
- 6           l. collaborating with other health professionals in the
- 7                 management of health care,
- 8           m. performing additional nursing functions in accordance
- 9                 with knowledge and skills acquired beyond basic
- 10                 nursing preparation, and
- 11           n. delegating those nursing tasks as defined in the rules
- 12                 of the Board that may be performed by an advanced
- 13                 unlicensed assistive person;

14           4. "Licensed practical nursing" means the practice of nursing  
15 under the supervision or direction of a registered nurse, licensed  
16 physician or dentist. This directed scope of nursing practice  
17 includes, but is not limited to:

- 18           a. contributing to the assessment of the health status of
- 19                 individuals and groups,
- 20           b. participating in the development and modification of
- 21                 the plan of care,
- 22           c. implementing the appropriate aspects of the plan of
- 23                 care,

- d. delegating such tasks as may safely be performed by others, consistent with educational preparation and that do not conflict with the Oklahoma Nursing Practice Act,
- e. providing safe and effective nursing care rendered directly or indirectly,
- f. participating in the evaluation of responses to interventions,
- g. teaching basic nursing skills and related principles,
- h. performing additional nursing procedures in accordance with knowledge and skills acquired through education beyond nursing preparation, and
- i. delegating those nursing tasks as defined in the rules of the Board that may be performed by an advanced unlicensed assistive person;

5. "Advanced Practice Registered Nurse" means a licensed Registered Nurse:

- a. who has completed an advanced practice registered nursing education program in preparation for one of four recognized advanced practice registered nurse roles,
- b. who has passed a national certification examination recognized by the Board that measures the advanced practice registered nurse role and specialty

1 competencies and who maintains recertification in the  
2 role and specialty through a national certification  
3 program,

4 c. who has acquired advanced clinical knowledge and  
5 skills in preparation for providing both direct and  
6 indirect care to patients; however, the defining  
7 factor for all Advanced Practice Registered Nurses is  
8 that a significant component of the education and  
9 practice focuses on direct care of individuals,

10 d. whose practice builds on the competencies of  
11 Registered Nurses by demonstrating a greater depth and  
12 breadth of knowledge, a greater synthesis of data, and  
13 increased complexity of skills and interventions, and

14 e. who has been educationally prepared to assume  
15 responsibility and accountability for health promotion  
16 and/or maintenance as well as the assessment,  
17 diagnosis and management of patient problems which may  
18 include the use and prescription of pharmacological  
19 and nonpharmacological interventions,

20 f. who has clinical experience of sufficient depth and  
21 breadth to reflect the license, and

22 g. who has obtained a license as an Advanced Practice  
23 Registered Nurse in one of the following roles:

24 Certified Registered Nurse Anesthetist, Certified

1 Nurse-Midwife, Clinical Nurse Specialist, or Certified  
2 Nurse Practitioner.

3 Practicing as an Advanced Practice Registered Nurse means an  
4 expanded scope of nursing in a role and population focus approved by  
5 the Board, with or without compensation or personal profit, and  
6 includes the registered nurse scope of practice. The scope of an  
7 Advanced Practice Registered Nurse may include, but is not limited  
8 to, performing acts of advanced assessment; diagnosing; prescribing  
9 and ordering nonpharmacological interventions, including, but not  
10 limited to, durable medical equipment, medical devices, nutrition,  
11 blood and blood products; and supportive services, including, but  
12 not limited to, home health care, hospice and physical and  
13 occupational therapy. Advanced Practice Registered Nurses may serve  
14 as primary care providers of record.

15 Advanced Practice Registered Nurses are expected to practice as  
16 licensed practitioners within standards established and/or  
17 recognized by the Board. Each Advanced Practice Registered Nurse is  
18 accountable to patients, the nursing profession and the Board for  
19 complying with the requirements of the Oklahoma Nursing Practice Act  
20 and accountable for the quality of advanced nursing care rendered,  
21 for recognizing limits of knowledge and experience, for planning for  
22 the management of situations beyond the Advanced Practice Registered  
23 Nurse's expertise and for consulting with or referring patients to  
24 other health care providers, as appropriate.

1        Only those persons who hold a license to practice advanced  
2 practice registered nursing in this state shall have the right to  
3 use the title "Advanced Practice Registered Nurse" and to use the  
4 abbreviation "APRN". Only those persons who have obtained a license  
5 in the following disciplines shall have the right to fulfill the  
6 roles and use the applicable titles: Certified Registered Nurse  
7 Anesthetist and the abbreviation "CRNA", Certified Nurse-Midwife and  
8 the abbreviation "CNM", Clinical Nurse Specialist and the  
9 abbreviation "CNS", and Certified Nurse Practitioner and the  
10 abbreviation "CNP".

11        It shall be unlawful for any person to assume the role or use  
12 the title Advanced Practice Registered Nurse or use the abbreviation  
13 "APRN" or use the respective specialty role titles and abbreviations  
14 or to use any other titles or abbreviations that would reasonably  
15 lead a person to believe the user is an Advanced Practice Registered  
16 Nurse, unless permitted by this act. Any individual doing so shall  
17 be guilty of a misdemeanor, which shall be punishable, upon  
18 conviction, by imprisonment in the county jail for not more than one  
19 (1) year or by a fine of not less than One Hundred Dollars (\$100.00)  
20 nor more than One Thousand Dollars (\$1,000.00), or by both such  
21 imprisonment and fine for each offense;

22        6. "Certified Nurse Practitioner" is an Advanced Practice  
23 Registered Nurse who ~~performs in an expanded role in the delivery of~~  
24 ~~health care:~~

- 1           a. ~~consistent with advanced educational preparation as a~~  
2           ~~Certified Nurse Practitioner in an area of specialty,~~  
3           b. ~~functions within the Certified Nurse Practitioner~~  
4           ~~scope of practice for the selected area of~~  
5           ~~specialization, and~~  
6           c. ~~is in accord with the standards for Certified Nurse~~  
7           ~~Practitioners as identified by the certifying body and~~  
8           ~~approved by the Board~~

9 is prepared to function as a licensed practitioner, providing  
10 primary or acute care in accordance with education and specialty  
11 certification, along the wellness-illness continuum to a specific  
12 population in diverse settings. The Certified Nurse Practitioner  
13 diagnoses and treats patients with undifferentiated symptoms as well  
14 as those with established diagnoses. The Certified Nurse  
15 Practitioner practices in accordance with the standards for  
16 certified nurse practitioner practice as defined by the professional  
17 associations recognized by the Board.

18           A Certified Nurse Practitioner shall be eligible, in accordance  
19 with the scope of practice of the Certified Nurse Practitioner, to  
20 obtain recognition as authorized by the Board to prescribe and  
21 order, as defined by the rules promulgated by the Board pursuant to  
22 this section ~~and subject to the medical direction of a supervising~~  
23 ~~physician~~. This authorization shall not include dispensing drugs,  
24 but shall not preclude, subject to federal regulations, the receipt

1 of, the signing for, or the dispensing of professional samples to  
2 patients.

3 The Certified Nurse Practitioner accepts responsibility,  
4 accountability, and obligation to practice in accordance with usual  
5 and customary advanced practice registered nursing standards and  
6 functions as defined by the scope of practice/role definition  
7 statements for the Certified Nurse Practitioner;

8 7. a. "Clinical Nurse Specialist" is an Advanced Practice  
9 Registered Nurse who holds:

- 10 ~~(1) a master's degree or higher in nursing with~~  
11 ~~clinical specialization preparation to function~~  
12 ~~in an expanded role,~~
- 13 ~~(2) specialty certification from a national~~  
14 ~~certifying organization recognized by the Board,~~
- 15 ~~(3) a certificate of recognition from the Board, and~~
- 16 ~~(4) any nurse holding a specialty certification as a~~  
17 ~~Clinical Nurse Specialist valid on January 1,~~  
18 ~~1994, granted by a national certifying~~  
19 ~~organization recognized by the Board, shall be~~  
20 ~~deemed to be a Clinical Nurse Specialist under~~  
21 ~~the provisions of the Oklahoma Nursing Practice~~  
22 ~~Act.~~

23  
24

1           ~~b. In the expanded role, the Clinical Nurse Specialist~~  
2           ~~performs at an advanced practice level which shall~~  
3           ~~include, but not be limited to:~~

4           ~~(1) practicing as an expert clinician in the~~  
5           ~~provision of direct nursing care to a selected~~  
6           ~~population of patients or clients in any setting,~~  
7           ~~including private practice,~~

8           ~~(2) managing the care of patients or clients with~~  
9           ~~complex nursing problems,~~

10          ~~(3) enhancing patient or client care by integrating~~  
11          ~~the competencies of clinical practice, education,~~  
12          ~~consultation, and research, and~~

13          ~~(4) referring patients or clients to other services~~  
14          as a licensed practitioner, diagnosing and treating  
15          patients with undifferentiated symptoms as well as  
16          those with established diagnoses, in a specialized  
17          area of nursing practice to specific populations in  
18          diverse settings. The Clinical Nurse Specialist  
19          practices in accordance with the standards for  
20          clinical nurse specialist practice as defined by the  
21          professional associations recognized by the Board.

22          ~~e. b. A Clinical Nurse Specialist in accordance with the~~  
23          ~~scope of practice of such Clinical Nurse Specialist~~  
24          ~~shall be eligible to obtain recognition as authorized~~

1 by the Board to prescribe and order, as defined by the  
2 rules promulgated by the Board pursuant to this  
3 section, ~~and subject to the medical direction of a~~  
4 ~~supervising physician~~. This authorization shall not  
5 include dispensing drugs, but shall not preclude,  
6 subject to federal regulations, the receipt of, the  
7 signing for, or the dispensing of professional samples  
8 to patients.

9 ~~d.~~ c. The Clinical Nurse Specialist accepts responsibility,  
10 accountability, and obligation to practice in  
11 accordance with usual and customary advanced practice  
12 nursing standards and functions as defined by the  
13 scope of practice/role definition statements for the  
14 Clinical Nurse Specialist;

15 8. "Nurse-Midwife" is ~~a qualified registered nurse who has~~  
16 ~~received a certificate of recognition from the Oklahoma Board of~~  
17 ~~Nursing who possesses evidence of certification according to the~~  
18 ~~requirements of the American College of Nurse-Midwives~~ an Advanced  
19 Practice Registered Nurse who is prepared to function as a licensed  
20 practitioner providing a full range of primary health care services  
21 in diverse settings to women throughout the lifespan, including  
22 gynecologic care, family planning services, preconception care,  
23 prenatal and postpartum care, childbirth, care of the newborn and  
24 treating the male partner of female patients for sexually

1 transmitted infection and reproductive health. The Certified Nurse-  
2 Midwife practices in accordance with the standards for nurse-midwife  
3 practice as defined by the professional associations recognized by  
4 the Board.

5 A Certified Nurse-Midwife in accordance with the scope of  
6 practice of such Certified Nurse-Midwife shall be eligible to obtain  
7 recognition as authorized by the Board to prescribe and order, as  
8 defined by the rules promulgated by the Board pursuant to this  
9 section ~~and subject to the medical direction of a supervising~~  
10 ~~physician.~~ This authorization shall not include the dispensing of  
11 drugs, but shall not preclude, subject to federal regulations, the  
12 receipt of, the signing for, or the dispensing of professional  
13 samples to patients.

14 The Certified Nurse-Midwife accepts responsibility,  
15 accountability, and obligation to practice in accordance with usual  
16 and customary advanced practice registered nursing standards and  
17 functions as defined by the scope of practice/role definition  
18 statements for the Certified Nurse-Midwife;

19 9. ~~"Nurse-midwifery practice" means providing management of~~  
20 ~~care of normal newborns and women, antepartally, intrapartally,~~  
21 ~~postpartally and gynecologically, occurring within a health care~~  
22 ~~system which provides for medical consultation, medical management~~  
23 ~~or referral, and is in accord with the standards for nurse-midwifery~~  
24 ~~practice as defined by the American College of Nurse-Midwives;~~

1       ~~10.~~ a.    "Certified Registered Nurse Anesthetist" is an  
2                   Advanced Practice Registered Nurse who:

3                   (1)   is certified by the Council on Certification of  
4                   Nurse Anesthetists as a Certified Registered  
5                   Nurse Anesthetist within one (1) year following  
6                   completion of an approved certified registered  
7                   nurse anesthetist education program, and  
8                   continues to maintain such recertification by the  
9                   Council on Recertification of Nurse Anesthetists,  
10                  and

11                  (2)   administers anesthesia under the supervision of a  
12                  medical doctor, an osteopathic physician, a  
13                  podiatric physician or a dentist licensed in this  
14                  state and under conditions in which timely onsite  
15                  consultation by such doctor, osteopath, podiatric  
16                  physician or dentist is available.

17                  b.    A Certified Registered Nurse Anesthetist, under the  
18                  supervision of a medical doctor, osteopathic  
19                  physician, podiatric physician or dentist licensed in  
20                  this state, and under conditions in which timely, on-  
21                  site consultation by such medical doctor, osteopathic  
22                  physician, podiatric physician or dentist is  
23                  available, shall be authorized, pursuant to rules  
24                  adopted by the Oklahoma Board of Nursing, to order,

1 select, obtain and administer legend drugs, Schedules  
2 II through V controlled substances, devices, and  
3 medical gases only when engaged in the preanesthetic  
4 preparation and evaluation; anesthesia induction,  
5 maintenance and emergence; and postanesthesia care. A  
6 Certified Registered Nurse Anesthetist may order,  
7 select, obtain and administer drugs only during the  
8 perioperative or periobstetrical period.

9 c. A Certified Registered Nurse Anesthetist who applies  
10 for authorization to order, select, obtain and  
11 administer drugs shall:

12 (1) be currently recognized as a Certified Registered  
13 Nurse Anesthetist in this state,

14 (2) provide evidence of completion, within the two-  
15 year period immediately preceding the date of  
16 application, of a minimum of fifteen (15) units  
17 of continuing education in advanced pharmacology  
18 related to the administration of anesthesia as  
19 recognized by the Council on Recertification of  
20 Nurse Anesthetists or the Council on  
21 Certification of Nurse Anesthetists, and

22 (3) complete and submit a notarized application, on a  
23 form prescribed by the Board, accompanied by the  
24

1 application fee established pursuant to this  
2 section.

3 d. The authority to order, select, obtain and administer  
4 drugs shall be terminated if a Certified Registered  
5 Nurse Anesthetist has:

6 (1) ordered, selected, obtained or administered drugs  
7 outside of the Certified Registered Nurse  
8 Anesthetist scope of practice or ordered,  
9 selected, obtained or administered drugs for  
10 other than therapeutic purposes, or

11 (2) violated any provision of state laws or rules or  
12 federal laws or regulations pertaining to the  
13 practice of nursing or the authority to order,  
14 select, obtain and administer drugs.

15 e. The Oklahoma Board of Nursing shall notify the Board  
16 of Pharmacy after termination of or a change in the  
17 authority to order, select, obtain and administer  
18 drugs for a Certified Registered Nurse Anesthetist.

19 f. The Board shall provide by rule for biennial  
20 application renewal and reauthorization of authority  
21 to order, select, obtain and administer drugs for  
22 Certified Registered Nurse Anesthetists. At the time  
23 of application renewal, a Certified Registered Nurse  
24 Anesthetist shall submit documentation of a minimum of

1 eight (8) units of continuing education, completed  
2 during the previous two (2) years, in advanced  
3 pharmacology relating to the administration of  
4 anesthesia, as recognized by the Council on  
5 Recertification of Nurse Anesthetists or the Council  
6 on Certification of Nurse Anesthetists.

7 g. This paragraph shall not prohibit the administration  
8 of local or topical anesthetics as now permitted by  
9 law. Provided further, nothing in this paragraph  
10 shall limit the authority of the Board of Dentistry to  
11 establish the qualifications for dentists who direct  
12 the administration of anesthesia; and

13 11. ~~"Supervising physician" means an individual holding a~~  
14 ~~current license to practice as a physician from the State Board of~~  
15 ~~Medical Licensure and Supervision or the State Board of Osteopathic~~  
16 ~~Examiners, who supervises a Certified Nurse Practitioner, a Clinical~~  
17 ~~Nurse Specialist, or a Certified Nurse Midwife, and who is not in~~  
18 ~~training as an intern, resident, or fellow. To be eligible to~~  
19 ~~supervise such Advanced Practice Registered Nurse, such physician~~  
20 ~~shall remain in compliance with the rules promulgated by the State~~  
21 ~~Board of Medical Licensure and Supervision or the State Board of~~  
22 ~~Osteopathic Examiners;~~

23 12. ~~"Supervision of an Advanced Practice Registered Nurse with~~  
24 ~~prescriptive authority" means overseeing and accepting~~

1 ~~responsibility for the ordering and transmission by a Certified~~  
2 ~~Nurse Practitioner, a Clinical Nurse Specialist, or a Certified~~  
3 ~~Nurse-Midwife of written, telephonic, electronic or oral~~  
4 ~~prescriptions for drugs and other medical supplies, subject to a~~  
5 ~~defined formulary; and~~

6 13. "Advanced Unlicensed Assistant" means any person who has  
7 successfully completed a certified training program approved by the  
8 Board that trains the Advanced Unlicensed Assistant to perform  
9 specified technical skills identified by the Board in acute care  
10 settings under the direction and supervision of the Registered Nurse  
11 or Licensed Practical Nurse.

12 SECTION 3. AMENDATORY 59 O.S. 2011, Section 567.4a, is  
13 amended to read as follows

14 Section 567.4a The Board may grant prescribing and ordering  
15 authority through the Advanced Practice Registered Nurse license to  
16 Certified Nurse Practitioners, Certified Nurse-Midwives and Clinical  
17 Nurse Specialists meeting requirements identified in the Board's  
18 rules. The Board may limit the ability of Certified Nurse  
19 Practitioners, Certified Nurse-Midwives and Clinical Nurse  
20 Specialists to prescribe and order. All licensed Certified Nurse  
21 Practitioners, Certified Nurse-Midwives and Clinical Nurse  
22 Specialists who are granted prescribing and ordering authority are  
23 authorized to diagnose, prescribe and institute therapy or referrals  
24 of patients to healthcare agencies, healthcare providers and

1 community resources. They are authorized to prescribe, procure,  
2 administer and dispense over the counter legend and controlled  
3 substances. They plan and initiate a therapeutic regimen that  
4 includes ordering and prescribing medical devices and equipment,  
5 nutrition, diagnostic and supportive services, including, but not  
6 limited to, speech therapy, home health care, hospice and physical  
7 and occupational therapy.

8 The rules regarding ~~prescriptive~~ prescribing and ordering  
9 authority ~~recognition~~ promulgated by the Oklahoma Board of Nursing  
10 pursuant to paragraphs 6 through 9, 11 and 12 of Section 567.3a of  
11 this title shall:

12 1. ~~Define the procedure for documenting supervision by a~~  
13 ~~physician licensed in Oklahoma to practice by the State Board of~~  
14 ~~Medical Licensure and Supervision or the State Board of Osteopathic~~  
15 ~~Examiners. Such procedure shall include a written statement that~~  
16 ~~defines appropriate referral, consultation, and collaboration~~  
17 ~~between the advanced practice nurse, recognized to prescribe as~~  
18 ~~defined in paragraphs 6 through 9, 11 and 12 of Section 567.3a of~~  
19 ~~this title, and the supervising physician. The written statement~~  
20 ~~shall include a method of assuring availability of the supervising~~  
21 ~~physician through direct contact, telecommunications or other~~  
22 ~~appropriate electronic means for consultation, assistance with~~  
23 ~~medical emergencies, or patient referral. The written statement~~  
24 ~~shall be part of the initial application and the renewal application~~

1 ~~submitted to the Board for recognition for prescriptive authority~~  
2 ~~for the advanced practice nurse. Changes to the written statement~~  
3 ~~shall be filed with the Board within thirty (30) days of the change~~  
4 ~~and shall be effective on filing;~~

5       ~~2.~~ Define minimal requirements for initial application for  
6 prescriptive authority which shall include, but not be limited to,  
7 evidence of completion of a minimum of forty-five (45) contact hours  
8 or three (3) academic credit hours of education in  
9 pharmacotherapeutics, clinical application, and use of  
10 pharmacological agents in the prevention of illness, and in the  
11 restoration and maintenance of health in a program beyond basic
