7 AS INTRODUCED

8 An Act relating to motor vehicles; amending 47 O.S.
9 2011, Section 1135.5, as last amended by Section 25,
10 Chapter 210, O.S.L. 2016 (47 O.S. Supp. 2016, Section
11 1135.5), which relates to special license plates;
12 clarifying language; clarifying references; creating
13 certain motorcycle license plate; authorizing certain
14 licensing agreements; providing for certain payments;
15 limiting certain payments; and providing an effective
16 date.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 47 O.S. 2011, Section 1135.5, as
17 last amended by Section 25, Chapter 210, O.S.L. 2016 (47 O.S. Supp.
18 2016, Section 1135.5), is amended to read as follows:

19 Section 1135.5 A. The Oklahoma Tax Commission is hereby
20 authorized to design and issue appropriate official special license
21 plates to persons wishing to demonstrate support and provide
22 financial assistance as provided by this section.

23 Special license plates shall not be transferred to any other
24 person but shall be removed from the vehicle upon transfer of

1 ownership and retained. The special license plate may then be used
2 on another vehicle but only after such other vehicle has been
3 registered for the current year with a motor license agent.

4 Special license plates shall be renewed each year by the Tax
5 Commission or a motor license agent. The Tax Commission shall
6 annually notify by mail all persons issued special license plates.
7 The notice shall contain all necessary information and shall contain
8 instructions for the renewal procedure upon presentation to a motor
9 license agent or the Tax Commission. The license plates shall be
10 issued on a staggered system.

11 The Tax Commission is hereby directed to develop and implement a
12 system whereby motor license agents are permitted to accept
13 applications for special license plates authorized under this
14 section. The motor license agent shall confirm the applicant's
15 eligibility, if applicable, collect and deposit any amount
16 specifically authorized by law, accept and process the necessary
17 information directly into such system and generate a receipt
18 accordingly. For performance of these duties, motor license agents
19 shall retain the fee provided in Section 1141.1 of this title for
20 registration of a motor vehicle. The motor license agent fees for
21 acceptance of applications and renewals shall be paid out of the
22 Oklahoma Tax Commission Reimbursement Fund.

23 If fewer than one hundred of any type of special license plates
24 authorized prior to January 1, 2004, are issued prior to January 1,

1 2006, the Tax Commission shall discontinue issuance and renewal of
2 that type of special license plate. Any such authorized special
3 license plate registrant shall be allowed to display the license
4 plate upon the designated vehicle until the registration expiration
5 date. After such time the expired special license plate shall be
6 removed from the vehicle.

7 For special license plates authorized on or after July 1, 2004,
8 no special license plates shall be developed or issued by the Tax
9 Commission until the Commission receives one hundred prepaid
10 applications therefor. The prepaid applications must be received by
11 the Tax Commission within one hundred eighty (180) days of the
12 effective date of the authorization or the authority to issue shall
13 be null and void. In the event one hundred prepaid applications are
14 not received by the Tax Commission within such prescribed time
15 period any payment so received shall be refunded accordingly.

16 B. The special license plates provided by this section are as
17 follows:

18 1. University or College Supporter License ~~Plates~~ Plate - such
19 plates shall be designed and issued to any person wishing to
20 demonstrate support to any state-supported or private university or
21 college. As provided in this section, an amount of the fee
22 collected shall be apportioned as provided in Section 1104.1 of this
23 title;

24

1 2. Environmental Awareness License ~~Plates~~ Plate - such plates
2 shall be designed, subject to the criteria to be presented to the
3 Tax Commission by the Department of Environmental Quality in
4 consultation with the Oklahoma Arts Council, and issued to any
5 person wishing to demonstrate support to implement the statewide
6 general public environmental education program created pursuant to
7 the provisions of the Oklahoma Environmental Quality Code. Such
8 plates shall be designed and issued to any person in any combination
9 of numbers and letters from one to a maximum of seven, as for
10 personalized license plates. A dealer's license plate issued
11 pursuant to Section 1116.1 or 1128 of this title may be designated
12 an Environmental Awareness License Plate upon payment of the fee
13 imposed by this section and any other registration fees required by
14 the Oklahoma Vehicle License and Registration Act. As provided in
15 this section, an amount of the fee collected shall be apportioned
16 pursuant to Section 1104.2 of this title;

17 3. Firefighter License ~~Plates~~ Plate - such plates shall be
18 designed for any career or retired firefighter, volunteer or paid.
19 Firefighters may apply for firefighter plates for up to four
20 vehicles with a rated capacity of one (1) ton or less or for a
21 motorcycle upon proof of a fire department membership by either an
22 identification card or letter from the chief of the fire department.
23 Retirees who are eligible for such plates shall provide proof of
24 eligibility upon initial application, but shall not be required to

1 provide proof of eligibility annually. The surviving spouse of any
2 deceased firefighter, if the spouse has not since remarried, may
3 apply for a firefighter license plate for one vehicle with a rated
4 carrying capacity of one (1) ton or less or for a motorcycle upon
5 proof that the deceased firefighter was a member of a fire
6 department by either an identification card or letter from the chief
7 of the fire department. The license plate shall be designed in
8 consultation with the Oklahoma Firefighters Association.

9 As provided in this section, an amount of the fee collected
10 shall be deposited to the Oklahoma State Firemen's Museum Building &
11 Memorial Fund for support of the Oklahoma Firefighters Museum and
12 the Oklahoma ~~Firefighter~~ Fallen and Living Firefighters Memorial;

13 4. Wildlife Conservation License ~~Plates~~ Plate - such plates
14 shall be designed, subject to the criteria to be presented to the
15 Tax Commission by the Oklahoma Department of Wildlife Conservation
16 in consultation with the Oklahoma Arts Council, and issued to any
17 person wishing to demonstrate support for wildlife conservation in
18 this state through the Wildlife Diversity Fund, provided for in
19 Section 3-310 of Title 29 of the Oklahoma Statutes. Such plates may
20 be designed and issued to any person as for personalized license
21 plates.

22 As provided in this section, an amount of the fee collected
23 shall be apportioned pursuant to subsection D of Section 3-310 of
24 Title 29 of the Oklahoma Statutes;

1 5. Child Abuse Prevention License ~~Plates~~ Plate - such plates
2 shall be designed, subject to the criteria to be presented to the
3 Tax Commission by the Office of Child Abuse Prevention in the State
4 Department of Health and the Oklahoma Committee to Prevent Child
5 Abuse, and issued to any person wishing to demonstrate support for
6 the prevention of child abuse.

7 As provided in this section, an amount of the fee collected
8 shall be deposited in the Child Abuse Prevention Fund;

9 6. United States Olympic Committee Supporter License ~~Plates~~
10 Plate - such plates shall be designed and issued to any person
11 wishing to demonstrate support for the United States Olympic
12 Committee. The plates shall be issued to any person in any
13 combination of numbers and letters from one to a maximum of seven,
14 as for personalized license plates. The plate shall contain the
15 official United States Olympic Committee logo. The Tax Commission
16 shall be authorized, if necessary, to enter into a licensing
17 agreement with the United States Olympic Committee for any licensing
18 fees which may be required in order to use the United States Olympic
19 Committee logo or design. The licensing agreement shall provide for
20 a payment of not more than Twenty-five Dollars (\$25.00) for each
21 license plate issued;

22 7. Oklahoma History License ~~Plates~~ Plate - such plates shall be
23 designed and issued to any person wishing to demonstrate interest in
24 Oklahoma history. As provided in this section, an amount of the fee

1 collected shall be deposited to the Oklahoma Historical Society
2 Revolving Fund to be used for educational purposes;

3 8. Historic Route 66 License ~~Plates~~ Plate - such:

4 a. vehicle plates shall be designed to honor historic
5 Route 66, also known as the "Mother Road". As
6 provided in this section, an amount of the fee
7 collected for each vehicle license plate shall be
8 apportioned to the Oklahoma Historical Society
9 Revolving Fund to be distributed to the Route 66
10 Museum located in Clinton, Oklahoma, and

11 b. motorcycle plates shall be designed in consultation
12 with the Oklahoma Route 66 Association, Inc. The
13 Oklahoma Tax Commission shall be authorized to enter
14 into a licensing agreement with the Oklahoma Route 66
15 Association, Inc., for any licensing fees which may be
16 required in order to use the Oklahoma Route 66
17 Association, Inc., logo or design. The licensing
18 agreement shall provide for a payment to the Oklahoma
19 Route 66 Association, Inc., of not more than Twenty
20 Dollars (\$20.00) for each motorcycle license plate
21 issued;

22 9. Heart of the Heartland License ~~Plates~~ Plate - such plates
23 shall be designed and issued to any person wishing to honor the
24 victims of the terrorist bombing attack on the Alfred P. Murrah

1 Federal Building in downtown Oklahoma City on April 19, 1995. As
2 provided in this section, an amount of the fee collected shall be
3 deposited in the Heart of the Heartland Scholarship Fund, as
4 established in Section 2282 of Title 70 of the Oklahoma Statutes;

5 10. Emergency Medical Technician License ~~Plates~~ Plate - such
6 plates shall be designed and issued to any person who is an
7 emergency medical technician. Such persons may apply for an
8 emergency medical technician license plate for each vehicle with a
9 rated carrying capacity of one (1) ton or less upon proof of an
10 emergency medical technician's license. The license plate shall be
11 designed in consultation with the state association of emergency
12 medical technicians. As provided in this section, an amount of the
13 fee collected shall be apportioned to the Emergency Medical
14 ~~Technician~~ Personnel Death Benefit Revolving Fund created in Section
15 1-2505.2 of Title 63 of the Oklahoma Statutes;

16 11. Fight Breast Cancer License ~~Plates~~ Plate - such plates
17 shall be designed to demonstrate support for the prevention and
18 treatment of breast cancer in this state. As provided in this
19 section, an amount of the fee collected shall be apportioned to the
20 Breast Cancer Act Revolving Fund;

21 12. Crime Victims Awareness License ~~Plates~~ Plate - such plates
22 shall be designed and issued to any person wishing to demonstrate
23 awareness of and support for victims of crimes. The license plates
24 shall be designed in consultation with the Oklahoma Crime Victims

1 Centre. As provided in this section, an amount of the fee collected
2 shall be apportioned to the Attorney General's Revolving Fund for
3 the Office of the Attorney General, which is hereby directed to use
4 such funds to contract with a statewide nonprofit organization to
5 provide services to crime victims;

6 13. Oklahoma Safe Kids Association License ~~Plates~~ Plate - such
7 plates shall be designed and issued to any person wishing to
8 demonstrate support and awareness of the Oklahoma Safe Kids
9 Association. The license plate shall be designed in consultation
10 with the Oklahoma Safe Kids Association. As provided in this
11 section, an amount of the fee collected shall be deposited in the
12 Children's Hospital - Oklahoma Safe Kids Association Revolving Fund
13 to be distributed to the Oklahoma Safe Kids Association program;

14 14. Four-H Club License ~~Plates~~ Plate - such plates shall be
15 designed, subject to criteria to be presented to the Tax Commission
16 by the Four-H Foundation, and issued to any person wishing to
17 demonstrate support of the Four-H Club. Such plates may be designed
18 and issued to any person as for personalized license plates. As
19 provided in this section, an amount of the fee collected shall be
20 apportioned to the OSU Extension Service License Plate Revolving
21 Fund created in Section 1104.4 of this title;

22 15. Agricultural Awareness License ~~Plates~~ Plate - such plates
23 shall be designed, subject to criteria to be presented to the Tax
24 Commission, by the Oklahoma Department of Agriculture, Food, and

1 Forestry in consultation with the Oklahoma Arts Council, and issued
2 to any person wishing to demonstrate support of the Department's Ag
3 in the Classroom Education Program. As provided in this section, an
4 amount of the fee collected shall be apportioned as provided in
5 Section 1104.3 of this title;

6 16. Oklahoma Statehood Centennial License ~~Plates~~ Plate - such
7 plates shall be designed and issued to any person wishing to
8 commemorate the centennial of Oklahoma's admission to statehood in
9 1907. The license plates shall be designed in consultation with the
10 Oklahoma Capitol Complex and Centennial Commemoration Commission.
11 As provided in this section, an amount of the fee collected shall be
12 deposited in the Oklahoma Capitol Complex and Centennial
13 Commemoration Commission Revolving Fund created in Section 98.5 of
14 Title 73 of the Oklahoma Statutes;

15 17. Support Education License ~~Plates~~ Plate - such plates shall
16 be designed, subject to criteria to be presented to the Tax
17 Commission by the State Department of Education in consultation with
18 the Oklahoma Arts Council, and issued to any person wishing to
19 demonstrate support for education in this state. All motor license
20 agents shall display a sample of the Support Education License plate
21 in the area of the business accessed by the public. Twenty-three
22 Dollars (\$23.00) of the fee collected shall be apportioned as
23 follows:

24

- 1 a. five percent (5%) shall be deposited to the Education
2 Reform Revolving Fund,
3 b. five percent (5%) shall be deposited to the Higher
4 Education Revolving Fund,
5 c. five percent (5%) shall be deposited to the State
6 Career Technology Fund, and
7 d. eighty-five percent (85%) of the fee shall be
8 deposited to the Teachers' Retirement Benefit Fund as
9 set forth in Section 17-108 of Title 70 of the
10 Oklahoma Statutes.

11 However, when the Teachers' Retirement Benefit Fund attains a
12 seventy percent (70%) funded ratio based on an annual actuarial
13 valuation as required by law, the amount of the fee shall be
14 apportioned equally pursuant to subparagraphs a, b and c of this
15 paragraph;

16 18. Retired Oklahoma Highway Patrol Officers License ~~Plates~~
17 Plate - such plates shall be designed and issued to any retired
18 officer of the Oklahoma Highway Patrol. The license plate shall
19 have the legend "Oklahoma" and shall contain, in the center of the
20 plate, the Highway Patrol Officers patch using the same colors and
21 pattern as used in the patch. Centered on the bottom of the license
22 plate shall be the word "Retired". The letters "TRP" shall be used
23 in combination with three numbers on either side of the insignia or
24 emblem. The color of the letters and numbers shall be brown.

1 Retirees who are eligible for such plates shall provide proof of
2 eligibility upon initial application, but shall not be required to
3 provide proof of eligibility annually. The surviving spouse of any
4 deceased retired officer of the Oklahoma Highway Patrol, if the
5 spouse has not since remarried, or if remarried, the remarriage is
6 terminated by death, divorce, or annulment, may apply for a Retired
7 Oklahoma Highway Patrol Officers license plate. As provided in this
8 section, an amount of the fee collected shall be deposited into the
9 Law Enforcement Retirement Fund;~~Plates~~ Plate Plates - such plates
10 shall be designed and issued to any person wishing to demonstrate
11 support for the Boy Scouts of America. The plates shall be issued
12 to any person in any combination of numbers and letters from one to
13 a maximum of seven, as for personalized license plates. The plate
14 shall contain the official Boy Scouts of America logo. The Tax
15 Commission shall be authorized, if necessary, to enter into a
16 licensing agreement with the Boy Scouts of America for any licensing
17 fees which may be required in order to use the Boy Scouts of America
18 logo or design. The licensing agreement shall provide for a payment
19 to the Boy Scouts of America of not more than Twenty Dollars
20 (\$20.00) for each license plate issued;

21 20. Urban Forestry and Beautification License ~~Plates~~ Plate -
22 such plates shall be designed, subject to criteria to be presented
23 to the Tax Commission, by the Oklahoma Department of Agriculture,
24 Food, and Forestry in consultation with nonprofit organizations in

1 this state that develop and operate programs to encourage urban
2 forestry and beautification, and issued to any person wishing to
3 demonstrate support of such programs. As provided in this section,
4 an amount of the fee collected shall be apportioned as provided in
5 Section 1104.5 of this title;

6 21. Oklahoma State Parks Supporter License ~~Plates~~ Plate - such
7 plates shall be designed, subject to criteria to be presented to the
8 Tax Commission by the Oklahoma Tourism and Recreation Department,
9 and issued to any person wishing to demonstrate support for the
10 Oklahoma state parks system. Twenty-three Dollars (\$23.00) of the
11 fee collected shall be deposited in the Oklahoma Tourism and
12 Recreation Department Revolving Fund. Such money shall be
13 designated for and may only be expended for the support of Oklahoma
14 state parks;

15 22. Adoption Creates Families License ~~Plates~~ Plate - such
16 plates shall be issued to any person wishing to demonstrate support
17 of pregnant women who are committed to placing their children for
18 adoption and wishing to provide assistance to guardians, adoptive
19 parents and other created families to assist in the adoption and
20 placement of children in permanent, safe homes. The license plates
21 shall be designed and final terminology delivered in consultation
22 with the Oklahoma Adoption Coalition and the Department of Human
23 Services. Twenty-five Dollars (\$25.00) of the fee collected shall
24 be deposited in a revolving fund established in the State Treasury

1 for and to be used by the Department of Human Services for the
2 implementation of the Investing in Stronger Oklahoma Families Act
3 specifically for created families;

4 23. Choose Life License ~~Plates~~ Plate - such plates shall be
5 designed, subject to criteria presented to the Tax Commission, by
6 Choose Life, Inc., and issued to any person who wishes to
7 demonstrate support of organizations that encourage adoption as a
8 positive choice for women with unplanned pregnancies. As provided
9 in this section, an amount of the fee collected shall be deposited
10 in the Choose Life Assistance Program Revolving Fund established in
11 Section 1104.6 of this title;

12 24. Future Farmers of America License Plate - such plates shall
13 be designed and issued to persons wishing to demonstrate support for
14 the Oklahoma FFA (formerly known as Future Farmers of America). The
15 license plates shall be designed in consultation with the Oklahoma
16 FFA Foundation Board of Directors. As provided in this section, an
17 amount of the fee collected shall be apportioned as provided in
18 Section 1104.7 of this title;

19 25. Lions Club License ~~Plates~~ Plate - such plates shall be
20 designed and issued to persons wishing to demonstrate support for
21 the Lions Club of Oklahoma. The plates shall be issued to any
22 person in any combination of numbers and letters from one to a
23 maximum of seven, as for personalized license plates. The license
24 plates shall be designed in consultation with the Oklahoma Lions

1 Service Foundation and shall contain the official logo of the
2 International Association of Lions Clubs. The Tax Commission shall
3 be authorized to enter into a licensing agreement with the Oklahoma
4 Lions Service Foundation. The licensing agreement shall provide for
5 a payment to the Oklahoma Lions Service Foundation of not more than
6 Ten Dollars (\$10.00) for each license plate issued;

7 26. Color Oklahoma License ~~Plates~~ Plate - such plates shall be
8 designed, subject to criteria to be presented to the Tax Commission
9 by the Oklahoma Native Plant Society, and issued to any person
10 wishing to demonstrate support for preserving and planting
11 wildflowers and native plants in Oklahoma and to promote Oklahoma's
12 wildflower heritage through education. As provided in this section,
13 an amount of the fee collected shall be apportioned as provided in
14 Section 1104.8 of this title;

15 27. Girl Scouts of the United States of America Supporter
16 License ~~Plates~~ Plate - such plates shall be designed and issued to
17 any person wishing to demonstrate support for the Girl Scouts of the
18 United States of America. The plates shall be issued to any person
19 in any combination of numbers and letters from one to a maximum of
20 seven, as for personalized license plates. The plate shall contain
21 the official Girl Scouts of the United States of America logo. The
22 Tax Commission shall be authorized, if necessary, to enter into a
23 licensing agreement with the Girl Scouts of the United States of
24 America for any licensing fees which may be required in order to use

1 the Girl Scouts of the United States of America logo or design. The
2 licensing agreement shall provide for a payment to the Girl Scouts
3 of Magic Empire Council, acting on behalf of all Oklahoma Girl Scout
4 councils, of not more than Twenty Dollars (\$20.00) for each license
5 plate issued;

6 28. Oklahoma City Memorial Marathon License ~~Plates~~ Plate - such
7 plates shall be designed and issued to any person wishing to
8 demonstrate support for the Oklahoma City Memorial Marathon. The
9 plate shall be designed in consultation with the Oklahoma City
10 Memorial Marathon. The Tax Commission shall be authorized to enter
11 into a licensing agreement with the Oklahoma City Memorial Marathon
12 for any licensing fees which may be required in order to use the
13 Oklahoma City Memorial Marathon logo or design. The licensing
14 agreement shall provide for a payment to the Oklahoma City Memorial
15 Marathon of not more than Twenty Dollars (\$20.00) for each license
16 plate issued;

17 29. Oklahoma Scenic Rivers License Plate - such plates shall be
18 designed to demonstrate support for the Oklahoma Scenic Rivers. The
19 plates shall be designed in consultation with the Oklahoma Scenic
20 Rivers Commission. Twenty-five Dollars (\$25.00) of the fee shall be
21 apportioned to the Oklahoma Scenic Rivers Commission;

22 30. Fight Cancer License Plate - such plates shall be designed
23 to demonstrate support for the Oklahoma Central Cancer Registry.
24 The plate shall contain the American Cancer Society logo. The

1 American Cancer Society logo shall be used in accordance with the
2 American Cancer Society's branding guidelines and shall only be
3 utilized to support the Oklahoma Central Cancer Registry. Twenty
4 Dollars (\$20.00) of the fee shall be apportioned to the Oklahoma
5 Central Cancer Registry Revolving Fund;

6 31. Animal Friendly License Plate - such plates shall be
7 designed and issued to any person wishing to demonstrate support for
8 controlling the overpopulation of dogs and cats through educational
9 and sterilization efforts. The plates shall be designed in
10 consultation with the Veterinary Medical Association. Twenty
11 Dollars (\$20.00) of the fee collected shall be designated by the
12 purchaser of the plate to be deposited in the Oklahoma Pet
13 Overpopulation Fund created in Section 2368.13 of Title 68 of the
14 Oklahoma Statutes or the Animal Friendly Revolving Fund created in
15 Section 1104.10 of this title;

16 32. Patriot License Plate - such plates shall be designed in
17 consultation with the Military Department of Oklahoma and issued to
18 any person wishing to demonstrate support for Oklahoma residents who
19 are members of the Oklahoma National Guard and deployed on active
20 duty. The plates shall be issued to any person in any combination
21 of numbers and letters from one to a maximum of seven, as for
22 personalized license plates. As provided in this section, a portion
23 of the fee collected shall be deposited in the Patriot License Plate
24 Revolving Fund created in Section 1104.11 of this title;

1 33. Global War on Terrorism License Plate - such plate shall be
2 designed in consultation with the Military Department of Oklahoma
3 and issued to any person wishing to demonstrate support for Oklahoma
4 residents who are members of the Armed Forces of the United States
5 or Oklahoma National Guard that have served in the Global War on
6 Terrorism. The plate shall be issued to any person in any
7 combination of numbers and letters from one to a maximum of six. As
8 provided in this section, a portion of the fee collected shall be
9 deposited in the 45th Infantry Division Museum Fund created in
10 Section 235.1 of Title 44 of the Oklahoma Statutes;

11 34. Boys and Girls Clubs of America Supporter License ~~Plates~~
12 Plate - such plates shall be designed and issued to any person
13 wishing to demonstrate support for the Boys and Girls Clubs of
14 America. The plates shall be issued to any person in any
15 combination of numbers and letters from one to a maximum of seven,
16 as for personalized license plates. The plate shall contain the
17 official Boys and Girls Clubs of America logo. The Tax Commission,
18 if necessary, may enter into a licensing agreement with the Boys and
19 Girls Clubs of America for any licensing fees which may be required
20 in order to use the Boys and Girls Clubs of America logo or design.
21 The licensing agreement shall provide for a payment to the Boys and
22 Girls Clubs of America of not more than Twenty Dollars (\$20.00) for
23 each license plate issued;

1 35. Oklahoma Quarter Horse License ~~Plates~~ Plate - such plates
2 shall be designed and issued to any person wishing to demonstrate
3 support for the American Quarter Horse in Oklahoma. The plate shall
4 be designed in consultation with the Oklahoma Quarter Horse
5 Association. As provided in this section, a portion of the fee
6 collected shall be deposited in the Oklahoma Quarter Horse Revolving
7 Fund created in Section 1104.12 of this title;

8 36. Oklahoma Association for the Deaf License Plate - such
9 plates shall be designed in consultation with the Oklahoma
10 Association for the Deaf and issued to any person wishing to
11 demonstrate support for Oklahoma residents who are deaf. The plates
12 shall be issued to any person in any combination of numbers and
13 letters from one to maximum of seven, as for personalized license
14 plates. As provided in this section, a portion of the fee collected

22 Zoological Society Revolving Fund created in Section 1104.13 of this

1 38. March of Dimes License Plate - such plates shall be issued
2 to persons wishing to demonstrate support for the March of Dimes
3 mission to improve the health of babies by preventing birth defects,
4 premature birth and infant mortality. The license plates shall be
5 designed in consultation with the Oklahoma Chapter March of Dimes.
6 As provided in this section, an amount of the fee collected shall be
7 deposited in the Oklahoma Prevent Birth Defects, Premature Birth and

15 mark "Support Our Troops" across the bottom of the plate. The Tax
16 Commission, if necessary, may enter into a licensing agreement with

22 shall be designed in consultation with the Oklahoma Chapter of the
23 Alzheimer's Association. As provided in this section, an amount of
24 the fee collected shall be deposited in the Alzheimer's Research

1 License Plate Revolving Fund created in Section 1104.20 of this
2 title;

3 49. Hospice and Palliative Care License Plate - such plates
4 shall be issued to any person wishing to provide financial support
5 for the Oklahoma Hospice and Palliative Care Association. The
6 license plates shall be designed in consultation with the Oklahoma
7 Hospice and Palliative Care Association. As provided in this
8 section, an amount of the fee collected shall be deposited in the
9 Hospice and Palliative Care License Plate Revolving Fund created in
10 Section 1104.21 of this title;

11 50. Juvenile Diabetes Research License Plate - such plates
12 shall be issued to any person wishing to provide financial support
13 for the Oklahoma Chapters of the Juvenile Diabetes Research
14 Foundation. The license plates shall be designed in consultation
15 with the Oklahoma Chapters of the Juvenile Diabetes Research
16 Foundation. As provided in this section, an amount of the fee
17 collected shall be deposited in the Juvenile Diabetes Research
18 License Plate Revolving Fund created in Section 1104.22 of this
19 title;

20 51. Deer Creek Schools Foundation License Plate - such plates
21 shall be issued to any person wishing to provide financial support
22 for the Deer Creek Schools Foundation. The license plates shall be
23 designed in consultation with the Deer Creek Schools Foundation.
24 The plates shall be issued to any person in any combination of

1 numbers and letters from one to a maximum of seven, as for
2 personalized license plates. As provided in this section, an amount
3 of the fee collected shall be deposited in the Deer Creek Schools
4 Foundation License Plate Revolving Fund created in Section 1104.23

6 52. Lupus Awareness and Education License Plate - such plates
7 shall be issued to any person wishing to provide financial support
8 for the Lupus Foundation of Oklahoma. The license plates shall be

11 deposited in the Oklahoma Lupus License Plate Revolving Fund created

15 53. Chiefs of Police License Plate - such plates shall be
16 issued to any person wishing to provide financial support for the
17 Oklahoma Association of Chiefs of Police for a vehicle or motorcycle
18 in any combination of numbers and letters from one to a maximum of
19 seven, as for personalized plates. The license plates shall be
20 designed in consultation with the Oklahoma Association of Chiefs of
21 Police. The license plate for a motorcycle may be of similar design
22 as space permits or a new design in order to meet the space
23 requirements of a motorcycle license plate. The Tax Commission
24 shall be authorized to enter into a licensing agreement with the

Oklahoma Association of Chiefs of Police for any licensing fees which may be required in order to use the association's logo or design. The licensing agreement shall provide for a payment to the Oklahoma Association of Chiefs of Police of not more than Twenty Dollars (\$20.00) for each license plate issued. Subject to the provisions of subsection A of this section, the Chiefs of Police License Plate is hereby reauthorized effective November 1, 2015;

54. Crossings Christian School License Plate - such plates shall be designed and issued to any person wishing to demonstrate support for Crossings Christian School located in Oklahoma City. The license plates shall be designed in consultation with the administration of Crossings Christian School. The Tax Commission shall be authorized to enter into a licensing agreement with Crossings Christian School for any licensing fees which may be required in order to use the school's logo or design. The licensing agreement shall provide for a payment to the Crossings Christian School of not more than Twenty Dollars (\$20.00) for each license plate issued;

55. Hilldale Education Foundation License ~~Plates~~ Plate - such plates shall be designed and issued to any person wishing to demonstrate support for the Hilldale Education Foundation. The license plates shall be designed in consultation with the administration of the Hilldale Education Foundation. The Tax Commission shall be authorized to enter into a licensing agreement

1 with the Hilldale Education Foundation for any licensing fees which
2 may be required in order to use the foundation's logo or design.

3 The licensing agreement shall provide for a payment to the Hilldale
4 Education Foundation of not more than Twenty Dollars (\$20.00) for

21 Fame's logo or design. The licensing agreement shall provide for a
22 payment to the Oklahoma Sports Hall of Fame of not more than Twenty
23 Dollars (\$20.00) for each license plate issued;

1 58. Childhood Cancer Awareness License Plate - such plates
2 shall be issued to any person wishing to demonstrate support for the
3 Oklahoma Children's Cancer Association. The license plates shall be
4 designed in consultation with the administration of the Oklahoma
5 Children's Cancer Association. The Oklahoma Tax Commission shall be
6 authorized to enter into a licensing agreement with the Oklahoma
7 Children's Cancer Association for any licensing fees which may be
8 required in order to use the Oklahoma Children's Cancer
9 Association's logo or design. The licensing agreement shall provide
10 for a payment to the Oklahoma Children's Cancer Association of not
11 more than Twenty Dollars (\$20.00) for each license plate issued;

12 59. Oklahoma Educational Television Authority License Plate -
13 such plates shall be designed and issued to any person wishing to
14 demonstrate support for the Oklahoma Educational Television
15 Authority and such plates shall be designed in consultation with the
16 Authority. As provided in this section, an amount of the fee
17 collected shall be deposited in the Educational Television Authority
18 Revolving Fund created in Section 156 of Title 62 of the Oklahoma
19 Statutes; and

20 60. Remembering Fallen Heroes License Plate - such plates shall
21 be designed and issued to any person wishing to demonstrate support
22 for Concerns of Police Survivors, Inc. Such plates shall be
23 designed in consultation with the Oklahoma chapter of Concerns of
24 Police Survivors, Inc. As provided in this section, an amount of

1 the fee collected shall be deposited in the Oklahoma Concerns of
2 Police Survivors License Plate Revolving Fund created in Section
3 1104.27 of this title.

4 C. The fee for such plates shall be Thirty-five Dollars
5 (\$35.00) and shall be in addition to all other registration fees
6 provided by the Oklahoma Vehicle License and Registration Act. The
7 fee shall be apportioned as follows:

8 1. Twenty Dollars (\$20.00) or any other amount as provided in
9 this title of the fee shall be apportioned as provided or deposited
10 in a fund as specified within the paragraph authorizing the special
11 license plate;

12 2. Eight Dollars (\$8.00) of the fee shall be deposited in the
13 Oklahoma Tax Commission Reimbursement Fund to be used for the
14 administration of the Oklahoma Vehicle License and Registration Act;

16 3. Any remaining amounts of the fee shall be apportioned as
17 provided in Section 1104 of this title.
