10 COMMITTEE SUBSTITUTE

11 An Act relating to motor vehicle registrations;
12 creating the Motor Fuels Tax Fee; establishing fee as
13 a registration fee for certain types of vehicles;
14 providing fee amount; clarifying circumstances and
15 manner in which fee shall be paid; making fee a
16 prerequisite to licensing and registration;
17 apportioning fee revenue; defining terms; providing
18 for codification; and providing an effective date.

19 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

20 SECTION 1. NEW LAW A new section of law to be codified
21 in the Oklahoma Statutes as Section 1132.7 of Title 47, unless there
22 is created a duplication in numbering, reads as follows:

23 A. In addition to other vehicle registration fees specified by
24 law, for the year beginning January 1, 2018, and for each year

1 thereafter, there is hereby levied and there shall be paid to the
2 Oklahoma Tax Commission a Motor Fuels Tax Fee of:

3 1. One Hundred Fifty Dollars (\$150.00) upon every electric-
4 drive motor vehicle to be registered; and

5 2. Thirty Dollars (\$30.00) upon every hybrid-drive motor
6 vehicle to be registered.

7 The fee shall accrue and shall be collectible upon each
8 electric-drive motor vehicle and hybrid-drive motor vehicle under
9 the same circumstances and shall be payable in the same manner and
10 times as apply to vehicle registrations under the provisions of the
11 Oklahoma Vehicle License and Registration Act; provided, the fee
12 shall be paid in full for the then current year at the time any
13 electric-drive motor vehicle or hybrid-drive motor vehicle is first
14 registered in a calendar year.

15 B. The collection and payment of the fee specified in this
16 section shall be a prerequisite to licensing or registration of any
17 electric-drive motor vehicle or hybrid-drive motor vehicle.

18 C. Revenue from the fee provided for in subsection A of this
19 section shall be deposited in the State Treasury to the credit of
20 the General Revenue Fund.

21 D. For purposes of this section:

22 1. "Electric-drive motor vehicle" means a vehicle subject to a
23 registration fee as provided for in subsection A of Section 1132 of
24 Title 47 of the Oklahoma Statutes that is propelled solely by

1 electrical energy and is not capable of using gasoline, diesel or
2 any other fuel for propulsion; and

3 2. "Hybrid-drive motor vehicle" means a vehicle subject to a
4 registration fee as provided for in subsection A of Section 1132 of
5 Title 47 of the Oklahoma Statutes that is capable of being propelled
6 at least in part by electrical energy through the use of a battery
7 storage system of at least four (4) kilowatt-hours, and is also
8 capable of using gasoline, diesel fuel or alternative fuel to propel
9 the vehicle.

10 SECTION 2. This act shall become effective November 1, 2017.
