11 An Act relating to the County Community Safety
12 Investment Fund; amending Section 2, State Question
13 No. 781, Initiative Petition No. 405; changing entity
14 responsible for budgeting and expending funds;
15 changing entity responsible for promulgating certain
16 rules; providing an effective date; and declaring an
17 emergency.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. AMENDATORY Section 2, State Question No. 781,
Initiative Petition No. 405, is amended to read as follows:

20 Section 2. A. There is hereby created in the State Treasury a
21 revolving fund to be designated the "County Community Safety
22 Investment Fund". The fund shall be a continuing fund, not subject
23 to fiscal year limitations, and shall consist of all monies received
24 pursuant to Section 633 of Title 57 of the Oklahoma Statutes.

1 B. All monies appropriated and accruing to the credit of the
2 fund shall be budgeted and expended by the ~~Office of Management and~~
3 ~~Enterprise Services~~ Department of Mental Health and Substance Abuse
4 Services for the sole purpose of providing funds to ~~counties to~~
5 ~~provide~~ community rehabilitative programming, including but not
6 limited to mental health and substance abuse services within the
7 counties. Funds shall be disbursed in proportion to county
8 population, as reported in the most recent census.

9 C. Expenditures from the fund shall be made upon warrants
10 issued by the State Treasurer against claims filed as prescribed by
11 law with the Director of the Office of Management and Enterprise
12 Services for approval and payment.

13 D. ~~The Director of the Office of Management and Enterprise~~
14 Commissioner of the Department of Mental Health and Substance Abuse
15 Services shall promulgate rules necessary to implement the
16 provisions of this act.

17 SECTION 2. This act shall become effective July 1, 2017.

18 SECTION 3. It being immediately necessary for the preservation
19 of the public peace, health or safety, an emergency is hereby
20 declared to exist, by reason whereof this act shall take effect and
21 be in full force from and after its passage and approval.
