9 An Act relating to criminal procedure; amending 22
10 O.S. 2011, Section 1602, which relates to the
11 Domestic Violence Fatality Review Board; increasing
12 membership of the Board; and providing an effective
13 date.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 22 O.S. 2011, Section 1602, is
16 amended to read as follows:

17 Section 1602. A. The Domestic Violence Fatality Review Board
18 shall be composed of ~~eighteen (18)~~ twenty (20) members, or their
19 designees, as follows:

20 1. Eight of the members shall be:

21 a. the Chief Medical Examiner,

22 b. a designee of the Attorney General. The designee
23 shall be a person assigned to the Victims Services
24 Unit of the Office of the Attorney General,

- c. the State Commissioner of Health,
- d. the Chief of Injury Prevention Services of the State Department of Health,
- e. the Director of the Department of Human Services,
- f. the Director of the Oklahoma State Bureau of Investigation,
- g. the Commissioner of the Department of Mental Health and Substance Abuse Services, and
- h. the Executive Director of the Office of Juvenile Affairs; and

2. ~~Ten~~ Twelve of the members shall be appointed by the Attorney General, shall serve for terms of two (2) years and shall be eligible for reappointment. The members shall be persons having training and experience in matters related to domestic violence. The appointed members shall include:

- a. a county sheriff selected from a list of three names submitted by the executive board of the Oklahoma Sheriffs' Association,
- b. a chief of a municipal police department selected from a list of three names submitted by the Oklahoma Association of Chiefs of Police,
- c. an attorney licensed in this state who is in private practice selected from a list of three names submitted

2 Association,

3 d. a district attorney selected from a list of three
4 names submitted by the District Attorneys Council,

5 e. a physician selected from a list of three names
6 submitted by the Oklahoma State Medical Association,

7 f. a physician selected from a list of three names
8 submitted by the Oklahoma Osteopathic Association,

9 g. a nurse selected from a list of three names submitted
10 by the Oklahoma Nurses Association,

11 h. two individuals, at least one of whom shall be a
12 survivor of domestic violence, selected from lists of
13 three names submitted by the Oklahoma Coalition
14 Against Domestic Violence and Sexual Assault, ~~and~~

15 i. a member of the Judiciary selected from a list of
16 three names submitted by the Oklahoma Supreme Court,
17 and

18 j. two individuals, at least one of whom shall be an
19 American Indian survivor of domestic violence,
20 selected from a list of three names submitted by the
21 Native Alliance Against Violence, Oklahoma's tribal
22 coalition against domestic violence and sexual
23 assault.

1 B. Every two (2) years the Board shall elect from among its
2 membership a chair and a vice-chair. The Board shall meet at least
3 quarterly and may meet more frequently as necessary as determined by
4 the chair. Members shall serve without compensation but may be
5 reimbursed for necessary travel out of funds available to the Office
6 of the Attorney General pursuant to the State Travel Reimbursement
7 Act; provided, that the reimbursement shall be paid in the case of
8 state employee members by the agency employing the member.

9 C. With funds appropriated or otherwise available for that
10 purpose, the Office of the Attorney General shall provide
11 administrative assistance and services to the Domestic Violence
12 Fatality Review Board.

13 SECTION 2. This act shall become effective November 1, 2018.
