9 AS INTRODUCED

10 An Act relating to state government; amending 74 O.S.
11 2011, Section 250.4, as last amended by Section 1,
12 Chapter 338, O.S.L. 2015 (74 O.S. Supp. 2017, Section
13 250.4), which relates to salaries of state officers
14 modifying salaries; and providing an effective date.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 74 O.S. 2011, Section 250.4, as
17 last amended by Section 1, Chapter 338, O.S.L. 2015 (74 O.S. Supp.
18 2017, Section 250.4), is amended to read as follows:

19 Section 250.4 Pursuant to provisions of the Constitution of the
20 State of Oklahoma from and after the beginning date of a term of
21 office which commences in, or after, January ~~2016~~ 2019, the
22 following officers of the State of Oklahoma shall be annually
23 compensated for their services, payable monthly, as follows:

1 1. The Governor shall receive a salary ~~of One Hundred Forty~~
2 ~~seven Thousand Dollars (\$147,000.00)~~ equal to three times the
3 amount of the base pay for members of the Legislature;

4 2. The Lieutenant Governor shall receive a salary ~~of One~~
5 ~~Hundred Fourteen Thousand Seven Hundred Thirteen Dollars~~
6 ~~(\$114,713.00)~~ equal to eighty percent (80%) of the salary of the
7 Governor;

8 3. The Attorney General shall receive a salary ~~of One Hundred~~
9 ~~Thirty-two Thousand Eight Hundred Twenty-five Dollars (\$132,825.00)~~
10 equal to the salary of the Governor;

11 4. The State Superintendent of Public Instruction shall receive
12 a salary ~~of One Hundred Twenty-four Thousand Three Hundred Seventy-~~
13 ~~three Dollars (\$124,373.00)~~ equal to the salary of the Governor;

14 5. Each member of the Corporation Commission shall receive a
15 salary ~~of One Hundred Fourteen Thousand Seven Hundred Thirteen~~
16 ~~Dollars (\$114,713.00)~~ equal to the salary of the Governor;

17 6. The State Treasurer shall receive a salary ~~of One Hundred~~
18 ~~Fourteen Thousand Seven Hundred Thirteen Dollars (\$114,713.00)~~ equal
19 to the salary of the Governor;

20 7. The State Auditor and Inspector shall receive a salary ~~of~~
21 ~~One Hundred Fourteen Thousand Seven Hundred Thirteen Dollars~~
22 ~~(\$114,713.00)~~ equal to the salary of the Governor;

1 8. The State Insurance Commissioner shall receive a salary of
2 ~~One Hundred Fourteen Thousand Seven Hundred Thirteen Dollars~~
3 ~~(\$114,713.00)~~ equal to the salary of the Governor; and

4 9. The Commissioner of Labor shall receive a salary of ~~One~~
5 ~~Hundred Five Thousand Fifty-three Dollars (\$105,053.00)~~ equal to the
6 salary of the Governor.

7 SECTION 2. This act shall become effective November 1, 2018.
