7                                   AS INTRODUCED

8           An Act relating to water; amending 82 O.S. 2011,  
9           Section 1085.7, as amended by Section 1065, Chapter  
10          304, O.S.L. 2012 (82 O.S. Supp. 2017, Section  
11          1085.7), which relates to the Oklahoma Water  
12          Resources Board Fee Revolving Fund; renaming fund;  
13          specifying that fund is not subject to fiscal year  
14          limitations; specifying sources of revenue; providing  
15          purpose of fund; requiring that claims paid from the  
16          revolving fund be approved solely by the Oklahoma  
17          Water Resources Board; providing an effective date;  
18          and declaring an emergency.

16   BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17           SECTION 1.           AMENDATORY           82 O.S. 2011, Section 1085.7, as  
18           amended by Section 1065, Chapter 304, O.S.L. 2012 (82 O.S. Supp.  
19           2017, Section 1085.7), is amended to read as follows:

20           Section 1085.7 ~~All monies derived from fees shall be deposited~~  
21           ~~with the State Treasurer and credited, apportioned and appropriated~~  
22           ~~to a separate and distinct fund to be known as the~~ There is hereby  
23           created in the State Treasury a revolving fund for the Oklahoma  
24           Water Resources Board Fee Revolving Fund ~~to be used to enforce and~~

1 ~~administer the water duties of~~ designated the "Oklahoma Water  
2 Resources Board Fee Revolving Fund". The fund shall be a continuing  
3 fund, not subject to fiscal year limitations and shall consist of  
4 all fee monies collected by the Oklahoma Water Resources Board, ~~but~~  
5 ~~no monies shall be paid out of said Water Resources Board Fee~~  
6 ~~Revolving Fund until the claim therefor has been itemized and~~  
7 ~~verified by claimant and approved by the Oklahoma Water Resources~~  
8 ~~Board and the Director of the Office of Management and Enterprise~~  
9 ~~Services as provided by law~~ which are not otherwise designated.  
10 ~~When so approved, the State Treasurer shall draw his warrant~~  
11 ~~therefor upon the State Treasurer and the same shall be paid out of~~  
12 All monies accruing to the credit of the fund are hereby  
13 appropriated and may be budgeted and expended by the Oklahoma Water  
14 Resources Board Fee Revolving Fund hereby created for the purpose of  
15 duties imposed upon the Oklahoma Water Resources Board by law.

16 SECTION 2. This act shall become effective July 1, 2018.

17 SECTION 3. It being immediately necessary for the preservation  
18 of the public peace, health or safety, an emergency is hereby  
19 declared to exist, by reason whereof this act shall take effect and  
20 be in full force from and after its passage and approval.
