Knight, Esteemed Leading Knight and was elected as Exalted Ruler in
1986-1987; and
WHEREAS, Mr. McPherson continued to serve his Lodge in many
capacities, including Justice of the Subordinate Forum from 1987-
2005; and
WHEREAS, Mr. McPherson achieved Honorable Life Membership in
April 1997; and
WHEREAS, Mr. McPherson served as Chairman for the New Jersey
North Central District Ritual Committee and also became a certified
Ritualistic judge; and
WHEREAS, Mr. McPherson served as an attorney for both the New
Jersey State Elks Association Convention and Special Children's
Committee and was also Chairman of the New Jersey State Laws
Committee; and
WHEREAS, Mr. McPherson was elected President of the New Jersey
State Elks Association 1999-2000; and
WHEREAS, at the Grand Lodge level, Mr. McPherson was appointed

- 9 has been a loyal member of that Lodge for 30 years; and
- 10 WHEREAS, during that time Mr. Robinson has served in all chairs
- 11 | except for Chaplain and Leading Knight; and
- 12 WHEREAS, Mr. Robinson has been Exalted Ruler seven times and
- 13 | served many years as Lodge trustee; and
- 14 WHEREAS, Mr. Robinson currently serves as Lodge auditor; and
- 15 WHEREAS, Mr. Robinson served as North East District Grand
- 16 | Exalted Ruler in 2010 and served as State Convention Chairman from
- 17 | 2008 to 2015; and
- 18 WHEREAS, Mr. Robinson served as Oklahoma Elks Association
- 19 | President-Elect in 2016 and was elected State President of the
- 20 Oklahoma Elks Association in 2017.
