NEW LAW 14 15 in the Oklahoma Statutes as Section 1021.1 of Title 82, unless there 16 is created a duplication in numbering, reads as follows: This act shall be known and may be cited as the "Oklahoma Water 17 Sustainability Act". 18 SECTION 2. NEW LAW A new section of law to be codified 19 in the Oklahoma Statutes as Section 1021.2 of Title 82, unless there 20 is created a duplication in numbering, reads as follows: 21 The Legislature hereby declares that in order to efficiently 22 utilize and orderly develop the water resources available within 23

each geographic region of this state for the benefit of our

citizens, the public policy of this state is to promote and support the planning and development of long-term water projects to achieve this policy through the use of programs and incentives that first seek to maximize the efficient use of water resources available within each region. The Legislature finds that prioritizing efforts to more efficiently develop our state's water resources to meet the needs of all areas within the state is consistent with the provisions of Section 105.12 of Title 82 of the Oklahoma Statutes. Provided, however, that nothing in this act shall be construed as amending the provisions of law pertaining to rights or permits to use water.

SECTION 3. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1021.3 of Title 82, unless there is created a duplication in numbering, reads as follows:

The Oklahoma Water Resources Board may complete studies that will contribute to the implementation of the policy recommendations of the Oklahoma Comprehensive Water Plan and identify practical and efficient water resource management options. The Board may contract, based upon the availability of funds, with a private company, nonprofit or academic institution to assist with the studies. The subject of the studies shall include but are not limited to:

1. Addressing Oklahoma's projected water and wastewater infrastructure need between the effective date of this act and 2060

- by conducting a statewide infrastructure needs assessment, including
 an assessment of potential water system efficiencies and incentives
 and reviewing both traditional and nontraditional funding
 mechanisms;
 - 2. Assisting nonregulatory local stakeholders and regional water planning groups in identifying efficiencies, incentives and priorities for long-term solutions to water supply needs;
 - 3. Coordinating potential federal, state, tribal, local and corporation partnership opportunities for financing and incentives to develop plans, technical studies and related projects; and
 - 4. Identifying innovative solutions to forecasted water shortages with the goal of maintaining water use at current levels through 2060 by considering the initiatives recommended by the Water for 2060 Advisory Council, including the implementation of a statewide water conservation campaign, and continuing the interdisciplinary Produced Water Working Group to identify alternatives and opportunities for the beneficial use of produced water.
 - SECTION 4. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1021.4 of Title 82, unless there is created a duplication in numbering, reads as follows:
 - The Oklahoma Water Resources Board shall encourage and assist local and regional groups to develop water plans and projects to

1 efficiently maximize the use of water resources within this state, 2 including, but not limited to:

- 1. Voluntary consolidation and regionalization of existing infrastructure and water supplies in order to utilize limited resources most efficiently;
- 2. Maximizing existing reservoirs through activities such as providing financing for raising dams, reallocating existing storage pools and the dredging of reservoirs;
- 3. Increasing water storage and minimizing transportation and evaporative losses of water used for agricultural purposes;
- 4. Managing or augmenting aquifer storage through activities such as the land application or injection of excess fresh, marginal or recycled water; and
- 5. Implementing conservation measures, such as system water loss audits, conservation education programs, technical assistance with long-term planning, water reuse projects and system sustainability projects.
- SECTION 5. NEW LAW A new section of law not to be codified in the Oklahoma Statutes reads as follows:
- The Oklahoma Water Resources Board is authorized to promulgate rules as necessary to implement the provisions of this act.
- 22 SECTION 6. This act shall become effective July 1, 2018.
- 23 <u>SECTION 7. It being immediately necessary for the preservation</u>
 24 <u>of the public peace, health or safety, an emergency is hereby</u>
