10           An Act relating to the 1921 Tulsa Race Riot; creating  
11           the 1921 Tulsa Race Riot Centennial Memorial  
12           Revolving Fund; providing for deposits thereto and  
13           expenditures therefrom; requiring transfer of certain  
14           funds; repealing 74 O.S. 2011, Sections 8201.1,  
15           8201.2, 8203, 8204 and 8205, which relate to the 1921  
16           Tulsa Race Riot; providing for codification; and  
17           providing an effective date.

18   BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19           SECTION 1.       NEW LAW       A new section of law to be codified  
20           in the Oklahoma Statutes as Section 8207 of Title 74, unless there  
21           is created a duplication in numbering, reads as follows:

22           A.   There is hereby created in the State Treasury a revolving  
23           fund for the Oklahoma Historical Society to be designated the "1921  
24           Tulsa Race Riot Centennial Memorial Revolving Fund".   The fund shall  
          be a continuing fund, not subject to fiscal year limitations, and  
          shall consist of all monies received by the Oklahoma Historical

1 Society from appropriations, donations or any other source. All  
2 monies accruing to the credit of the fund are hereby appropriated  
3 and may be budgeted and expended by the Oklahoma Historical Society  
4 for the purpose of commemoration of the centennial of the 1921 Tulsa  
5 Race Riot. Expenditures from the fund shall be made upon warrants  
6 issued by the State Treasurer against claims filed as prescribed by  
7 law with the Director of the Office of Management and Enterprise  
8 Services for approval and payment.

9 B. Any funds in the revolving fund created in Section 8201.2 of  
10 Title 74 of the Oklahoma Statutes on the effective date of this act  
11 shall be transferred to the 1921 Tulsa Race Riot Centennial Memorial  
12 Revolving Fund.

13 SECTION 2. REPEALER 74 O.S. 2011, Sections 8201.1,  
14 8201.2, 8203, 8204 and 8205, are hereby repealed.

15 SECTION 3. This act shall become effective November 1, 2017.
