7 SECTION 2. AMENDATORY 21 O.S. 2011, Section 1290.2, as
8 last amended by Section 2, Chapter 366, O.S.L. 2013 (21 O.S. Supp.
9 2016, Section 1290.2), is amended to read as follows:

10 Section 1290.2.

11 DEFINITIONS

12 A. As used in the Oklahoma Self-Defense Act:

13 1. "Concealed handgun" means a loaded or unloaded pistol, ~~the~~
14 ~~presence of which is~~ or handgun not openly ~~discernible~~ visible to
15 the ordinary observation of a reasonable person;

16 2. "Unconcealed handgun" or "open carry" means a loaded or
17 unloaded pistol or handgun carried upon the person in a ~~belt holster~~
18 ~~or shoulder holster that is wholly or partially~~ where the firearm is
19 visible, or carried upon the person ~~in~~ using a scabbard, sling or
20 case designed for carrying firearms ~~that is wholly or partially~~
21 visible; and

22 3. "Pistol" or "handgun" means any derringer, revolver or
23 semiautomatic firearm which:
24

- 1 a. has an overall barrel or barrels length of less than
2 sixteen (16) inches,
3 b. is capable of discharging ~~a projectile~~ single or
4 multiple projectiles from a single round of ammunition
5 composed of any material which may reasonably be
6 expected to be able to cause lethal injury,
7 c. ~~is designed to~~ can be held and fired by the use of ~~a~~
8 ~~single hand~~ one or both hands, and
9 d. uses ~~either gunpowder, gas or any means of rocket~~
10 ~~propulsion~~ a combustible propellant charge to
11 ~~discharge~~ propel the projectile or projectiles.

12 B. The definition of pistol or handgun for purposes of the
13 Oklahoma Self-Defense Act shall not apply to ~~homemade or~~ imitation
14 pistols, flare guns, underwater fishing guns or blank pistols.

15 SECTION 3. This act shall become effective November 1, 2017.
