9 An Act relating to fines and fees; amending 20 O.S.
10 2011, Section 1313.3, which relates to the
11 fingerprinting fee; modifying certain fees; and
12 providing an effective date.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY 20 O.S. 2011, Section 1313.3, is
15 amended to read as follows:

16 Section 1313.3. A. In addition to the fees imposed by Sections
17 1313.2 and 1313.4 of this title, any person convicted of any
18 offense, including traffic offenses but excluding parking and
19 standing violations, punishable by a fine of Ten Dollars (\$10.00) or
20 more or by incarceration or any person forfeiting bond when charged
21 with such offense, shall be ordered by the court to pay a
22 fingerprinting fee in the amount of ~~Five Dollars (\$5.00)~~ Ten Dollars
23 (\$10.00) for each offense for the A.F.I.S. Fund created by Section
24 150.25 of Title 74 of the Oklahoma Statutes. The fee shall be in

1 addition to and not in substitution for any and all fines and
2 penalties otherwise provided for by law for the offense. The fee
3 shall be collected at the same time as the fees provided for in
4 Section 1313.2 of this title. ~~Four Dollars and fifty cents (\$4.50)~~
5 Nine Dollars (\$9.00) of each fee received pursuant to this section
6 shall be paid directly to the A.F.I.S. Fund and the balance shall be
7 deposited in the General Revenue Fund by the court clerk. The
8 payments shall be made to the appropriate fund by the court clerk on
9 a monthly basis as set forth by subsection H of Section 1313.2 of
10 this title.

11 B. As used in this section:

12 1. "Convicted" means any final adjudication of guilt, whether
13 pursuant to a plea of guilty or nolo contendere or otherwise, and
14 any deferred judgment or suspended sentence; and

15 2. "Court" means any state or municipal court having
16 jurisdiction to impose a criminal fine or penalty.

17 SECTION 2. This act shall become effective November 1, 2017.
