AMENDATORY 73 O.S. 2011, Section 15, as 14 amended by Section 658, Chapter 304, O.S.L. 2012 (73 O.S. Supp. 15 2016, Section 15), is amended to read as follows: 16 Section 15. Except as otherwise provided by law, the custody, 17 supervision, and control of all work or material required in and 18 about the Capitol building and the grounds and appurtenances thereof 19 shall be exercised by the Office of Management and Enterprise 20 Services which shall make all requisitions for supplies, repairs, or 21 material required in the heating, lighting, plumbing, ventilation, 2.2 and operation of the Capitol building and grounds. All activities 23 related to restoration, preservation, enhancement or modification of 24

- 1 | the Capitol building or grounds, as defined in Section 4101 of Title
- 2 | 74 of the Oklahoma Statutes, shall be approved by the State Capitol
- 3 | Preservation Commission before commencement of such activity.
- 4 | Maintenance, as defined in Section 4101 of Title 74 of the Oklahoma
- 5 Statutes, is exempt from such approval requirement.
- 6 | SECTION 2. AMENDATORY 73 O.S. 2011, Section 15.1, as
- 7 | last amended by Section 1, Chapter 335, O.S.L. 2016 (73 O.S. Supp.
- 8 2016, Section 15.1), is amended to read as follows:
- 9 Section 15.1. A. The Legislature shall have management and
- 10 | control of the following space in the State Capitol Building:
  - 1. The space on the third, fourth, fifth and sixth floors;
- 12 2. Approximately one thousand five hundred eighty-five (1,585)
- 13 | square feet of space on the north side of the west wing of the
- 14 basement;

- 3. Approximately four thousand four hundred forty-six (4,446)
- 16 | square feet of space on the north side of the east wing of the
- 17 | basement;
- 18 4. Approximately four thousand seven hundred (4,700) square
- 19 | feet of space on the south side of the west wing of the basement;
- 20 5. Approximately two thousand sixty-nine (2,069) square feet of
- 21 | space on the east side of the north wing of the first floor;
- 22 6. Approximately fifteen thousand two hundred twenty (15,220)
- 23 square feet of space on the north and south sides of the west wing
- 24 of the first floor;

- 7. Approximately one hundred (100) square feet of space between the restrooms and the northwest stairwells and approximately one hundred (100) square feet of space between the restrooms and the northeast stairwells on the second, third, fourth and fifth floors; and
- 8. All space in the west wing of the second floor and all space in the north wing of the second floor that was occupied by the appellate courts prior to relocation to the Wiley Post Historical Building; provided, the Supreme Court shall continue to have exclusive management and control of the Supreme Court courtroom and designated robing room located in the west wing of the second floor.
- B. The space under the management and control of the Legislature pursuant to the provisions of this section shall be allotted as follows:
- 1. Except as otherwise provided in this subsection, all space on the east side of the center of the State Capitol Building shall be occupied by the Senate and all space on the west side of the center of the State Capitol Building shall be occupied by the House of Representatives;
- 2. The space specified in paragraph 5 of subsection A of this section shall be occupied by the Legislative Service Bureau; and
- 3. All space in the north wings of the second, third and fifth floors, other than the space specified in paragraph 7 of subsection A of this section, shall be occupied by the Senate.

- C. The Office of Management and Enterprise Services shall establish an enclosed vending area within the utility shafts accessible on the fourth floor of the State Capitol Building.
- D. The authority of the Legislature to allot space may be delegated to the President Pro Tempore of the Senate and the Speaker of the House of Representatives. Any allotment other than as provided in this section shall be executed pursuant to a written agreement signed by the President Pro Tempore of the Senate and the Speaker of the House of Representatives.
- E. Each House of the State Legislature shall have the exclusive charge of the purchase, use, allotment and disposition of its respective chambers, committee rooms, fixtures, furniture, supplies and apparatus, and shall be responsible for the use and preservation of same. All activities related to restoration, preservation, enhancement or modification of the Capitol building or grounds, as defined in Section 4101 of Title 74 of the Oklahoma Statutes, in space designated to the Senate and House of Representatives, shall be approved by the State Capitol Preservation Commission before commencement of such activity. Maintenance, as defined in Section 4101 of Title 74 of the Oklahoma Statutes, is exempt from such approval requirement.
- F. The provisions of this section shall not prohibit the Legislature from allowing agencies of the executive or judicial departments to use space within the State Capitol Building that is

- under its management and control pursuant to a written agreement signed by the President Pro Tempore of the Senate and the Speaker of the House of Representatives.
- The Office of Management and Enterprise Services shall cause to be created a comprehensive set of architectural drawings reflecting the physical layout of the Capitol spaces allocated to the Legislature pursuant to this section. The President Pro Tempore of the Senate and the Speaker of the House of Representatives shall review and certify the architectural drawings created pursuant to this subsection. The certification required by this subsection shall be accomplished by the signature of each such officer upon the face of the drawings. Upon certification, such architectural drawings shall become the official record of the spaces allocated to the Legislature within the State Capitol Building. The Secretary of State shall attest the signatures required by this subsection and the signed and attested architectural drawings shall be deposited with the State Archivist, as defined in Section 204 of Title 67 of the Oklahoma Statutes. The State Archivist shall hold the signed and attested architectural drawings as an official record of the State of Oklahoma. The Office of Management and Enterprise Services shall provide two copies of the signed and attested architectural drawings to the Secretary of the Senate and two copies to the Clerk of the House of Representatives.

Section 4101. As used in Sections 4101 through 4108 of this title:

- 1. "Public areas" means those areas in the <u>State</u> Capitol open to the general public for general visitation; and
- 2. "Art" means fine art of museum quality representing the highest quality of art objects available to include paintings, graphic arts, art photography and sculpture, aesthetically aligned with recognized values, created by the conscious use of skill and creative imagination;
- 3. "Maintenance" means keeping spaces, structures and infrastructure in proper operating condition in a routine, scheduled or anticipated fashion to prevent failure and/or degradation.

  "Maintenance" restores an existing aspect of the State Capitol or grounds to its original working or aesthetic condition;
- 4. "Restoration" means the act or process of accurately 17 depicting the form, features and character of the State Capitol as 18 it appeared in 1917 (building) and 2002 (dome) by means of the 19 removal of features from later periods in its history and 20 21 reconstruction of missing features from the restoration period. 2.2 limited and sensitive upgrading of mechanical, electrical and 23 plumbing systems and other code-required work to make properties 24 functional is appropriate within a restoration project;

1	5. "Preservation" means the act or process of applying measures
2	necessary to sustain the existing form, integrity and materials of
3	an historic property. Work, including preliminary measures to
4	protect and stabilize the property, generally focuses upon the
5	ongoing maintenance and repair of historic materials and features,
6	rather than extensive replacement and new construction;
7	6. "Enhancement" means an increase or improvement upon the
8	quality, value or extent of the original design intent of the State
9	Capitol, Governor's Mansion or the respective grounds;
10	7. "Modification" means any change to an existing physical
11	attribute of the State Capitol, Governor's Mansion or the respective
12	grounds; and
13	8. "Grounds" means all land surrounding the State Capitol and
14	bordered by Lincoln Boulevard and the land contained within the

- bordered by Lincoln Boulevard and the land contained within the fence line surrounding the Governor's Mansion.
- SECTION 4. AMENDATORY 74 O.S. 2011, Section 4102, as 16 17 last amended by Section 1, Chapter 237, O.S.L. 2015 (74 O.S. Supp. 2016, Section 4102), is amended to read as follows: 18
  - Section 4102. There is hereby re-created, to continue until July 1, 2019 July 1, 2022, in accordance with the provisions of the Oklahoma Sunset Law, the State Capitol Preservation Commission which shall be responsible for planning and supervising approving the preservation and, restoration, enhancement and modification of the interior and exterior in all areas of the State Capitol Building,

One of the members appointed by the Governor, the President 4 Pro Tempore of the Senate, and the Speaker of the House of 5 Representatives shall serve a three-year term; and 6 3. One of the members appointed by the Governor, the President Pro Tempore of the Senate, and the Speaker of the House of 7 Representatives shall serve a five-year term. 9 The term of office for each successor shall be for five (5) 10 years. Any member of the Legislature who is appointed to the 11 Commission shall serve only as long as the member is a member of the 12 respective house from which the member was appointed. C. The Commission shall elect a chair and a vice-chair from its 13 membership to serve for a period of two (2) years. All appointed 14 15 voting and ex-officio members of the State Capitol Preservation Commission shall serve at the pleasure of their appointing 16 17 authorities. C. The first chair of the Commission shall be the Governor who 18 will serve a term of two (2) years. Thereafter, the chair of the 19 20 Commission will rotate between the Speaker of the House of 21 Representatives, the President Pro Tempore of the Senate and the 2.2 Governor for two-year increments in perpetuity. Members of the 23 Commission shall not be compensated except for reimbursement as provided in the State Travel Reimbursement Act. The Commission 24

1 | shall meet at least once per quarter and at the call of the chair as

2 | needed. A quorum of the voting members must be present for any

3 action to be taken. The Commission shall be subject to the Open

4 Meeting Act.

- 5 D. The Office of Management and Enterprise Services shall make
- 6 the necessary arrangements for support services for the State
- 7 | Capitol Preservation Commission. The Commission functions performed
- 8 | by the Governor, the President Pro Tempore of the Senate, the
- 9 | Speaker of the House of Representatives and appointed Senators and
- 10 Representatives are additional functions of their other public
- 11 offices and duties.
- 12 | SECTION 6. AMENDATORY 74 O.S. 2011, Section 4104, as
- 13 | last amended by Section 14, Chapter 209, O.S.L. 2013 (74 O.S. Supp.
- 14 2016, Section 4104), is amended to read as follows:
- 15 Section 4104. A. The State Capitol Preservation Commission
- 16 | shall:
- 1. Research, plan, and have control of modifications and decor
- 18 | Approve all work and activity related to preservation, restoration,
- 19 enhancement and modification in all areas of the interior and
- 20 exterior of the Capitol and, the Governor's Mansion and the
- 21 | respective grounds. The Commission may require architectural
- 22 designs and a written description of the proposed work, or some
- 23 | combination thereof, before taking action. Maintenance is exempt
- 24 from approval of the Commission. Activities related to the Capitol

Restoration Project, as outlined in Sections 345 and 346 of Title 73 of the Oklahoma Statutes are exempt from approval of the Commission;

- 2. Adopt design standards and preservation zones for the

  Capitol, the Governor's Mansion and the respective grounds, which

  shall serve as the primary reference for acceptable preservation,

  restoration, enhancement and modification activities;
- 2. 3. Establish standards for the acquisition and display of works of art for public display in the Capitol and the Governor's Mansion and select such works. Such works of art shall be directly related to the history and culture of the State of Oklahoma;
- 3. 4. Establish procedures by which private contributions of suitable art can be accepted for the Capitol and the Governor's Mansion. The Commission is authorized to accept and make proper disposition of works of art as may be donated to the Commission and this state;
- 4. Have authority to approve and submit to the Long-Range Capital Planning Commission any proposed modification, alteration, renovation, repair, or construction on any part of the Capital and the Governor's Mansion; and
- 5. Have final approval authority for any plans or programs for the restoration, preservation, or display of fine art programs in and surrounding the Capitol and, the Governor's Mansion and the respective grounds.

B. The Long-Range Capital Planning Commission shall submit any
capital construction or renovation project with respect to the State
Capital or the Governor's Mansion to the State Capital Preservation
Commission for its advisory opinion prior to consideration by the
Long-Range Capital Planning Commission.

SECTION 7. AMENDATORY 74 O.S. 2011, Section 4105, as last amended by Section 15, Chapter 209, O.S.L. 2013 (74 O.S. Supp. 2016, Section 4105), is amended to read as follows:

Section 4105. There is hereby established the position of the Capitol Architect and Curator who shall:

- 1. Develop the technical plans and programs for consideration by the State Capitol Preservation Commission and the Long-Range Capital Planning Commission with regard to preservation, restoration, and preservation enhancement and modification of the Capitol and, the Governor's Mansion and the respective grounds;
- 2. Develop and enforce standards adopted for acquisition and display of works of art in and surrounding the Capitol and the Governor's Mansion;
- 3. Coordinate space demands of the various agencies in the

  Capitol and the Governor's Mansion Assume primary responsibility for

  development and revision of the design standards and preservation

  zones in the Capitol, Governor's Mansion and the respective grounds

  and present them to the Commission for adoption;

- 4. Maintain a record of all structural and decor changes made in the Capitol and the Governor's Mansion; and
- 5. Make recommendations to the State Capitol Preservation

  Commission of necessary action on proposed modifications in decor or design to ensure preservation and maintenance of the cultural and historic integrity of the Capitol and, the Governor's Mansion and the respective grounds remains intact.

The Director of the Office of Management and Enterprise Services may contract for the services of a Capitol Architect and Curator or employ such an individual on either a full- or part-time basis.

Compensation for the position will be in accord with similar professional positions in state government.

SECTION 8. AMENDATORY 74 O.S. 2011, Section 4106, as amended by Section 16, Chapter 209, O.S.L. 2013 (74 O.S. Supp. 2016, Section 4106), is amended to read as follows:

Section 4106. The State Capitol Preservation Commission and the Long-Range Capital Planning Commission are is directed to maintain close coordination with the executive, legislative and judicial branches of government to ensure that the needs of each branch of government are considered in all planned development and modifications of the Capitol and the Governor's Mansion.

SECTION 9. AMENDATORY 74 O.S. 2011, Section 4108, is amended to read as follows:

1 Section 4108. The provisions of Sections 4101 through 4107 of 2 this title shall apply to all modifications in the structure or 3 decor of the Capitol and the Governor's Mansion except for those 4 immediate emergency maintenance repairs needed to prevent loss or 5 damage to property or to protect the public during use of the 6 building. SECTION 10. 74 O.S. 2011, Section 4109, as 7 AMENDATORY amended by Section 1014, Chapter 304, O.S.L. 2012 (74 O.S. Supp. 9 2016, Section 4109), is amended to read as follows: 10 Section 4109. By the order of the Director of the Office of Management and Enterprise Services, restoration and, preservation, 11 12 enhancement and modification projects of the State Capitol Building or of the Governor's Mansion may be exempted from the provisions of 13 the Public Competitive Bidding Act of 1974, Section 101 et seq. of 14 15 Title 61 of the Oklahoma Statutes. For exempted State Capitol 16 Building or Governor's Mansion construction projects, the Office of 17 Management and Enterprise Services shall select among contractors qualified by past experience to conduct historical preservation 18 19 projects. SECTION 11. This act shall become effective November 1, 2017. 20
