9	An Act relating to motor vehicles; amending Section 6, Chapter 176, O.S.L. 2013, as amended by Section 3,
10	Chapter 125, O.S.L. 2016 (47 O.S. Supp. 2017, Section 7-626), which relates to the Oklahoma Temporary
11	Motorist Liability Plan; authorizing the Insurance Commissioner to contact with a certain association to
12	serve as Plan Administrator; and providing an effective date.

14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	
16	SECTION 1. AMENDATORY Section 6, Chapter 176, O.S.L.
17	2013, as amended by Section 3, Chapter 125, O.S.L. 2016 (47 O.S.
18	Supp. 2017, Section 7-626), is amended to read as follows:
19	Section 7-626. A. $\frac{1}{4}$ The Insurance Commissioner may contract
20	$\underline{\text{with a}}$ statewide association of county sheriffs in Oklahoma $\underline{\text{shall}}$ $\underline{\text{to}}$
	serve as the Plan Administrator.
21	B. The daily rate for temporary insurance under the Oklahoma
22	Temporary Motorist Liability Plan for the following calendar year
2324	shall be announced on the first Monday in December. The daily cost

1 of coverage and administrative fee shall be paid to the county 2 sheriff's office or municipal police department and the fine and court fees associated with the traffic ticket shall be paid to the 3 court clerk. The daily cost of coverage shall be calculated on each 4 5 twenty-four-hour period from the time the citation was issued pursuant to subparagraph b of paragraph 1 of subsection A of Section 6 7 7-606 of Title 47 of the Oklahoma Statutes this title, rounding up. The county sheriff's office or municipal police department shall not 9 waive premium dues for any defendant, except as provided in 10 subsection D of this section. The county sheriff's office or 11 municipal police department shall remit all proceeds from the daily cost of insurance to the Plan on the first business day of each 12 month to the Plan Administrator. The Plan Administrator shall remit 13 the total statewide monthly premium to the appropriate insurance 14 carrier within sixty (60) days of the premium being earned. 15

- C. If for any reason the premium is not collected, then the Oklahoma Temporary Motorist Liability Plan shall pay the premium out of the Temporary Insurance Premium Pool.
- D. If the citation issued pursuant to subparagraph b of paragraph 1 of subsection A of Section 7-606 of Title 47 of the Oklahoma Statutes this title is dismissed without cost, the coverage provided under the Plan is considered never activated and the premium is considered unearned and shall be waived.
