~~BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:~~

SECTION 1. AMENDATORY 47 O.S. 2011, Section 1135.3, as last amended by Section 23, Chapter 210, O.S.L. 2016 (47 O.S. Supp. 2016, Section 1135.3), is amended to read as follows:

Section 1135.3. A. The Oklahoma Tax Commission is hereby authorized to design and issue appropriate official special license plates to persons wishing to demonstrate support, interest, or membership to or for an organization, occupation, cause or other subject as provided by this section.

1 Special license plates shall not be transferred to any other
2 person but shall be removed from the vehicle upon transfer of
3 ownership and retained. The special license plate may then be used
4 on another vehicle but only after such other vehicle has been
5 registered for the current year.

6 Special license plates shall be renewed each year by the Tax
7 Commission or a motor license agent. The Tax Commission shall
8 annually notify by mail all persons issued special license plates.
9 The notice shall contain all necessary information and shall contain
10 instructions for the renewal procedure upon presentation to a motor
11 license agent or the Tax Commission. The license plates shall be
12 issued on a staggered system.

13 The Tax Commission is hereby directed to develop and implement a
14 system whereby motor license agents are permitted to accept
15 applications for special license plates authorized under this
16 section. The motor license agent shall confirm the applicant's
17 eligibility, if applicable, collect and deposit any amount
18 specifically authorized by law, accept and process the necessary
19 information directly into such system and generate a receipt
20 accordingly. For performance of these duties, motor license agents
21 shall retain the fee provided in Section 1141.1 of this title for
22 registration of a motor vehicle. The motor license agent fees for
23 acceptance of applications and renewals shall be paid out of the
24 Oklahoma Tax Commission Reimbursement Fund.

1 If fewer than one hundred of any type of special license plates
2 authorized prior to January 1, 2004, are issued prior to January 1,
3 2006, the Tax Commission shall discontinue issuance and renewal of
4 that type of special license plate. Any such authorized special
5 license plate registrant shall be allowed to display the license
6 plate upon the designated vehicle until the registration expiration
7 date. After such time the expired special license plate shall be
8 removed from the vehicle.

9 Except as otherwise provided in this section, for special
10 license plates authorized on or after July 1, 2004, no special
11 license plates shall be developed or issued by the Tax Commission
12 until the Commission receives one hundred (100) prepaid applications
13 therefor. The prepaid applications must be received by the Tax
14 Commission within one hundred eighty (180) days of the effective
15 date of the authorization or the authority to issue shall be null
16 and void. In the event one hundred (100) prepaid applications are
17 not received by the Tax Commission within such prescribed time
18 period any payment so received shall be refunded accordingly.

19 contain the Masonic emblem;

1 in consultation with the Shriner's Temples in Oklahoma and shall
2 contain the Shriner's emblem;

3 ~~71.~~ 69. 911 Dispatcher License Plate - such plates shall be
4 issued to persons wishing to demonstrate support for 911
5 dispatchers. Persons applying for such license plate must show
6 proof of current employment as a 911 dispatcher or sign an
7 attestation that they are a currently employed or retired 911
8 dispatcher.

9 C. The fee for such plates shall be Fifteen Dollars (\$15.00)
10 and shall be in addition to all other registration fees provided by
11 the Oklahoma Vehicle License and Registration Act. Unless otherwise
12 provided in this section, the fee shall be apportioned as follows:
13 Eight Dollars (\$8.00) of the special license plate fee shall be
14 deposited in the Oklahoma Tax Commission Reimbursement Fund to be
15 used for the administration of the Oklahoma Vehicle License and
16 Registration Act and the remaining Seven Dollars (\$7.00) of the

19 SECTION 2. AMENDATORY 47 O.S. 2011, Section 1135.5, as
20 last amended by Section 25, Chapter 210, O.S.L. 2016 (47 O.S. Supp.
21 2016, Section 1135.5), is amended to read as follows:

22 Section 1135.5. A. The Oklahoma Tax Commission is hereby
23 authorized to design and issue appropriate official special license
24

1 plates to persons wishing to demonstrate support and provide
2 financial assistance as provided by this section.

3 Special license plates shall not be transferred to any other
4 person but shall be removed from the vehicle upon transfer of
5 ownership and retained. The special license plate may then be used
6 on another vehicle but only after such other vehicle has been
7 registered for the current year with a motor license agent.

8 Special license plates shall be renewed each year by the Tax
9 Commission or a motor license agent. The Tax Commission shall
10 annually notify by mail all persons issued special license plates.
11 The notice shall contain all necessary information and shall contain
12 instructions for the renewal procedure upon presentation to a motor
13 license agent or the Tax Commission. The license plates shall be
14 issued on a staggered system.

15 The Tax Commission is hereby directed to develop and implement a
16 system whereby motor license agents are permitted to accept
17 applications for special license plates authorized under this
18 section. The motor license agent shall confirm the applicant's
19 eligibility, if applicable, collect and deposit any amount
20 specifically authorized by law, accept and process the necessary
21 information directly into such system and generate a receipt
22 accordingly. For performance of these duties, motor license agents
23 shall retain the fee provided in Section 1141.1 of this title for
24 registration of a motor vehicle. The motor license agent fees for

1 acceptance of applications and renewals shall be paid out of the
2 Oklahoma Tax Commission Reimbursement Fund.

3 If fewer than one hundred of any type of special license plates
4 authorized prior to January 1, 2004, are issued prior to January 1,
5 2006, the Tax Commission shall discontinue issuance and renewal of
6 that type of special license plate. Any such authorized special
7 license plate registrant shall be allowed to display the license
8 plate upon the designated vehicle until the registration expiration
9 date. After such time the expired special license plate shall be
10 removed from the vehicle.

11 For special license plates authorized on or after July 1, 2004,
12 no special license plates shall be developed or issued by the Tax
13 Commission until the Commission receives one hundred prepaid
14 applications therefor. The prepaid applications must be received by
15 the Tax Commission within one hundred eighty (180) days of the
16 effective date of the authorization or the authority to issue shall
17 be null and void. In the event one hundred prepaid applications are
18 not received by the Tax Commission within such prescribed time
19 period any payment so received shall be refunded accordingly.

20 B. The special license plates provided by this section are as
21 follows:

22 1. University or College Supporter License ~~Plates~~ Plate - such
23 plates shall be designed and issued to any person wishing to
24 demonstrate support to any state-supported or private university or

1 college. As provided in this section, an amount of the fee
2 collected shall be apportioned as provided in Section 1104.1 of this

4 2. Environmental Awareness License ~~Plates~~ Plate - such plates
5 shall be designed, subject to the criteria to be presented to the
6 Tax Commission by the Department of Environmental Quality in
7 consultation with the Oklahoma Arts Council, and issued to any
8 person wishing to demonstrate support to implement the statewide
9 general public environmental education program created pursuant to
10 the provisions of the Oklahoma Environmental Quality Code. Such
11 plates shall be designed and issued to any person in any combination
12 of numbers and letters from one to a maximum of seven, as for
13 personalized license plates. A dealer's license plate issued
14 pursuant to Section 1116.1 or 1128 of this title may be designated
15 an Environmental Awareness License Plate upon payment of the fee
16 imposed by this section and any other registration fees required by
17 the Oklahoma Vehicle License and Registration Act. As provided in
18 this section, an amount of the fee collected shall be apportioned
19 pursuant to Section 1104.2 of this title;

20 3. Firefighter License ~~Plates~~ Plate - such plates shall be
21 designed for any career or retired firefighter, volunteer or paid.
22 Firefighters may apply for firefighter plates for up to four
23 vehicles with a rated capacity of one (1) ton or less or for a
24 motorcycle upon proof of a fire department membership by either an

1 identification card or letter from the chief of the fire department.
2 Retirees who are eligible for such plates shall provide proof of
3 eligibility upon initial application, but shall not be required to
4 provide proof of eligibility annually. The surviving spouse of any
5 deceased firefighter, if the spouse has not since remarried, may
6 apply for a firefighter license plate for one vehicle with a rated
7 carrying capacity of one (1) ton or less or for a motorcycle upon
8 proof that the deceased firefighter was a member of a fire
9 department by either an identification card or letter from the chief
10 of the fire department. The license plate shall be designed in
11 consultation with the Oklahoma Firefighters Association.

12 As provided in this section, an amount of the fee collected
13 shall be deposited to the Oklahoma State Firemen's Museum Building &
14 Memorial Fund for support of the Oklahoma Firefighters Museum and
15 the Oklahoma ~~Firefighter~~ Fallen and Living Firefighters Memorial;

16 4. Wildlife Conservation License ~~Plates~~ Plate - such plates
17 shall be designed, subject to the criteria to be presented to the
18 Tax Commission by the Oklahoma Department of Wildlife Conservation
19 in consultation with the Oklahoma Arts Council, and issued to any
20 person wishing to demonstrate support for wildlife conservation in
21 this state through the Wildlife Diversity Fund, provided for in
22 Section 3-310 of Title 29 of the Oklahoma Statutes. Such plates may
23 be designed and issued to any person as for personalized license
24 plates.

1 As provided in this section, an amount of the fee collected
2 shall be apportioned pursuant to subsection D of Section 3-310 of
3 Title 29 of the Oklahoma Statutes;

4 5. Child Abuse Prevention License ~~Plates~~ Plate - such plates
5 shall be designed, subject to the criteria to be presented to the
6 Tax Commission by the Office of Child Abuse Prevention in the State
7 Department of Health and the Oklahoma Committee to Prevent Child
8 Abuse, and issued to any person wishing to demonstrate support for
9 the prevention of child abuse.

10 As provided in this section, an amount of the fee collected
11 shall be deposited in the Child Abuse Prevention Fund;

12 6. United States Olympic Committee Supporter License ~~Plates~~
13 Plate - such plates shall be designed and issued to any person
14 wishing to demonstrate support for the United States Olympic
15 Committee. The plates shall be issued to any person in any
16 combination of numbers and letters from one to a maximum of seven,
17 as for personalized license plates. The plate shall contain the
18 official United States Olympic Committee logo. The Tax Commission
19 shall be authorized, if necessary, to enter into a licensing
20 agreement with the United States Olympic Committee for any licensing
21 fees which may be required in order to use the United States Olympic
22 Committee logo or design. The licensing agreement shall provide for
23 a payment of not more than Twenty-five Dollars (\$25.00) for each
24 license plate issued;

1 7. Oklahoma History License ~~Plates~~ Plate - such plates shall be
2 designed and issued to any person wishing to demonstrate interest in
3 Oklahoma history. As provided in this section, an amount of the fee
4 collected shall be deposited to the Oklahoma Historical Society
5 Revolving Fund to be used for educational purposes;

6 8. Historic Route 66 License ~~Plates~~ Plate - such:

7 a. vehicle plates shall be designed to honor historic
8 Route 66, also known as the "Mother Road". As
9 provided in this section, an amount of the fee
10 collected for each vehicle license plate shall be
11 apportioned to the Oklahoma Historical Society
12 Revolving Fund to be distributed to the Route 66
13 Museum located in Clinton, Oklahoma, and

14 b. motorcycle plates shall be designed in consultation
15 with the Oklahoma Route 66 Association, Inc. The
16 Oklahoma Tax Commission shall be authorized to enter
17 into a licensing agreement with the Oklahoma Route 66
18 Association, Inc., for any licensing fees which may be
19 required in order to use the Oklahoma Route 66
20 Association, Inc., logo or design. The licensing
21 agreement shall provide for a payment to the Oklahoma

23 Dollars (\$20.00) for each motorcycle license plate

2 shall be designed and issued to any person wishing to honor the
3 victims of the terrorist bombing attack on the Alfred P. Murrah
4 Federal Building in downtown Oklahoma City on April 19, 1995. As
5 provided in this section, an amount of the fee collected shall be
6 deposited in the Heart of the Heartland Scholarship Fund, as
7 established in Section 2282 of Title 70 of the Oklahoma Statutes;

8 10. Emergency Medical Technician License ~~Plates~~ Plate - such
9 plates shall be designed and issued to any person who is an
10 emergency medical technician. Such persons may apply for an
11 emergency medical technician license plate for each vehicle with a
12 rated carrying capacity of one (1) ton or less upon proof of an
13 emergency medical technician's license. The license plate shall be
14 designed in consultation with the state association of emergency
15 medical technicians. As provided in this section, an amount of the
16 fee collected shall be apportioned to the Emergency Medical
17 ~~Technician~~ Personnel Death Benefit Revolving Fund created in Section
18 1-2505.2 of Title 63 of the Oklahoma Statutes;

19 11. Fight Breast Cancer License ~~Plates~~ Plate - such plates
20 shall be designed to demonstrate support for the prevention and

22 section, an amount of the fee collected shall be apportioned to the
23 Breast Cancer Act Revolving Fund;

1 12. Crime Victims Awareness License ~~Plates~~ Plate - such plates
2 shall be designed and issued to any person wishing to demonstrate
3 awareness of and support for victims of crimes. The license plates

5 Centre. As provided in this section, an amount of the fee collected

14 1907. The license plates shall be designed in consultation with the
15 Oklahoma Capitol Complex and Centennial Commemoration Commission.
16 As provided in this section, an amount of the fee collected shall be
17 deposited in the Oklahoma Capitol Complex and Centennial
18 Commemoration Commission Revolving Fund created in Section 98.5 of
19 Title 73 of the Oklahoma Statutes;

20 17. Support Education License ~~Plates~~ Plate - such plates shall
21 be designed, subject to criteria to be presented to the Tax
22 Commission by the State Department of Education in consultation with
23 the Oklahoma Arts Council, and issued to any person wishing to
24 demonstrate support for education in this state. All motor license

agents shall display a sample of the Support Education License plate in the area of the business accessed by the public. Twenty-three Dollars (\$23.00) of the fee collected shall be apportioned as follows:

- a. five percent (5%) shall be deposited to the Education Reform Revolving Fund,
- b. five percent (5%) shall be deposited to the Higher Education Revolving Fund,
- c. five percent (5%) shall be deposited to the State Career Technology Fund, and

17 be issued to any person in any combination of numbers and letters
18 from one to a maximum of seven, as for personalized license plates.
19 The plate shall contain the official Boy Scouts of America logo.
20 The Tax Commission shall be authorized, if necessary, to enter into
21 a licensing agreement with the Boy Scouts of America for any
22 licensing fees which may be required in order to use the Boy Scouts
23 of America logo or design. The licensing agreement shall provide
24

1 for a payment to the Boy Scouts of America of not more than Twenty
2 Dollars (\$20.00) for each license plate issued;

3 20. Urban Forestry and Beautification License ~~Plates~~ Plate -
4 such plates shall be designed, subject to criteria to be presented
5 to the Tax Commission, by the Oklahoma Department of Agriculture,
6 Food, and Forestry in consultation with nonprofit organizations in
7 this state that develop and operate programs to encourage urban
8 forestry and beautification, and issued to any person wishing to
9 demonstrate support of such programs. As provided in this section,
10 an amount of the fee collected shall be apportioned as provided in
11 Section 1104.5 of this title;

12 21. Oklahoma State Parks Supporter License ~~Plates~~ Plate - such
13 plates shall be designed, subject to criteria to be presented to the
14 Tax Commission by the Oklahoma Tourism and Recreation Department,
15 and issued to any person wishing to demonstrate support for the
16 Oklahoma state parks system. Twenty-three Dollars (\$23.00) of the
17 fee collected shall be deposited in the Oklahoma Tourism and
18 Recreation Department Revolving Fund. Such money shall be
19 designated for and may only be expended for the support of Oklahoma
20 state parks;

22 plates shall be issued to any person wishing to demonstrate support
23 of pregnant women who are committed to placing their children for

3 shall be designed and final terminology delivered in consultation

The plates shall be designed in consultation with the Veterinary Medical Association. Twenty Dollars (\$20.00) of the fee collected shall be designated by the purchaser of the plate to be deposited in the Oklahoma Pet Overpopulation Fund created in Section 2368.13 of Title 68 of the Oklahoma Statutes or the Animal Friendly Revolving Fund created in Section 1104.10 of this title;

32. Patriot License Plate - such plates shall be designed in consultation with the Military Department of Oklahoma and issued to any person wishing to demonstrate support for Oklahoma residents who

1 are members of the Oklahoma National Guard and deployed on active
2 duty. The plates shall be issued to any person in any combination
3 of numbers and letters from one to a maximum of seven, as for
4 personalized license plates. As provided in this section, a portion
5 of the fee collected shall be deposited in the Patriot License Plate
6 Revolving Fund created in Section 1104.11 of this title;

7 33. Global War on Terrorism License Plate - such plate shall be
8 designed in consultation with the Military Department of Oklahoma
9 and issued to any person wishing to demonstrate support for Oklahoma
10 residents who are members of the Armed Forces of the United States
11 or Oklahoma National Guard that have served in the Global War on
12 Terrorism. The plate shall be issued to any person in any
13 combination of numbers and letters from one to a maximum of six. As
14 provided in this section, a portion of the fee collected shall be
15 deposited in the 45th Infantry Division Museum Fund created in
16 Section 235.1 of Title 44 of the Oklahoma Statutes;

17 34. Boys and Girls Clubs of America Supporter License ~~Plates~~
18 Plate - such plates shall be designed and issued to any person
19 wishing to demonstrate support for the Boys and Girls Clubs of

21 combination of numbers and letters from one to a maximum of seven,
22 as for personalized license plates. The plate shall contain the
23 official Boys and Girls Clubs of America logo. The Tax Commission,

12 issued to any person in any combination of numbers and letters from
13 one to a maximum of seven, as for personalized plates. Twenty-four
14 Dollars (\$24.00) of the fee collected shall be deposited in the
15 Oklahoma Aeronautics Commission Revolving Fund, for expenditure as
16 provided in Section 91 of Title 3 of the Oklahoma Statutes;

17 64. Ducks Unlimited License Plate - such plates shall be
18 designed and issued to any person wishing to demonstrate support for
19 Ducks Unlimited. Such plates shall be designed in consultation with
20 Ducks Unlimited. The Oklahoma Tax Commission shall be authorized to
21 enter into a licensing agreement with Ducks Unlimited for any
22 licensing fee which may be required in order to use the Ducks

1 SECTION 3. AMENDATORY 3 O.S. 2011, Section 91, as
2 amended by Section 21, Chapter 304, O.S.L. 2012 (3 O.S. Supp. 2016,
3 Section 91), is amended to read as follows:

4 Section 91. There is hereby created in the State Treasury a
5 revolving fund for the Oklahoma Aeronautics Commission to be
6 designated as the Oklahoma Aeronautics Commission Revolving Fund.
7 The fund shall be a continuing fund, not subject to fiscal year
8 limitations, and shall consist of a monthly allocation by the

15 Act, donations, gifts, bequests, contribution, devices, interagency
16 reimbursements, federal funds unless otherwise provided by federal
17 law or regulation, sale of leases and aircraft registration fees and
18 taxes, fees authorized by Section 1135.5 of Title 47 of the Oklahoma
19 Statutes or any other source. All monies accruing to ~~said~~ the fund
20 are hereby appropriated and may be budgeted and expended by the
21 Oklahoma Aeronautics Commission for airport construction and
22 rehabilitation programs ~~and~~, general operations of the agency, for
23 promoting the awareness of aviation and aerospace, and providing
24 financial support for aviation education programs to address the

1 need for a skilled and competent aviation workforce. Expenditures
2 from ~~said~~ the fund shall be made upon warrants issued by the State
3 Treasurer against claims filed as prescribed by law with the
4 Director of the Office of Management and Enterprise Services for
5 approval and payment.

6 SECTION 4. NEW LAW A new section of law to be codified
7 in the Oklahoma Statutes as Section 1104.28 of Title 47, unless
8 there is created a duplication in numbering, reads as follows:

9 A. Twenty Dollars (\$20.00) of the fee authorized by Section
10 1135.5 of Title 47 of the Oklahoma Statutes for the Prisoner of War
11 and Missing in Action License Plate shall be deposited in the
12 Prisoner of War and Missing in Action License Plate Revolving Fund
13 created in subsection B of this section.

14 B. There is hereby created in the State Treasury a revolving
15 fund for the Oklahoma Department of Veterans Affairs to be
16 designated the "Prisoner of War and Missing in Action License Plate
17 Revolving Fund". The fund shall be a continuing fund, not subject
18 to fiscal year limitations, and shall consist of all monies received
19 by the Department pursuant to the provisions of subsection A of this
20 section. All monies accruing to the credit of the fund are hereby
21 appropriated and may be budgeted and expended by the Department for
22 any purpose related to Oklahoma residents who are American veterans.
23 Expenditures from the fund shall be made upon warrants issued by the
24 State Treasurer against claims filed as prescribed by law with the

1 Director of the Office of Management and Enterprise Services for
2 approval and payment.

3 SECTION 5. This act shall become effective November 1, 2017.
