BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 10A O.S. 2011, Section 2-7-202, as last amended by Section 5, Chapter 15, O.S.L. 2013 (10A O.S. Supp. 2017, Section 2-7-202), is amended to read as follows:

Section 2-7-202. A. There is hereby created the Office of Juvenile Affairs which shall be responsible for programs and services for juveniles alleged or adjudicated to be delinquent or in need of supervision. Within the Office of Juvenile Affairs there is hereby created:

1. The Division of Institutional Services which shall be responsible for the institutions operated by or contracted for by the Office of Juvenile Affairs;

1 2. The Division of Community-based Youth Services which shall
2 be responsible for contracting with, monitoring, evaluation and
3 support of community-based Youth Services Agencies;

4 3. The Division of Juvenile and Treatment Services which shall
5 be responsible for intake, probation and parole services,
6 supervision and placement of juveniles and the contracting for,
7 monitoring and evaluation of residential and treatment programs
8 other than institutions and community-based Youth Services Agencies;
9 and

10 4. Such other divisions specifically established by the
11 Executive Director of the Office of Juvenile Affairs, with the
12 approval of the Board.

13 The Executive Director of the Office of Juvenile Affairs, with
14 the approval of the Board, shall appoint a Director of the Division
15 of Institutional Services, a Director of the Division of Community-
16 based Youth Services, and a Director of the Division of Juvenile and
17 Treatment Services to serve as the administrative head of each
18 division, respectively. The Division Directors shall have at least
19 six (6) years of experience in the same or similar programs or
20 facilities as they are to supervise and a baccalaureate degree or
21 higher level of education.

22 B. Suitable office space shall be provided by the Office of
23 Management and Enterprise Services to the Office of Juvenile
24 Affairs, to the extent necessary for the Office to implement its

jurisdictional duties provided by the Oklahoma Juvenile Code, and the Office may incur necessary expenses for office rent.

C. Effective July 1, 1995, the Office of Juvenile Affairs shall be a Merit System agency and all employees of the Office of Juvenile Affairs shall be classified employees who are subject to the Oklahoma Personnel Act and the Merit System of Personnel Administration, except as otherwise provided by law. Effective **June 1, 2020**, employees hired for service at the Southwest Oklahoma Juvenile Center in Manitou shall be considered unclassified and employed in a term-limited appointment. If state services continue at the facility after the designated term, the employee may be transferred into a non-term-limited position. Current employees and employees hired prior to **June 1, 2020**, shall not be subject to this provision.

D. Effective July 1, 1995, within its jurisdictional areas of responsibility, the Office of Juvenile Affairs, acting through the Executive Director, or persons authorized by law, rule or designated by the Executive Director to perform such acts, shall have the power and duty to:

1. Advise, consult, cooperate and enter into agreements with agencies of the state, municipalities and counties, other states and the federal government, and other persons;

2. Enter into agreements for, accept, administer and use, disburse and administer grants of money, personnel and property from

1 the federal government or any department or agency thereof, or from
2 any state or state agency, or from any other source, to promote and
3 carry on in this state any program within its jurisdictional area of
4 responsibility;

5 3. Require the establishment and maintenance of records and
6 reports;

7 4. Establish a system of training for personnel in order to
8 assure uniform statewide application of law and rules;

9 5. Enforce the provisions of the Oklahoma Juvenile Code and
10 rules promulgated thereunder and orders issued pursuant thereto;

11 6. Charge and receive fees pursuant to fee schedules
12 promulgated by the Board of Juvenile Affairs;

13 7. Conduct studies, research and planning of programs and
14 functions, pursuant to the authority granted by the Oklahoma
15 Juvenile Code;

16 8. Enter into interagency agreements;

17 9. Provide administrative and support services to the Board of
18 Juvenile Affairs as necessary to assist the Board in the performance
19 of their duties;

20 10. Establish and maintain such facilities and institutions as
21 are necessary or convenient for the operation of programs for
22 children under the jurisdiction of the Office of Juvenile Affairs;

23 11. Lease, from time to time, any real property which the Board
24 of Juvenile Affairs shall determine advisable to more fully carry

1 into effect the operation of the Office of Juvenile Affairs in
2 accordance with applicable state statutes. All such leases for real
3 property shall be subject to the provisions of Section 63 of Title
4 74 of the Oklahoma Statutes;

5 12. Purchase or lease any equipment, supplies or materials
6 pursuant to The Oklahoma Central Purchasing Act;

7 13. Contract for professional services;

8 14. Acquire, construct, extend, and operate any and all
9 facilities of all kinds which in the judgment of the Executive
10 Director and the approval of the Legislature shall be necessary or
11 convenient to carry out the duties of the Office of Juvenile
12 Affairs, as authorized by law; and

13 15. Exercise all incidental powers which are necessary and
14 proper to implement and administer the purposes of the Oklahoma
15 Juvenile Code.

16 E. The Office of Juvenile Affairs shall maintain a fair, simple
17 and expeditious system for resolution of grievances of all persons
18 committed to the Office of Juvenile Affairs regarding the substance
19 or application of any written or unwritten policy, rule of the Board
20 of Juvenile Affairs or of an agent or contractor of the Office of
21 Juvenile Affairs or any decision, behavior or action by an employee,
22 agent or contractor or by any other person committed to the Office
23 of Juvenile Affairs.

1 F. Effective November 1, 2012, the Office of Juvenile Affairs
2 shall establish a system of certification in accordance with the
3 Oklahoma Child Care Facilities Licensing Act for the shelters
4 managed and operated by the Department of Human Services pursuant to
5 the requirements of Section 1-9-111 of this title. The Office of
6 Juvenile Affairs shall certify shelters pursuant to the requirements
7 of existing rules as established by the Oklahoma Commission on
8 Children and Youth until such time the Office of Juvenile Affairs
9 has promulgated rules for the certification of shelters.

10 SECTION 2. AMENDATORY 74 O.S. 2011, Section 840-5.5, as
11 last amended by Section 1, Chapter 177, O.S.L. 2017 (74 O.S. Supp.
12 2017, Section 840-5.5), is amended to read as follows:

13 Section 840-5.5 A. The following offices, positions, and
14 personnel shall be in the unclassified service and shall not be
15 placed under the classified service:

16 1. Persons chosen by popular vote or appointment to fill an
17 elective office, and their employees, except the employees of the
18 Corporation Commission, the State Department of Education and the
19 Department of Labor;

20 2. Members of boards and commissions, and heads of agencies;
21 also one principal assistant or deputy and one executive secretary
22 for each state agency;

23 3. All judges, elected or appointed, and their employees;
24

1 4. Persons employed with one-time, limited duration, federal or
2 other grant funding that is not continuing or indefinitely
3 renewable. The length of the unclassified employment shall not
4 exceed the period of time for which that specific federal funding is
5 provided;

6 5. All officers and employees of The Oklahoma State System of
7 Higher Education, State Board of Education and Oklahoma Department
8 of Career and Technology Education;

9 6. Persons employed in a professional or scientific capacity to
10 make or conduct a temporary and special inquiry, investigation, or
11 examination on behalf of the Legislature or a committee thereof or
12 by authority of the Governor. These appointments and authorizations
13 shall terminate on the first day of the regular legislative session
14 immediately following the appointment, if not terminated earlier.
15 However, nothing in this paragraph shall prevent the reauthorization
16 and reappointment of any such person. Any such appointment shall be
17 funded from the budget of the appointing authority;

18 7. Election officials and employees;

19 8. Temporary employees employed to work less than one thousand
20 (1,000) hours in any twelve-month period, and seasonal employees
21 employed by the Oklahoma Tourism and Recreation Department pursuant
22 to Section 2241 of this title who work less than one thousand six
23 hundred (1,600) hours in any twelve-month period;

1 9. Department of Public Safety employees occupying the
2 following offices or positions:

- 3 a. administrative aides to the Commissioner,
- 4 b. executive secretaries to the Commissioner,
- 5 c. the Governor's representative of the Oklahoma Highway
6 Safety Office who shall be appointed by the Governor,
- 7 d. Highway Patrol Colonel,
- 8 e. Highway Patrol Lieutenant Colonel,
- 9 f. Director of Finance,
- 10 g. noncommissioned pilots,
- 11 h. Information Systems Administrator,
- 12 i. Law Enforcement Telecommunications System Specialist,
- 13 j. Director of Driver Compliance,
- 14 k. Director of Transportation Division,
- 15 l. Director of the Oklahoma Highway Safety Office,
- 16 m. Civil Rights Administrator,
- 17 n. Budget Analyst,
- 18 o. Comptroller,
- 19 p. Chaplain,
- 20 q. Helicopter Mechanic,
- 21 r. Director of Safety Compliance,
- 22 s. Human Resources Director,
- 23 t. Administrator of Department Services, and

1 u. a maximum of seven positions for the purpose of
2 administering programs in the Oklahoma Highway Safety
3 Office, within full-time employee limitations of the
4 Department, employed with federal funding that is
5 continuing or indefinitely renewable. The
6 authorization for such positions shall be terminated
7 if the federal funding for positions is discontinued;
8 provided, any person appointed to a position prescribed in
9 subparagraph d or e of this paragraph shall have a right of return
10 to the classified commissioned position without any loss of rights,
11 privileges or benefits immediately upon completion of the duties in
12 the unclassified commissioned position;

13 10. Professional trainees only during the prescribed length of
14 their course of training or extension study;

15 11. Students who are employed on a part-time basis, which shall
16 be seventy-five percent (75%) of a normal forty-hour work week or
17 thirty (30) hours per week, or less, or on a full-time basis if the
18 employment is pursuant to a cooperative education program such as
19 that provided for under Title I IV-D of the Higher Education Act of
20 1965 (20 U.S.C. 1087a-1087c), as amended, and who are regularly
21 enrolled in:

22 a. an institution of higher learning within The Oklahoma
23 State System of Higher Education,
24

- b. an institution of higher learning qualified to become coordinated with The Oklahoma State System of Higher Education. For purposes of this section, a student shall be considered a regularly enrolled student if the student is enrolled in a minimum of five (5) hours of accredited graduate courses or a minimum of ten (10) hours of accredited undergraduate courses; provided, however, the student shall only be required to be enrolled in a minimum of six (6) hours of accredited undergraduate courses during the summer, or
- c. high school students regularly enrolled in a high school in Oklahoma and regularly attending classes during such time of enrollment;

12. The spouses of personnel who are employed on a part-time basis to assist or work as a relief for their spouses in the Oklahoma Tourism and Recreation Department;

13. Service substitute attendants who are needed to replace museum and site attendants who are unavoidably absent. Service substitutes may work as part-time or full-time relief for absentees for a period of not more than four (4) weeks per year in the Oklahoma Historical Society sites and museums; such substitutes will not count towards the agency's full-time-equivalent (FTE) employee limit;

14. Employees of the Oklahoma House of Representatives, the State Senate, or the Legislative Service Bureau;

15. Corporation Commission personnel occupying the following

10 personnel occupying the following offices and positions at each
11 facility:

- 12 a. Director of Facility,

- 15 d. Executive Secretary to Director, and
- 16 e. Directors or Heads of Departments or Services;

42. The Development Officer within the Oklahoma Department of Libraries;

43. Oklahoma Real Estate Commission personnel occupying the following offices and positions:

- a. Educational Program Director, and
- b. Data Processing Manager;

44. A Chief Consumer Credit Examiner for the Department of Consumer Credit;

45. All officers and employees of the Oklahoma Capitol Complex and Centennial Commemoration Commission;

46. All officers and employees of the Oklahoma Motor Vehicle Commission;

47. One Museum Archivist of The Will Rogers Memorial Commission;

1 48. One Fire Protection Consultant of the Office of the State

23 adjustments and increases in salary or benefits which the employee
24 would have received but for the leave of absence.
