9	<pre>municipal proposed budget; requiring proposed budget be published on the municipality's website, if</pre>
10	available; amending 19 O.S. 2011, Section 1412, which relates to public hearing on county proposed budget;
11	requiring proposed budget be published on the
12	county's website; increasing time requirement for certain publications; and providing an effective ate.

15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. AMENDATORY 11 O.S. 2011, Section 17-208, is
17	amended to read as follows:
18	Section 17-208. The municipal governing body shall hold a
19	public hearing on the proposed budget no later than fifteen (15)
20	days prior to the beginning of the budget year. Notice of the date,
21	time and place of the hearing, together with the proposed budget
22	summary, shall be published on the municipality's website, if
23	available, and in a newspaper of general circulation in the
24	municipality not less than <b>five (5)</b> days before the date of the

1 hearing. The municipal clerk shall make available a sufficient 2 number of copies of the proposed budget as the governing body shall determine and have them available for review or for distribution or 3 sale at the office of the municipal clerk. Whenever the total 4 5 operating budget, not including debt service, does not exceed Twelve Thousand Dollars (\$12,000.00) per year, the proposed budget summary 6 7 and notice may be posted at the governing body's principal headquarters in lieu of publication in a newspaper. At the public 8 9 hearing on the budget any person may present to the governing body 10 comments, recommendations or information on any part of the proposed 11 budget.

12 SECTION 2. AMENDATORY 19 O.S. 2011, Section 1412, is 13 amended to read as follows:

Section 1412. The county budget board shall hold a public hearing on the proposed budget no later than fifteen (15) days prior to the beginning of the budget year. Notice of the date, time and place of the hearing, together with the proposed budget summaries, shall be published on the county's website and in a newspaper of general circulation in the county not less than five (5) seven (7) days before the date of the hearing. Affidavit and proof of publication shall be attached to the budget when filed with the county excise board and State Auditor and Inspector. The county clerk shall make available a sufficient number of copies of the proposed budgets as the county budget board shall determine and have

them available for review or for distribution or sale at the office of the county clerk. At the public hearing on the budgets, any person may present to the county budget board comments, recommendations or information on any part of the proposed budget. SECTION 3.
