BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY Section 22, Chapter 366, O.S.L. 2016, as amended by Section 6, Chapter 381, O.S.L. 2017 (37A O.S. Supp. 2017, Section 2-110), is amended to read as follows:

Section 2-110. A mixed beverage license shall authorize the holder thereof:

1. To purchase alcohol, spirits, beer and/or wine in retail containers from the holder of a wine and spirits wholesaler and beer distributor license as specifically provided by law; and

2. To sell, offer for sale and possess mixed beverages for on-premises consumption only; provided, the holder of a mixed beverage license issued for an establishment which is also a restaurant may purchase wine directly from a winemaker and beer directly from a small brewer who is permitted and has elected to self-distribute as provided in Article XXVIII of the Oklahoma Constitution; and

1 3. In a municipality in which a university is located, to sell
2 beer in original packages only for off-premises consumption, from
3 8:00 a.m. until midnight on the day of any regularly scheduled
4 football game of the university.

5 Sales and service of mixed beverages by holders of mixed
6 beverage licenses shall be limited to the licensed premises of the
7 licensee unless the holder of the mixed beverage license also
8 obtains a caterer license or a mixed beverage/caterer combination
9 license. A mixed beverage license shall only be issued in counties
10 of this state where the sale of alcoholic beverages by the
11 individual drink for on-premises consumption has been authorized. A
12 separate license shall be required for each place of business.

13 Upon application, a mixed beverage license shall be issued for
14 any place of business functioning as a motion picture theater, as
15 defined by Section 1-103 of this title. Provided, that upon proof
16 of legal age to consume alcohol, every patron being served alcoholic
17 beverages shall be required to wear a wrist bracelet or receive a
18 hand stamp identifying the patron as being of legal age to consume
19 alcohol. This requirement shall only apply inside a motion picture
20 theater auditorium where individuals under the legal age to consume
21 alcohol are allowed.

22 SECTION 2. This act shall become effective October 1, 2018.
