14	SECTION 1. AMENDATORY 26 O.S. 2011, Section 2-111.1, is		
15	amended to read as follows:		
16	Section 2-111.1. The State Election Board shall appoint the		
17	secretary of each county election board for a term of two (2) years		
18	beginning May 1, 1983, and every two (2) years thereafter; provided,		
19	however, that on October 1, 1981, a secretary shall be appointed in		
20	each county for the balance of a term of two (2) years ending April		
21	30, 1983 beginning May 1, 2019, the State Election Board shall		
22	appoint the secretary of each county election board for a term of		
23	four (4) years beginning May 1, 2019, and every (4) years		
24	thereafter.

1 SECTION 2. AMENDATORY 26 O.S. 2011, Section 2-118, as amended by Section 98, Chapter 304, O.S.L. 2012 (26 O.S. Supp. 2017, 2 Section 2-118), is amended to read as follows: 3 Section 2-118. A. 1. Except as provided by subsection C of 4 5 this section the secretary of each county election board shall be paid an annual salary to be determined by the following schedule. 6 However, the salary of a county election board secretary shall not 7 fall below the level of the April 30, 2003, salary, and the salary 9 of any person who is reappointed to the position of county election 10 board secretary shall not fall below the salary received in the immediately preceding term, regardless of the number of active 11 registered voters in the county. The salary and fringe benefits paid to each secretary shall be paid from county funds on a monthly basis and shall be reimbursed from funds appropriated by the Legislature for that purpose at a rate of not to exceed one hundred thirty-five percent (135%) of the above-specified salaries. Claims for said reimbursement shall be filed according to procedures prescribed by the Secretary of the State Election Board and approved by the Director of the Office of Management and Enterprise Services. Said claims Claims for reimbursement shall only be paid for actual expenditures made by the county. The number of registered voters, for the purposes of this
