6 AS INTRODUCED

7 An Act relating to school superintendents;  
8 establishing maximum salary schedule for  
9 superintendents; prohibiting school district boards  
10 of education from entering into or renewing contracts  
11 above certain caps; allowing the State Board of  
12 Education to approve waivers to certain maximum  
13 amounts for certain districts; providing definition;  
14 providing for promulgation of rules; providing for  
15 codification; providing an effective date; and  
16 declaring an emergency.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. NEW LAW A new section of law to be codified  
16 in the Oklahoma Statutes as Section 18-114.15 of Title 70, unless  
17 there is created a duplication in numbering, reads as follows:

18 A. Beginning with the 2017-2018 school year, a school district  
19 board of education shall not enter into a new contract or renew a  
20 contract with a superintendent after the effective day of this act  
21 that exceeds the maximum compensation amounts provided for in the  
22 following schedule:

1        1. One Hundred Thousand Dollars (\$100,000.00) for the  
2 superintendent of a district or districts with an average daily  
3 membership (ADM) of two hundred fifty (250) or less;

4        2. One Hundred Ten Thousand Dollars (\$110,000.00) for the  
5 superintendent of a district or districts with an ADM of seven  
6 hundred fifty (750) or less but more than two hundred fifty (250);

7        3. One Hundred Twenty Thousand Dollars (\$120,000.00) for the  
8 superintendent of a district or districts with an ADM of one  
9 thousand five hundred (1,500) or less but more than seven hundred  
10 fifty (750);

11       4. One Hundred Thirty Thousand Dollars (\$130,000.00) for the  
12 superintendent of a district or districts with an ADM of three  
13 thousand (3,000) or less but more than one thousand five hundred  
14 (1,500);

15       5. One Hundred Forty Thousand Dollars (\$140,000.00) for the  
16 superintendent of a district or districts with an ADM of six  
17 thousand five hundred (6,500) or less but more than three thousand  
18 (3,000); and

19       6. One Hundred Fifty Thousand Dollars (\$150,000.00) for the  
20 superintendent of a district or districts with an ADM of more than  
21 six thousand five hundred (6,500).

22       B. 1. A school district board of education may enter into a  
23 new contract or renew a contract with a superintendent that exceeds  
24 the maximum compensation amounts provided for in subsection A of

1 this section provided that no state appropriated funds are used for  
2 any amount above the maximum amount allowed.

3 C. The State Board of Education, upon written application by  
4 the school district board of education, may approve a waiver of the  
5 maximum compensation amounts for any district or districts with an  
6 ADM of ten thousand (10,000) or more.

7 D. For the purposes of this section, "compensation" shall mean  
8 base salary and fringe benefits.

9 E. The State Board of Education shall promulgate rules  
10 necessary to implement the provisions of this act.

11 SECTION 2. This act shall become effective July 1, 2017.

12 SECTION 3. It being immediately necessary for the preservation  
13 of the public peace, health or safety, an emergency is hereby  
14 declared to exist, by reason whereof this act shall take effect and  
15 be in full force from and after its passage and approval.
