14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. NEW LAW A new section of law to be codified
16	in the Oklahoma Statutes as Section 18-114.15 of Title 70, unless
17	there is created a duplication in numbering, reads as follows:
18	A. Beginning with the 2017-2018 school year, a school district
19	board of education shall not enter into a new contract or renew a
20	contract with a superintendent after the effective day of this act
21	that exceeds the maximum compensation amounts provided for in the
22	following schedule:

1. One Hundred Thousand Dollars (\$100,000.00) for the superintendent of a district or districts with an average daily membership (ADM) of two hundred fifty (250) or less;

- 2. One Hundred Ten Thousand Dollars (\$110,000.00) for the superintendent of a district or districts with an ADM of seven hundred fifty (750) or less but more than two hundred fifty (250);
- 3. One Hundred Twenty Thousand Dollars (\$120,000.00) for the superintendent of a district or districts with an ADM of one thousand five hundred (1,500) or less but more than seven hundred fifty (750);
- 4. One Hundred Thirty Thousand Dollars (\$130,000.00) for the superintendent of a district or districts with an ADM of three thousand (3,000) or less but more than one thousand five hundred (1,500);
- 5. One Hundred Forty Thousand Dollars (\$140,000.00) for the superintendent of a district or districts with an ADM of six thousand five hundred (6,500) or less but more than three thousand (3,000); and
- 6. One Hundred Fifty Thousand Dollars (\$150,000.00) for the superintendent of a district or districts with an ADM of more than six thousand five hundred (6,500).
- B. 1. A school district board of education may enter into a new contract or renew a contract with a superintendent that exceeds the maximum compensation amounts provided for in subsection A of

- this section provided that no state appropriated funds are used for any amount above the maximum amount allowed.
 - C. The State Board of Education, upon written application by the school district board of education, may approve a waiver of the maximum compensation amounts for any district or districts with an ADM of ten thousand (10,000) or more.
- D. For the purposes of this section, "compensation" shall mean base salary and fringe benefits.
- E. The State Board of Education shall promulgate rules necessary to implement the provisions of this act.
- 11 SECTION 2. This act shall become effective July 1, 2017.
- SECTION 3. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
