7 An Act relating to the Oklahoma Water Resources
8 Board; amending 82 O.S. 2011, Section 1085.7, as
9 amended by Section 1065, Chapter 304, O.S.L. 2012 (82
10 O.S. Supp. 2017, Section 1085.7), which relates to
11 the Oklahoma Water Resources Board Fee Revolving
12 Fund; removing requirement to obtain verification and
13 approval from the Office of Management and Enterprise
14 Services; renaming fund; modifying stipulations of
15 fund; providing an effective date; and declaring an
16 emergency.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 82 O.S. 2011, Section 1085.7, as
16 amended by Section 1065, Chapter 304, O.S.L. 2012 (82 O.S. Supp.
17 2017, Section 1085.7), is amended to read as follows:

18 Section 1085.7. ~~All monies derived from fees shall be deposited~~
19 ~~with the State Treasurer and credited, apportioned and appropriated~~
20 ~~to a separate and distinct fund to be known as the Water Resources~~
21 ~~Board Fee Revolving Fund to be used to enforce and administer the~~
22 ~~water duties of the Oklahoma Water Resources Board, but no monies~~
23 ~~shall be paid out of said Water Resources Board Fee Revolving Fund~~
24 ~~until the claim therefor has been itemized and verified by claimant~~

1 ~~and approved by the Oklahoma Water Resources Board and the Director~~
2 ~~of the Office of Management and Enterprise Services as provided by~~
3 ~~law. When so approved, the State Treasurer shall draw his warrant~~
4 ~~therefor upon the State Treasurer and the same shall be paid out of~~
5 ~~the Water Resources Board Fee Revolving Fund hereby created~~ There is
6 hereby created in the State Treasury a revolving fund for the
7 Oklahoma Water Resources Board to be designated the "Oklahoma Water
8 Resources Board Fee Revolving Fund". The fund shall be a continuing
9 fund for direct and indirect costs of enforcement and administration
10 of the water duties of the Oklahoma Water Resources Board. The fund
11 shall be a continuing fund, not subject to fiscal year limitations
12 and shall consist of all monies collected by the Oklahoma Water
13 Resources Board for water-related fees. All monies accruing to the
14 credit of the fund are hereby appropriated and may be budgeted for
15 the purpose of duties imposed upon the Oklahoma Water Resources
16 Board.

17 SECTION 2. This act shall become effective July 1, 2018.

18 SECTION 3. It being immediately necessary for the preservation
19 of the public peace, health or safety, an emergency is hereby
20 declared to exist, by reason whereof this act shall take effect and
21 be in full force from and after its passage and approval.
