7	An Act relating to hospitals; requiring certain
8	facilities to submit certain information to the State Department of Health; requiring certain facilities to

11	codification; and providing an effective date.

13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
14	SECTION 1. NEW LAW A new section of law to be codified
15	in the Oklahoma Statutes as Section 1-725 of Title 63, unless there
16	is created a duplication in numbering, reads as follows:
17	A. Each hospital, general medical surgical hospital,
18	specialized hospital, critical access hospital and emergency
19	hospital, as such terms are defined by Section 1-701 of Title 63 of
20	the Oklahoma Statutes and each ambulatory surgical center as defined
21	by Section 2657 of Title 63 of the Oklahoma Statutes, shall:
22	1. Beginning with the quarter ending September 30, 2018, and at
23	least annually thereafter, provide to the State Department of
24	Health, utilizing electronic health records software, information on

the total costs for the one hundred most common medical procedures and the fifty most common imaging procedures, by volume, performed in hospital outpatient settings or in ambulatory surgical facilities as established by the Board on an annual basis, along with the related CPT and HCPCS codes; and

- 2. Beginning with the quarter ending September 30, 2018, and at least annually thereafter, provide to the Department, utilizing electronic health records software, the average dollar amount the hospital or ambulatory surgical center bills to private insurers for each procedure and the average amount the hospital or ambulatory surgical center receives in reimbursement from private insurers for each procedure specified in paragraph 1 of subsection A of this section.
- B. Hospitals and ambulatory surgical centers shall provide the information required by subsection A of this section in writing to an individual or the individual's legal guardian upon request.
- C. Hospitals and ambulatory surgical centers shall inform patients of their right to obtain the information specified by subsection A of this section at the earliest reasonable and practicable time after the patient has been admitted to the hospital or ambulatory surgical center.
- D. The provision of information required by subsection B of this act shall not be construed as an invoice, contract or any other
