6 AS INTRODUCED

7 An Act relating to public health and safety; amending
8 63 O.S. 2011, Section 142.2, as amended by Section 1,
Chapter 192, O.S.L. 2017 (63 O.S. Supp. 2017, Section
9 142.2), which relates to definitions of the Oklahoma
Underground Facilities Damage Prevention Act;
10 amending definition; and providing an effective date.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY 63 O.S. 2011, Section 142.2, as
14 amended by Section 1, Chapter 192, O.S.L. 2017 (63 O.S. Supp. 2017,
15 Section 142.2), is amended to read as follows:

16 Section 142.2. As used in the Oklahoma Underground Facilities
17 Damage Prevention Act:

18 1. "Certified project" means a project where the public agency
19 responsible for the public project, as part of its procedure,
20 certifies that the project right-of-way is free and clear of
21 underground facilities or wherein the public agency responsible for
22 such project, as part of its procedure, notifies all persons
23 determined by the public agency to have underground facilities
24

1 located within the construction right-of-way and certifies that all
2 known underground facilities are duly located or noted on the
3 engineering drawings for the project;

4 2. "Damage" means any impact upon or removal of support from an
5 underground facility as a result of explosion, excavation or
6 demolition which according to the operating practices of the
7 operator of the underground facilities would necessitate the repair
8 thereof;

9 3. "Demolish" means to wreck, raze, render, move or remove a
10 structure by means of any equipment or explosive;

11 4. "Demolition" means the act or operation of demolishing a
12 structure;

13 5. "Excavate" means to dig, compress or remove earth, rock or
14 other materials in or on the ground by use of mechanized equipment
15 or blasting, including, but not necessarily limited to, augering,
16 boring, backfilling, drilling, grading, pile driving, plowing in,
17 pulling in, trenching, tunneling and plowing; provided, however,
18 that neither:

19 a. the moving of earth by tools manipulated only by human
20 or animal power, nor

21 b. any form of cultivation for agricultural purposes, nor
22 any augering, dozing by noncommercial dozer operators
23 or digging for postholes, farm ponds, land clearing or
24 other normal agricultural purposes, nor

- c. routine maintenance, nor
- d. work by a public agency or its contractors on a preengineered project, nor
- e. work on a certified project, nor
- f. work on a permitted project, nor
- g. the opening of a grave in a cemetery, nor
- h. a solid waste disposal site which is a preengineered project, nor
- i. any individual excavating on his own property and who is not in the excavating business for hire,

shall be deemed excavation;

6. "Excavation" means the act or operation of excavating;

7. "Excavator" means a person or public agency that intends to excavate or demolish within the State of Oklahoma;

8. "Notification center" means the statewide center currently known as the Oklahoma One-Call System, Inc., which has as one of its purposes to receive notification of planned excavation and demolition in a specified area from excavators, and to disseminate such notification of planned excavation or demolition to operators who are members and participants;

9. "Operator" shall mean and include any person or public agency owning or operating underground facilities;

10. "Permitted project" means a project where a permit for the work to be performed must be issued by a state or federal agency

1 and, as a prerequisite to receiving such permit, the applicant must
2 locate all underground facilities in the area of the work and in the
3 vicinity of any blasting and notify each owner of such underground
4 facilities;

5 11. "Person" includes any individual, partnership, corporation,
6 association, cooperative, trust or other entity, including a person
7 engaged as a contractor by a public agency, but not including a
8 public agency;

9 12. "Preengineered project" means a public project wherein the
10 public agency responsible for such project, as part of its
11 engineering and contract procedures, holds a meeting prior to the
12 commencement of any construction work on such project in which all
13 persons, determined by the public agency to have underground
14 facilities located within the construction area of the project, are
15 invited to attend and given an opportunity to verify or inform the
16 public agency of the location of their underground facilities, if
17 any, within the construction area and where the location of all
18 known underground facilities are duly located or noted on the
19 engineering drawing and specifications for the project;

20 13. "Public agency" means the state or any board, commission or
21 agency of the state;

22 14. "Routine maintenance" means the grading of roads and barrow
23 or drainage ditches, the removal and replacement of pavement,
24 including excavation relating thereto and the installation and

1 maintenance of drainage and bridge facilities, signs, guardrails,
2 and electrical and communications facilities in or on the public
3 rights-of-way by a public agency; and

4 15. "Underground facility" means any underground line, cable,
5 facility, system and appurtenances thereto, for producing, storing,
6 conveying, transmitting or distributing communication (including
7 voice, video, or data information), electricity, power, light, heat,
8 ~~refined petroleum products~~ intrastate and interstate gas pipelines,
9 as described in 49 CFR Part 192.1, intrastate and interstate
10 hazardous liquid or carbon dioxide pipelines, as described in 49 CFR
11 Part 195.1, water (including storm water), steam, sewage and other
12 commodities. ~~Underground facilities shall also mean oil and natural~~
13 ~~gas pipelines that are subject to the Hazardous Liquid~~
14 ~~Transportation System Safety Act and natural gas pipelines subject~~
15 ~~to the jurisdiction of the Oklahoma Corporation Commission Pipeline~~
16 ~~Safety Department,~~ and any oil and gas pipeline located in a public
17 right-of-way.

18 SECTION 2. This act shall become effective November 1, 2018.
