6 AS INTRODUCED

7 A Joint Resolution directing the Secretary of State
8 to refer to the people for their approval or
9 rejection a proposed amendment to Section 3 of
10 Article XIIIIA of the Oklahoma Constitution; directing
11 the Legislature to make line-item appropriations to
12 each institution within The Oklahoma State System of
Higher Education; providing ballot title; and
directing filing.

13 BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
14 2ND SESSION OF THE 56TH OKLAHOMA LEGISLATURE:

15 SECTION 1. The Secretary of State shall refer to the people for
16 their approval or rejection, as and in the manner provided by law,
17 the following proposed amendment to Section 3 of Article XIIIIA of
18 the Oklahoma Constitution to read as follows:

19 Section 3. The appropriations made by the Legislature for all
20 such institutions shall be made ~~in consolidated form without~~
21 ~~reference to any particular institution and the~~ on a line-item basis
22 for each institution within The Oklahoma State System of Higher
23 Education. The Board of Regents herein created shall allocate to

1 each institution according to ~~its needs and functions~~ the line-item
2 appropriations approved by the Legislature.

3 SECTION 2. The Ballot Title for the proposed Constitutional
4 amendment as set forth in SECTION 1 of this resolution shall be in
5 the following form:

8 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

9 This measure amends Section 3 of Article 13A of the Oklahoma
10 Constitution. It directs the Legislature to make line-item
11 appropriations for each institution of higher education within
12 The Oklahoma State System of Higher Education. It also directs
13 the Board of Regents to make allocations to institutions based
14 on the line-item appropriations approved by the Legislature.
