17	the following proposed amendment to Section 23 of Article V of the

19	Section 23. No A. Except as provided for in subsection B of
20	this section, no member of the Legislature shall, during the term
21	for which he was elected, be appointed or elected to any office or
22	commission in the State, which shall have been created, or the
23	emoluments of which shall have been increased, during his term of
24	office, nor shall any member receive any appointment from the

    Governor, the Governor and Senate, or from the Legislature, during
    the term for which he shall have been elected, nor shall any member,
