6 AS INTRODUCED

7 A Joint Resolution directing the Secretary of State
8 to refer to the people for their approval or
9 rejection a proposed amendment to Section 23 of
10 Article V of the Oklahoma Constitution; allowing a
11 member of the Legislature to be employed as a
12 certified teacher with a public school district in
13 this state; providing ballot title; and directing
14 filing.

15 BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
16 2ND SESSION OF THE 56TH OKLAHOMA LEGISLATURE:

17 SECTION 1. The Secretary of State shall refer to the people for
18 their approval or rejection, as and in the manner provided by law,
19 the following proposed amendment to Section 23 of Article V of the
20 Oklahoma Constitution to read as follows:

21 Section 23. ~~No~~ A. Except as provided for in subsection B of
22 this section, no member of the Legislature shall, during the term
23 for which he was elected, be appointed or elected to any office or
24 commission in the State, which shall have been created, or the
emoluments of which shall have been increased, during his term of
office, nor shall any member receive any appointment from the

1 Governor, the Governor and Senate, or from the Legislature, during
2 the term for which he shall have been elected, nor shall any member,
3 during the term for which he shall have been elected, or within two
4 years thereafter, be interested, directly or indirectly, in any
5 contract with the State, or any county or other subdivision thereof,
6 authorized by law passed during the term for which he shall have
7 been elected.

8 B. A member of the Legislature may, during the term for which
9 he was elected or appointed, be employed by and under a contract to
10 teach as a certified teacher with a public school district in this
11 state.

12 SECTION 2. The Ballot Title for the proposed Constitutional
13 amendment as set forth in SECTION 1 of this resolution shall be in
14 the following form:

17 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

18 This measure amends Section 23 of Article 5 of the Oklahoma
19 Constitution. It allows a member of the Legislature to be
20 employed as a certified teacher with a public school district in
21 this state.
