7 AS INTRODUCED

8 A Joint Resolution directing the Secretary of State
9 to refer to the people for their approval or
10 rejection a proposed amendment to the Oklahoma
11 Constitution by adding a new Section 13A to Article
12 X; providing for a tax levy for legal interest in a
13 mineral acreage; setting amount of tax; clarifying
14 certain status of tax relative to other tax;
15 providing for collection and remittance; authorizing
16 certain legislation; providing ballot title; and
17 directing filing.

18 BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
19 2ND SESSION OF THE 56TH OKLAHOMA LEGISLATURE:

20 SECTION 1. The Secretary of State shall refer to the people for
21 their approval or rejection, as and in the manner provided by law,
22 the following proposed amendment to the Oklahoma Constitution by
23 adding a new Section 13A to Article X to read as follows:

24 Section 13A. A. For tax years beginning on or after January 1,
2019, there is hereby levied by the state on each owner of a mineral
interest an annual tax in the amount of Twelve Dollars (\$12.00) per
acre. For purposes of this section, an "owner" is a person or legal

1 entity with a legal interest in the mineral acreage under a well
2 which entitles that person or entity to oil or gas production or the
3 proceeds or revenues therefrom.

4 B. The tax levied pursuant to this section shall be in addition
5 to other taxation of the legal interest in a mineral acreage
6 provided for by law, but shall be subject to applicable credits for
7 the payment of gross production taxes to the state, if any.

8 C. The tax levied pursuant to this section shall be collected
9 and remitted as gross production tax is collected and remitted.

10 D. The Legislature may pass any additional laws that may be
11 required to implement the provisions of this section.

12 SECTION 2. The Ballot Title for the proposed Constitutional
13 amendment as set forth in SECTION 1 of this resolution shall be in
14 the following form:

17 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

18 This measure amends Article 10 of the Oklahoma Constitution. It
19 creates a new Section 13A. It provides for a new tax on mineral
20 interests. The tax would begin in 2019. The tax would be \$12
21 per acre. The tax may be subject to credits for gross
22 production tax paid. The tax would be levied in the same way as
23 gross production tax. The Legislature is given the authority to
24 enact laws related to the provision.
