8 AS INTRODUCED

9 An Act relating to state government; amending 74 O.S.
10 2011, Section 3601.2, as last amended by Section 1,
11 Chapter 351, O.S.L. 2013 (74 O.S. Supp. 2017, Section
12 3601.2), which relates to salaries of chief executive
13 officers; modifying establishment of certain
14 salaries; prohibiting processing of payroll in excess
15 of certain limits; and declaring an emergency.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 74 O.S. 2011, Section 3601.2, as
18 last amended by Section 1, Chapter 351, O.S.L. 2013 (74 O.S. Supp.
19 2017, Section 3601.2), is amended to read as follows:

20 Section 3601.2 A. ~~Beginning July 1, 2013, each agency, board,~~
21 ~~commission, department or program in the executive branch of state~~
22 ~~government shall establish the~~ The salary of each of the chief
23 executive officers for ~~which they have appointing authority~~ state
24 agencies and departments shall be determined by the appointing
authority of the chief executive officer. Such salary shall be set

1 between the minimum and maximum of the range specified in the annual
2 compensation reports required by paragraph 5 of Section 840-1.6A of
3 this title, for full-time employees only.

4 B. All increases require certification of the appointing
5 authority that said action can be implemented for the current fiscal
6 year and subsequent fiscal year without the need for additional
7 funding. The agency, board, commission, department or program shall
8 report increases granted under this section to the Office of
9 Management and Enterprise Services on an annual basis by August 1 of
10 each year. The Office of Management and Enterprise Services shall
11 forward a report of such increases to the Governor, President Pro
12 Tempore of the Senate, and Speaker of the House of Representatives
13 no later than September 1 of each year.

14 C. Every three (3) years beginning with fiscal year 2013, the
15 Office of Management and Enterprise Services shall review these
16 salary ranges and report on and make recommendations on proposed
17 salary ranges in its annual compensation reports mandated by
18 paragraph 5 of Section 840-1.6A of this title. Such recommendations
19 shall be made no later than February 1 for chief executive officers
20 in all state agencies, boards, commissions, departments or programs
21 in the executive branch of state government, including but not
22 limited to those specified in Section 3601.1 of this title. The
23 Office of Management and Enterprise Services shall not process
24

1 payroll in excess of the salary limits recommended in the annual
2 compensation reports.

3 SECTION 2. It being immediately necessary for the preservation
4 of the public peace, health or safety, an emergency is hereby
5 declared to exist, by reason whereof this act shall take effect and
6 be in full force from and after its passage and approval.
