HOUSE BILL 1510

AS INTRODUCED

An Act relating to motor vehicles; amending 47 O.S. 2011, Sections 1135.3 and 1135.5, as last amended by Sections 23 and 25, Chapter 210, O.S.L. 2016 (47 O.S. Supp. 2016, Sections 1135.3 and 1135.5), which relate to special license plates; correcting certain reference; transferring authority for Jenks Trojans License Plate to different section; creating the Bixby Spartans License Plate; establishing plates as financial assistance license plates; providing for design of license plates; authorizing certain licensing agreements; authorizing and limiting certain payments; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 47 O.S. 2011, Section 1135.3, as last amended by Section 23, Chapter 210, O.S.L. 2016 (47 O.S. Supp. 2016, Section 1135.3), is amended to read as follows:

Section 1135.3 A. The Oklahoma Tax Commission is hereby authorized to design and issue appropriate official special license plates to persons wishing to demonstrate support, interest, or membership to or for an organization, occupation, cause or other subject as provided by this section.

1 Special license plates shall not be transferred to any other
2 person but shall be removed from the vehicle upon transfer of
3 ownership and retained. The special license plate may then be used
4 on another vehicle but only after such other vehicle has been
5 registered for the current year.

6 Special license plates shall be renewed each year by the Tax
7 Commission or a motor license agent. The Tax Commission shall
8 annually notify by mail all persons issued special license plates.
9 The notice shall contain all necessary information and shall contain
10 instructions for the renewal procedure upon presentation to a motor
11 license agent or the Tax Commission. The license plates shall be
12 issued on a staggered system.

13 The Tax Commission is hereby directed to develop and implement a
14 system whereby motor license agents are permitted to accept
15 applications for special license plates authorized under this
16 section. The motor license agent shall confirm the applicant's
17 eligibility, if applicable, collect and deposit any amount
18 specifically authorized by law, accept and process the necessary
19 information directly into such system and generate a receipt
20 accordingly. For performance of these duties, motor license agents
21 shall retain the fee provided in Section 1141.1 of this title for
22 registration of a motor vehicle. The motor license agent fees for
23 acceptance of applications and renewals shall be paid out of the
24 Oklahoma Tax Commission Reimbursement Fund.

1 If fewer than one hundred of any type of special license plates
2 authorized prior to January 1, 2004, are issued prior to January 1,
3 2006, the Tax Commission shall discontinue issuance and renewal of
4 that type of special license plate. Any such authorized special
5 license plate registrant shall be allowed to display the license
6 plate upon the designated vehicle until the registration expiration
7 date. After such time the expired special license plate shall be
8 removed from the vehicle.

9 Except as otherwise provided in this section, for special
10 license plates authorized on or after July 1, 2004, no special
11 license plates shall be developed or issued by the Tax Commission
12 until the Commission receives one hundred (100) prepaid applications
13 therefor. The prepaid applications must be received by the Tax
14 Commission within one hundred eighty (180) days of the effective
15 date of the authorization or the authority to issue shall be null
16 and void. In the event one hundred (100) prepaid applications are
17 not received by the Tax Commission within such prescribed time
18 period any payment so received shall be refunded accordingly.

19 B. The special license plates provided by this section are as
20 follows:

21 1. Round and Square Dance License ~~Plates~~ Plate - such plates
22 shall be designed and issued to any person wishing to demonstrate
23 support for round and square dancing;

1 2. National Association for the Advancement of Colored People
2 License ~~Plates~~ Plate - such plates shall be designed, subject to the
3 criteria to be presented to the Tax Commission by the NAACP, and
4 issued to any person wishing to demonstrate support for the NAACP;

5 3. National Rifle Association License ~~Plates~~ Plate - such
6 plates shall be designed, subject to the criteria to be presented to
7 the Tax Commission by the National Rifle Association, and issued to
8 any person wishing to demonstrate support for the National Rifle
9 Association;

10 4. Masonic Fraternity License ~~Plates~~ Plate - such plates shall
11 be designed and issued to any resident of this state who is a member
12 of a Masonic Fraternity of Oklahoma. Such persons may apply for a
13 Masonic Fraternity license plate for each vehicle with a rated
14 carrying capacity of one (1) ton or less upon proof of a Masonic
15 Fraternity membership or upon the presentment of an application for
16 a Masonic Fraternity license plate authorized and approved by the
17 Grand Lodge of Oklahoma. The license plates shall be designed in
18 consultation with the Masonic Fraternities of Oklahoma and shall
19 contain the Masonic emblem;

20 5. Shriner's Hospitals for Burned and Crippled Children License
21 ~~Plates~~ Plate - such plates shall be designed to demonstrate support
22 for Shriner's Hospitals for Burned and Crippled Children and shall
23 be issued to any resident of this state who is a member of a
24 Shriner's Temple in Oklahoma. The license plate shall be designed

1 in consultation with the Shriner's Temples in Oklahoma and shall
2 contain the Shriner's emblem;

3 6. Balloonists License ~~Plates~~ Plate - such plates shall be
4 designed and issued to any person wishing to demonstrate support for
5 hot air ballooning in this state;

6 7. Order of the Eastern Star License ~~Plates~~ Plate - such plates
7 shall be designed and issued to any resident of this state who is a
8 member of an Order of the Eastern Star. Such persons may apply for
9 an Order of the Eastern Star license plate for each vehicle with a
10 rated carrying capacity of one (1) ton or less upon proof of an
11 Order of the Eastern Star membership or upon the presentment of an
12 application for an Order of the Eastern Star license plate
13 authorized and approved by the organization. The license plate
14 shall be designed in consultation with the Order of the Eastern Star
15 and shall contain the Order of the Eastern Star emblem;

16 8. Knights of Columbus License ~~Plates~~ Plate - such plates shall
17 be designed and issued to any resident of this state who is a member
18 of the Knights of Columbus. Such persons may apply for a Knights of
19 Columbus license plate for each vehicle with a rated carrying
20 capacity of one (1) ton or less upon proof of a Knights of Columbus
21 membership or upon the presentment of an application for a Knights
22 of Columbus license plate authorized and approved by the
23 organization. The license plate shall be designed in consultation
24

1 with the Knights of Columbus and shall contain the Knights of
2 Columbus emblem;

3 9. Jaycees License ~~Plates~~ Plate - such plates shall be designed
4 and issued to members of the Jaycees. Persons applying for such
5 license plate must show proof of membership in the Jaycees. The
6 license plates shall be designed in consultation with the Jaycees;

7 10. Ducks Unlimited License ~~Plates~~ Plate - such plates shall be
8 designed and issued to persons wishing to demonstrate support for
9 Ducks Unlimited. The license plates shall be designed in
10 consultation with Ducks Unlimited;

11 11. Kiwanis International License ~~Plates~~ Plate - such plates
12 shall be designed and issued to members of Kiwanis International.
13 Persons applying for such license plate must show proof of
14 membership in Kiwanis International. The license plates shall be
15 designed in consultation with Kiwanis International;

16 12. Certified Public Accountants License ~~Plates~~ Plate - such
17 plates shall be designed and issued to any resident of this state
18 who is a Certified Public Accountant. Such persons may apply for a
19 Certified Public Accountant license plate for each vehicle with a
20 rated carrying capacity of one (1) ton or less upon proof of status
21 as a Certified Public Accountant. The license plates shall be
22 designed in consultation with the Oklahoma Society of Certified
23 Public Accountants;

1 13. Civil Emergency Management License ~~Plates~~ Plate - such
2 plates shall be designed and issued to persons wishing to
3 demonstrate support for the state civil emergency management system.
4 Persons applying for such license plate must show proof of official
5 affiliation by presenting a nonexpired proof of employment,
6 affiliation or retirement in the form of an identification card or
7 letter on official letterhead from a municipal, county or state
8 emergency management department head;

9 14. Civilian Conservation Corps License ~~Plates~~ Plate - such
10 plates shall be designed, subject to criteria to be presented to the
11 Tax Commission, by the Civilian Conservation Corps Association, and
12 issued to any person wishing to demonstrate support of the Civilian
13 Conservation Corps;

14 15. Rotarian License ~~Plates~~ Plate - such plates shall be
15 designed and issued to any resident of this state who is a member of
16 a Rotarian Club of Oklahoma. Such persons may apply for a Rotarian
17 license plate for each vehicle with a rated carrying capacity of one
18 (1) ton or less upon proof of a Rotarian Club membership or upon the
19 presentment of an application for a Rotarian license plate
20 authorized and approved by a Rotarian Club of Oklahoma. The license
21 plates shall be designed in consultation with the five Rotarian
22 District Governors and shall contain the Rotarian emblem;

23 16. Benevolent Protective Order of Elks License Plate - such
24 plates shall be designed, subject to criteria to be presented to the

1 Tax Commission, by the Benevolent Protective Order of Elks, and
2 issued to any resident of this state who is a member of the
3 Benevolent Protective Order of Elks;

4 17. Humane Society License ~~Plates~~ Plate - such plates shall be
5 designed and issued to any person wishing to demonstrate support for
6 the Humane Society of the United States. The plates shall be issued
7 to any person in any combination of numbers and letters from one to
8 a maximum of seven, as for personalized license plates. The plate
9 shall contain the official Humane Society logo;

10 18. Oklahoma Mustang Club License Plate - such plates shall be
11 designed, subject to criteria to be presented to the Tax Commission,
12 by the Oklahoma Mustang Club, and issued to any resident of this
13 state who is a member of the Oklahoma Mustang Club. Such persons
14 may apply for an Oklahoma Mustang Club license plate upon
15 presentment of proof of membership in the Oklahoma Mustang Club.
16 The plates shall be issued to any person in any combination of
17 numbers and letters from one to a maximum of seven, as for
18 personalized license plates;

19 19. American Business Clubs (AMBUCS) License ~~Plates~~ Plate -
20 such plates shall be designed and issued to members of American
21 Business Clubs. Persons applying for such license plate must show
22 proof of membership in AMBUCS. The license plates shall be designed
23 in consultation with American Business Clubs;

1 20. West Point 200th Anniversary License ~~Plates~~ Plate - such
2 plates shall be designed and issued to any person wishing to
3 commemorate the Two Hundredth Anniversary of the founding of the
4 United States Military Academy at West Point, New York. The license
5 plates shall be designed in consultation with the West Point Society
6 of Central Oklahoma;

7 21. Oklahoma Aquarium License Plate - such plates shall be
8 designed and issued to persons wishing to demonstrate support for
9 the Oklahoma Aquarium. The license plates shall be designed in
10 consultation with the Oklahoma Aquarium;

11 22. The Pride of Broken Arrow License ~~Plates~~ Plate - such
12 plates shall be designed and issued to any person wishing to
13 demonstrate support for The Pride of Broken Arrow marching band.
14 The plates shall be designed in consultation with the Broken Arrow
15 Public School System;

16 23. Fellowship of Christian Athletes License ~~Plates~~ Plate -
17 such plates shall be designed in consultation with the Fellowship of
18 Christian Athletes and issued to members and supporters of the
19 Fellowship of Christian Athletes;

20 24. Parrothead Club License ~~Plates~~ Plate - such plates shall be
21 designed and issued to members and supporters of the Parrothead
22 Club. The license plate shall be issued to any person in any
23 combination of numbers and letters from one to a maximum of seven as
24 for personalized license plates;

1 25. Oklahoma Bicycling Coalition License ~~Plates~~ Plate - such
2 plates shall be designed and issued to any person who is a member of
3 the Oklahoma Bicycling Coalition. The license plates shall be
4 designed in consultation with the Oklahoma Bicycling Coalition;

5 26. Electric Lineman License Plate - such plates shall be
6 designed and issued to persons wishing to demonstrate support for
7 Oklahoma's electric linemen. The license plates shall be designed
8 in consultation with the Oklahoma Electric Superintendent's
9 Association;

10 27. Alpha Kappa Alpha License Plate - such plates shall be
11 designed and issued to any person who is a member of Alpha Kappa
12 Alpha Sorority. The license plates shall be designed in
13 consultation with the Oklahoma Chapter of Alpha Kappa Alpha
14 Sorority;

15 28. The National Pan-Hellenic Council Incorporated License
16 Plate - such plates shall be designed and issued to any person
17 wishing to demonstrate support to any of the nine sororities and
18 fraternities recognized by the National Pan-Hellenic Council
19 Incorporated. The license plates shall be designed in consultation
20 with the Oklahoma Chapter of the National Pan-Hellenic Council
21 Incorporated;

22 29. Organ, Eye and Tissue License Plate - such plates shall be
23 designed and issued to persons wishing to demonstrate support and
24 increase awareness for organ, eye and tissue donation. The license

1 plates shall be designed in consultation with the State Department
2 of Health;

3 30. Central Oklahoma Habitat for Humanity License Plate - such
4 plates shall be designed and issued to persons wishing to
5 demonstrate support and increase awareness for Habitat for Humanity.
6 The license plate shall be designed in consultation with Central
7 Oklahoma Habitat for Humanity;

8 31. Family Career and Community Leaders of America Incorporated
9 License Plate - such plates shall be designed and issued to persons
10 wishing to demonstrate support for Family Career and Community
11 Leaders of America Incorporated. The license plates shall be
12 designed in consultation with Family Career and Community Leaders of
13 America Incorporated;

14 32. Delta Sigma Theta License Plate - such plates shall be
15 designed and issued to any person who is a member of Delta Sigma
16 Theta Sorority. The license plates shall be designed in
17 consultation with the Oklahoma Chapter of Delta Sigma Theta Sorority
18 Incorporated;

19 33. Omega Psi Phi License Plate - such plates shall be designed
20 and issued to any person who is a member of Omega Psi Phi
21 Fraternity. The license plates shall be designed in consultation
22 with the Oklahoma Chapter of Omega Psi Phi Fraternity Incorporated;

23 34. Alpha Phi Alpha License Plate - such plates shall be
24 designed and issued to any person who is a member of Alpha Phi Alpha

1 Fraternity. The license plates shall be designed in consultation
2 with the Oklahoma Chapter of Alpha Phi Alpha Fraternity
3 Incorporated;

4 35. 50th Anniversary of the Interstate System of Highways
5 License Plate - such plates shall be designed and issued to persons
6 wishing to commemorate the 50th Anniversary of the Interstate System
7 of Highways. The license plates shall be designed in consultation
8 with the American Association of State Highway and Transportation
9 Officials;

10 36. Kappa Alpha Psi License Plate - such plates shall be
11 designed and issued to any person who is a member of Kappa Alpha Psi
12 Fraternity. The license plates shall be designed in consultation
13 with the Oklahoma Chapter of Kappa Alpha Psi Fraternity
14 Incorporated;

15 37. Sigma Gamma Rho License Plate - such plates shall be
16 designed and issued to any person who is a member of Sigma Gamma Rho
17 Sorority. The license plates shall be designed in consultation with
18 the Oklahoma Chapter of Sigma Gamma Rho Sorority Incorporated.
19 Subject to the provisions of subsection A of this section, the Sigma
20 Gamma Rho License Plate is hereby reauthorized effective November 1,
21 2013;

22 38. Multiple Sclerosis License Plate - such plates shall be
23 designed and issued to persons wishing to demonstrate support for
24 and increase awareness of multiple sclerosis. The license plates

1 shall be designed in consultation with the Oklahoma Chapter of the
2 National Multiple Sclerosis Society;

3 39. Frederick Douglass High School License ~~Plates~~ Plate - such
4 plates shall be designed and issued to any person wishing to
5 demonstrate support for Frederick Douglass High School located in
6 Oklahoma City. The plates shall be designed in consultation with
7 representatives of Frederick Douglass High School National Alumni
8 Association;

9 40. United States Air Force Academy License ~~Plates~~ Plate - such
10 plates shall be designed and issued to any person wishing to
11 demonstrate support for the United States Air Force Academy;

12 41. In God We Trust License Plate - such plates shall be
13 designed to include the motto, "In God We Trust", and shall be
14 issued to any person wishing to demonstrate support for the motto;

15 42. National Weather Center License Plate - such plates shall
16 be designed and issued to any person wishing to demonstrate support
17 for the National Weather Center in Norman. The plates shall be
18 designed in consultation with representatives of the National
19 Weather Center Directors;

20 43. Make-A-Wish Foundation License Plate - such plates shall be
21 designed and issued to persons wishing to demonstrate support for
22 the Make-A-Wish Foundation. The license plates shall be designed in
23 consultation with the Oklahoma Chapter of the National Make-A-Wish
24 Foundation;

1 44. South Central Section PGA Foundation License Plate - such
2 plates shall be designed and issued to persons wishing to
3 demonstrate support for the South Central Section PGA Foundation.
4 The license plates shall be designed in consultation with the South
5 Central Section PGA Foundation;

6 45. Putnam City High School License Plate - such plates shall
7 be designed and issued to any person wishing to demonstrate support
8 for Putnam City High School. The plates shall be designed in
9 consultation with representatives of Putnam City High School Alumni
10 Association, Inc.;

11 46. Autism Awareness License Plate - such plates shall be
12 designed and issued to any person wishing to increase awareness of
13 autism. The license plate shall be designed in consultation with
14 the Oklahoma Autism Network;

15 47. Oklahoma Blood Institute License Plate - such plates shall
16 be designed and issued to any person wishing to demonstrate support
17 for the Oklahoma Blood Institute. The license plates shall be
18 designed in consultation with the Oklahoma Blood Institute;

19 48. Zeta Phi Beta and Phi Beta Sigma License Plate - such
20 plates shall be designed and issued to any person who is a member of
21 Zeta Phi Beta Sorority or Phi Beta Sigma Fraternity. The license
22 plates shall be designed in consultation with the Oklahoma chapters
23 of Zeta Phi Beta Sorority Incorporated and Phi Beta Sigma Fraternity
24 Incorporated;

1 49. Star Spencer High School License Plate - such plates shall
2 be designed and issued to any person wishing to demonstrate support
3 for Star Spencer High School located in Oklahoma City. The plates
4 shall be designed in consultation with representatives of the Star
5 Spencer High School Alumni Association. Subject to the provisions
6 of subsection A of this section, the Star Spencer High School
7 License Plate is hereby reauthorized effective November 1, 2015;

8 50. Northeast High School License Plate - such plates shall be
9 designed and issued to any person wishing to demonstrate support for
10 Northeast High School located in Oklahoma City. The plates shall be
11 designed in consultation with representatives of the Northeast High
12 School Alumni Association;

13 51. Oklahoma City Central High School License Plate - such
14 plates shall be designed and issued to any person wishing to
15 demonstrate support for the Oklahoma City Central High School Alumni
16 Association. The plates shall be designed in consultation with
17 representatives of the Oklahoma City Central High School Alumni
18 Association;

19 52. Historic Greenwood District License Plate - such plates
20 shall be issued to persons wishing to demonstrate support for music
21 festivals held in the Historic Greenwood District in Tulsa,
22 Oklahoma. The license plates shall be designed in consultation with
23 the Greenwood Cultural Center;

1 53. Oklahoma Rifle Association License Plate - such plates
2 shall be designed and issued to any person wishing to demonstrate
3 support for the Oklahoma Rifle Association. The plates shall be
4 designed in consultation with representatives of the Oklahoma Rifle
5 Association;

6 54. Oklahoma City Thunder License Plate - such plates shall be
7 designed and issued to any person wishing to demonstrate support for
8 the Oklahoma City Thunder. The license plate shall be designed in
9 consultation with the Oklahoma City Thunder organization;

10 55. Ovarian Cancer Awareness License Plate - such plates shall
11 be designed and issued to any person wishing to increase awareness
12 of ovarian cancer. The license plate shall be designed in
13 consultation with the HOPE in Oklahoma organization;

14 56. BMW Car Club of America License Plate - such plates shall
15 be designed and issued to any person wishing to demonstrate support
16 for the BMW Car Club of America. The plates shall be issued to any
17 person in any combination of numbers and letters from one to a
18 maximum of seven, as for personalized license plates. The license
19 plate shall be designed in consultation with the Sunbelt Chapter of
20 the BMW Car Club of America. Subject to the provisions of
21 subsection A of this section, the BMW Car Club of America License
22 Plate is hereby reauthorized effective November 1, 2013;

23 57. Don't Tread On Me License Plate - such plates shall be
24 designed to include the yellow background and rattlesnake emblem

1 above the motto "DON'T TREAD ON ME" as found on the historic Gadsden
2 flag, and shall be issued to any person wishing to demonstrate
3 support for the freedom and liberty of the Republic;

4 58. Oklahomans for the Arts License Plate - such plates shall
5 be designed and issued to any person wishing to demonstrate support
6 for arts, culture and creative industries as well as arts education.
7 The plates shall be designed in consultation with Oklahomans for the
8 Arts;

9 59. Oklahoma City Barons License Plate - such plates shall be
10 designed and issued to any person wishing to demonstrate support for
11 the Oklahoma City Barons. The license plate shall be designed in
12 consultation with the Oklahoma City Barons organization. The
13 license plates shall be issued to any person in any combination of
14 numbers and letters from one to a maximum of six;

15 60. Oklahoma City Redhawks License Plate - such plates shall be
16 designed and issued to any person wishing to demonstrate support for
17 the Oklahoma City Redhawks. The license plate shall be designed in
18 consultation with the Oklahoma City Redhawks organization;

19 61. Tulsa Shock License Plate - such plates shall be designed
20 and issued to any person wishing to demonstrate support for the
21 Tulsa Shock. The license plate shall be designed in consultation
22 with the Tulsa Shock organization;

23 62. Tulsa Oilers License Plate - such plates shall be designed
24 and issued to any person wishing to demonstrate support for the

1 Tulsa Oilers. The license plate shall be designed in consultation
2 with the Tulsa Oilers organization;

3 63. Tulsa Drillers License Plate - such plates shall be
4 designed and issued to any person wishing to demonstrate support for
5 the Tulsa Drillers. The license plate shall be designed in
6 consultation with the Tulsa Drillers organization;

7 64. Millwood School District License Plate - such plates shall
8 be designed and issued to any person wishing to demonstrate support
9 for the Millwood School District. The license plate shall be
10 designed in consultation with representatives of the Millwood School
11 District;

12 65. Booker T. Washington High School License Plate - such
13 plates shall be issued to persons wishing to demonstrate support for
14 Booker T. Washington High School and shall be designed in
15 consultation with the Booker T. Washington High School National
16 Alumni Association;

17 66. Oklahoma Current State Flag License Plate - such plates
18 shall be designed to include the current Oklahoma state flag and
19 issued to any person wishing to demonstrate support for the current
20 Oklahoma state flag. The plates shall be designed in consultation
21 with the Friends of the Oklahoma History Center;

22 67. Oklahoma Original State Flag License Plate - such plates
23 shall be designed to include the original Oklahoma state flag and
24 issued to any person wishing to demonstrate support for the original

Oklahoma state flag. The plates shall be designed in consultation with the Friends of the Oklahoma History Center. The plates shall be issued to any person in any combination of numbers and letters from one to a maximum of seven, as for personalized plates. Subject to the provisions of subsection A of this section, the Oklahoma Original State Flag license plate is hereby reauthorized effective November 1, 2015;

68. Tulsa 66ers License Plate - such plates shall be designed and issued to any person wishing to demonstrate support for the Tulsa 66ers. The plates shall be designed in consultation with the Tulsa 66ers Organization;

~~69. Jenks Trojans License Plate - such plates shall be issued to persons wishing to demonstrate support for Jenks School District and shall be designed in consultation with representatives of the Jenks School District;~~

~~70.~~ Frederick Bombers License Plate - such plates shall be issued to persons wishing to demonstrate support for the Frederick School District and shall be designed in consultation with representatives of the Frederick School District; and

3 C. The fee for such plates shall be Fifteen Dollars (\$15.00)
4 and shall be in addition to all other registration fees provided by
5 the Oklahoma Vehicle License and Registration Act. Unless otherwise
6 provided in this section, the fee shall be apportioned as follows:
7 Eight Dollars (\$8.00) of the special license plate fee shall be
8 deposited in the Oklahoma Tax Commission Reimbursement Fund to be
9 used for the administration of the Oklahoma Vehicle License and
10 Registration Act and the remaining Seven Dollars (\$7.00) of the
11 special license plate fee shall be apportioned as provided in
12 Section 1104 of this title.

13 SECTION 2. AMENDATORY 47 O.S. 2011, Section 1135.5, as
14 last amended by Section 25, Chapter 210, O.S.L. 2016 (47 O.S. Supp.
15 2016, Section 1135.5), is amended to read as follows:

16 Section 1135.5 A. The Oklahoma Tax Commission is hereby
17 authorized to design and issue appropriate official special license
18 plates to persons wishing to demonstrate support and provide
19 financial assistance as provided by this section.

20 Special license plates shall not be transferred to any other
21 person but shall be removed from the vehicle upon transfer of
22 ownership and retained. The special license plate may then be used
23 on another vehicle but only after such other vehicle has been
24 registered for the current year with a motor license agent.

1 Special license plates shall be renewed each year by the Tax
2 Commission or a motor license agent. The Tax Commission shall
3 annually notify by mail all persons issued special license plates.
4 The notice shall contain all necessary information and shall contain
5 instructions for the renewal procedure upon presentation to a motor
6 license agent or the Tax Commission. The license plates shall be
7 issued on a staggered system.

8 The Tax Commission is hereby directed to develop and implement a
9 system whereby motor license agents are permitted to accept
10 applications for special license plates authorized under this
11 section. The motor license agent shall confirm the applicant's
12 eligibility, if applicable, collect and deposit any amount
13 specifically authorized by law, accept and process the necessary
14 information directly into such system and generate a receipt
15 accordingly. For performance of these duties, motor license agents
16 shall retain the fee provided in Section 1141.1 of this title for
17 registration of a motor vehicle. The motor license agent fees for
18 acceptance of applications and renewals shall be paid out of the
19 Oklahoma Tax Commission Reimbursement Fund.

20 If fewer than one hundred of any type of special license plates
21 authorized prior to January 1, 2004, are issued prior to January 1,
22 2006, the Tax Commission shall discontinue issuance and renewal of
23 that type of special license plate. Any such authorized special
24 license plate registrant shall be allowed to display the license

1 plate upon the designated vehicle until the registration expiration
2 date. After such time the expired special license plate shall be
3 removed from the vehicle.

4 For special license plates authorized on or after July 1, 2004,
5 no special license plates shall be developed or issued by the Tax
6 Commission until the Commission receives one hundred prepaid
7 applications therefor. The prepaid applications must be received by
8 the Tax Commission within one hundred eighty (180) days of the
9 effective date of the authorization or the authority to issue shall
10 be null and void. In the event one hundred prepaid applications are
11 not received by the Tax Commission within such prescribed time
12 period any payment so received shall be refunded accordingly.

13 B. The special license plates provided by this section are as
14 follows:

15 1. University or College Supporter License ~~Plates~~ Plate - such
16 plates shall be designed and issued to any person wishing to
17 demonstrate support to any state-supported or private university or
18 college. As provided in this section, an amount of the fee
19 collected shall be apportioned as provided in Section 1104.1 of this
20 title;

21 2. Environmental Awareness License ~~Plates~~ Plate - such plates
22 shall be designed, subject to the criteria to be presented to the
23 Tax Commission by the Department of Environmental Quality in
24 consultation with the Oklahoma Arts Council, and issued to any

1 person wishing to demonstrate support to implement the statewide
2 general public environmental education program created pursuant to
3 the provisions of the Oklahoma Environmental Quality Code. Such
4 plates shall be designed and issued to any person in any combination
5 of numbers and letters from one to a maximum of seven, as for
6 personalized license plates. A dealer's license plate issued
7 pursuant to Section 1116.1 or 1128 of this title may be designated
8 an Environmental Awareness License Plate upon payment of the fee
9 imposed by this section and any other registration fees required by
10 the Oklahoma Vehicle License and Registration Act. As provided in
11 this section, an amount of the fee collected shall be apportioned
12 pursuant to Section 1104.2 of this title;

13 3. Firefighter License ~~Plates~~ Plate - such plates shall be
14 designed for any career or retired firefighter, volunteer or paid.
15 Firefighters may apply for firefighter plates for up to four
16 vehicles with a rated capacity of one (1) ton or less or for a
17 motorcycle upon proof of a fire department membership by either an
18 identification card or letter from the chief of the fire department.
19 Retirees who are eligible for such plates shall provide proof of
20 eligibility upon initial application, but shall not be required to
21 provide proof of eligibility annually. The surviving spouse of any
22 deceased firefighter, if the spouse has not since remarried, may
23 apply for a firefighter license plate for one vehicle with a rated
24 carrying capacity of one (1) ton or less or for a motorcycle upon

1 proof that the deceased firefighter was a member of a fire
2 department by either an identification card or letter from the chief
3 of the fire department. The license plate shall be designed in
4 consultation with the Oklahoma Firefighters Association.

5 As provided in this section, an amount of the fee collected
6 shall be deposited to the Oklahoma State Firemen's Museum Building &
7 Memorial Fund for support of the Oklahoma Firefighters Museum and
8 the Oklahoma ~~Firefighter~~ Fallen and Living Firefighters Memorial;

9 4. Wildlife Conservation License ~~Plates~~ Plate - such plates
10 shall be designed, subject to the criteria to be presented to the
11 Tax Commission by the Oklahoma Department of Wildlife Conservation
12 in consultation with the Oklahoma Arts Council, and issued to any
13 person wishing to demonstrate support for wildlife conservation in
14 this state through the Wildlife Diversity Fund, provided for in
15 Section 3-310 of Title 29 of the Oklahoma Statutes. Such plates may
16 be designed and issued to any person as for personalized license
17 plates.

18 As provided in this section, an amount of the fee collected
19 shall be apportioned pursuant to subsection D of Section 3-310 of
20 Title 29 of the Oklahoma Statutes;

21 5. Child Abuse Prevention License ~~Plates~~ Plate - such plates
22 shall be designed, subject to the criteria to be presented to the
23 Tax Commission by the Office of Child Abuse Prevention in the State
24 Department of Health and the Oklahoma Committee to Prevent Child

1 Abuse, and issued to any person wishing to demonstrate support for
2 the prevention of child abuse.

3 As provided in this section, an amount of the fee collected
4 shall be deposited in the Child Abuse Prevention Fund;

5 6. United States Olympic Committee Supporter License ~~Plates~~
6 Plate - such plates shall be designed and issued to any person
7 wishing to demonstrate support for the United States Olympic
8 Committee. The plates shall be issued to any person in any
9 combination of numbers and letters from one to a maximum of seven,
10 as for personalized license plates. The plate shall contain the
11 official United States Olympic Committee logo. The Tax Commission
12 shall be authorized, if necessary, to enter into a licensing
13 agreement with the United States Olympic Committee for any licensing
14 fees which may be required in order to use the United States Olympic
15 Committee logo or design. The licensing agreement shall provide for
16 a payment of not more than Twenty-five Dollars (\$25.00) for each
17 license plate issued;

18 7. Oklahoma History License ~~Plates~~ Plate - such plates shall be
19 designed and issued to any person wishing to demonstrate interest in
20 Oklahoma history. As provided in this section, an amount of the fee
21 collected shall be deposited to the Oklahoma Historical Society
22 Revolving Fund to be used for educational purposes;

23 8. Historic Route 66 License ~~Plates~~ Plate - such plates shall
24 be designed to honor historic Route 66, also known as the "Mother

1 Road". As provided in this section, an amount of the fee collected
2 shall be apportioned to the Oklahoma Historical Society Revolving
3 Fund to be distributed to the Route 66 Museum located in Clinton,
4 Oklahoma;

5 9. Heart of the Heartland License ~~Plates~~ Plate - such plates
6 shall be designed and issued to any person wishing to honor the
7 victims of the terrorist bombing attack on the Alfred P. Murrah
8 Federal Building in downtown Oklahoma City on April 19, 1995. As
9 provided in this section, an amount of the fee collected shall be
10 deposited in the Heart of the Heartland Scholarship Fund, as
11 established in Section 2282 of Title 70 of the Oklahoma Statutes;

12 10. Emergency Medical Technician License ~~Plates~~ Plate - such
13 plates shall be designed and issued to any person who is an
14 emergency medical technician. Such persons may apply for an
15 emergency medical technician license plate for each vehicle with a
16 rated carrying capacity of one (1) ton or less upon proof of an
17 emergency medical technician's license. The license plate shall be
18 designed in consultation with the state association of emergency
19 medical technicians. As provided in this section, an amount of the
20 fee collected shall be apportioned to the Emergency Medical
21 ~~Technician~~ Personnel Death Benefit Revolving Fund created in Section
22 1-2505.2 of Title 63 of the Oklahoma Statutes;

23 11. Fight Breast Cancer License ~~Plates~~ Plate - such plates
24 shall be designed to demonstrate support for the prevention and

1 treatment of breast cancer in this state. As provided in this
2 section, an amount of the fee collected shall be apportioned to the
3 Breast Cancer Act Revolving Fund;

4 12. Crime Victims Awareness License ~~Plates~~ Plate - such plates
5 shall be designed and issued to any person wishing to demonstrate
6 awareness of and support for victims of crimes. The license plates
7 shall be designed in consultation with the Oklahoma Crime Victims
8 Centre. As provided in this section, an amount of the fee collected
9 shall be apportioned to the Attorney General's Revolving Fund for
10 the Office of the Attorney General, which is hereby directed to use
11 such funds to contract with a statewide nonprofit organization to
12 provide services to crime victims;

13 13. Oklahoma Safe Kids Association License ~~Plates~~ Plate - such
14 plates shall be designed and issued to any person wishing to
15 demonstrate support and awareness of the Oklahoma Safe Kids
16 Association. The license plate shall be designed in consultation
17 with the Oklahoma Safe Kids Association. As provided in this
18 section, an amount of the fee collected shall be deposited in the
19 Children's Hospital - Oklahoma Safe Kids Association Revolving Fund
20 to be distributed to the Oklahoma Safe Kids Association program;

21 14. Four-H Club License ~~Plates~~ Plate - such plates shall be
22 designed, subject to criteria to be presented to the Tax Commission
23 by the Four-H Foundation, and issued to any person wishing to
24 demonstrate support of the Four-H Club. Such plates may be designed

1 and issued to any person as for personalized license plates. As
2 provided in this section, an amount of the fee collected shall be
3 apportioned to the OSU Extension Service License Plate Revolving
4 Fund created in Section 1104.4 of this title;

5 15. Agricultural Awareness License ~~Plates~~ Plate - such plates
6 shall be designed, subject to criteria to be presented to the Tax
7 Commission, by the Oklahoma Department of Agriculture, Food, and
8 Forestry in consultation with the Oklahoma Arts Council, and issued
9 to any person wishing to demonstrate support of the Department's Ag
10 in the Classroom Education Program. As provided in this section, an
11 amount of the fee collected shall be apportioned as provided in
12 Section 1104.3 of this title;

13 16. Oklahoma Statehood Centennial License ~~Plates~~ Plate - such
14 plates shall be designed and issued to any person wishing to
15 commemorate the centennial of Oklahoma's admission to statehood in
16 1907. The license plates shall be designed in consultation with the
17 Oklahoma Capitol Complex and Centennial Commemoration Commission.
18 As provided in this section, an amount of the fee collected shall be
19 deposited in the Oklahoma Capitol Complex and Centennial
20 Commemoration Commission Revolving Fund created in Section 98.5 of
21 Title 73 of the Oklahoma Statutes;

22 17. Support Education License ~~Plates~~ Plate - such plates shall
23 be designed, subject to criteria to be presented to the Tax
24 Commission by the State Department of Education in consultation with

1 the Oklahoma Arts Council, and issued to any person wishing to
2 demonstrate support for education in this state. All motor license
3 agents shall display a sample of the Support Education License plate
4 in the area of the business accessed by the public. Twenty-three
5 Dollars (\$23.00) of the fee collected shall be apportioned as
6 follows:

- 7 a. five percent (5%) shall be deposited to the Education
8 Reform Revolving Fund,
- 9 b. five percent (5%) shall be deposited to the Higher
10 Education Revolving Fund,
- 11 c. five percent (5%) shall be deposited to the State
12 Career Technology Fund, and
- 13 d. eighty-five percent (85%) of the fee shall be

4 plate shall be the word "Retired". The letters "TRP" shall be used
5 in combination with three numbers on either side of the insignia or
6 emblem. The color of the letters and numbers shall be brown.

7 Retirees who are eligible for such plates shall provide proof of
8 eligibility upon initial application, but shall not be required to
9 provide proof of eligibility annually. The surviving spouse of any

14 section, an amount of the fee collected shall be deposited into the
15 Law Enforcement Retirement Fund;

16 19. Boy Scouts of America Supporter License ~~Plates~~ Plate - such
17 plates shall be designed and issued to any person wishing to
18 demonstrate support for the Boy Scouts of America. The plates shall
19 be issued to any person in any combination of numbers and letters
20 from one to a maximum of seven, as for personalized license plates.
21 The plate shall contain the official Boy Scouts of America logo.
22 The Tax Commission shall be authorized, if necessary, to enter into
23 a licensing agreement with the Boy Scouts of America for any
24 licensing fees which may be required in order to use the Boy Scouts

1 of America logo or design. The licensing agreement shall provide
2 for a payment to the Boy Scouts of America of not more than Twenty
3 Dollars (\$20.00) for each license plate issued;

4 20. Urban Forestry and Beautification License ~~Plates~~ Plate -
5 such plates shall be designed, subject to criteria to be presented
6 to the Tax Commission, by the Oklahoma Department of Agriculture,
7 Food, and Forestry in consultation with nonprofit organizations in
8 this state that develop and operate programs to encourage urban
9 forestry and beautification, and issued to any person wishing to
10 demonstrate support of such programs. As provided in this section,
11 an amount of the fee collected shall be apportioned as provided in
12 Section 1104.5 of this title;

13 21. Oklahoma State Parks Supporter License ~~Plates~~ Plate - such
14 plates shall be designed, subject to criteria to be presented to the
15 Tax Commission by the Oklahoma Tourism and Recreation Department,
16 and issued to any person wishing to demonstrate support for the
17 Oklahoma state parks system. Twenty-three Dollars (\$23.00) of the
18 fee collected shall be deposited in the Oklahoma Tourism and
19 Recreation Department Revolving Fund. Such money shall be
20 designated for and may only be expended for the support of Oklahoma
21 state parks;

22 22. Adoption Creates Families License ~~Plates~~ Plate - such
23 plates shall be issued to any person wishing to demonstrate support
24 of pregnant women who are committed to placing their children for

1 adoption and wishing to provide assistance to guardians, adoptive
2 parents and other created families to assist in the adoption and
3 placement of children in permanent, safe homes. The license plates
4 shall be designed and final terminology delivered in consultation
5 with the Oklahoma Adoption Coalition and the Department of Human
6 Services. Twenty-five Dollars (\$25.00) of the fee collected shall
7 be deposited in a revolving fund established in the State Treasury
8 for and to be used by the Department of Human Services for the
9 implementation of the Investing in Stronger Oklahoma Families Act
10 specifically for created families;

11 23. Choose Life License ~~Plates~~ Plate - such plates shall be
12 designed, subject to criteria presented to the Tax Commission, by
13 Choose Life, Inc., and issued to any person who wishes to
14 demonstrate support of organizations that encourage adoption as a
15 positive choice for women with unplanned pregnancies. As provided
16 in this section, an amount of the fee collected shall be deposited
17 in the Choose Life Assistance Program Revolving Fund established in
18 Section 1104.6 of this title;

19 24. Future Farmers of America License Plate - such plates shall
20 be designed and issued to persons wishing to demonstrate support for
21 the Oklahoma FFA (formerly known as Future Farmers of America). The
22 license plates shall be designed in consultation with the Oklahoma
23 FFA Foundation Board of Directors. As provided in this section, an
24

1 amount of the fee collected shall be apportioned as provided in
2 Section 1104.7 of this title;

3 25. Lions Club License ~~Plates~~ Plate - such plates shall be
4 designed and issued to persons wishing to demonstrate support for
5 the Lions Club of Oklahoma. The plates shall be issued to any
6 person in any combination of numbers and letters from one to a
7 maximum of seven, as for personalized license plates. The license
8 plates shall be designed in consultation with the Oklahoma Lions
9 Service Foundation and shall contain the official logo of the
10 International Association of Lions Clubs. The Tax Commission shall
11 be authorized to enter into a licensing agreement with the Oklahoma
12 Lions Service Foundation. The licensing agreement shall provide for
13 a payment to the Oklahoma Lions Service Foundation of not more than
14 Ten Dollars (\$10.00) for each license plate issued;

15 26. Color Oklahoma License ~~Plates~~ Plate - such plates shall be
16 designed, subject to criteria to be presented to the Tax Commission
17 by the Oklahoma Native Plant Society, and issued to any person
18 wishing to demonstrate support for preserving and planting
19 wildflowers and native plants in Oklahoma and to promote Oklahoma's
20 wildflower heritage through education. As provided in this section,
21 an amount of the fee collected shall be apportioned as provided in
22 Section 1104.8 of this title;

23 27. Girl Scouts of the United States of America Supporter
24 License ~~Plates~~ Plate - such plates shall be designed and issued to

1 any person wishing to demonstrate support for the Girl Scouts of the
2 United States of America. The plates shall be issued to any person
3 in any combination of numbers and letters from one to a maximum of
4 seven, as for personalized license plates. The plate shall contain
5 the official Girl Scouts of the United States of America logo. The
6 Tax Commission shall be authorized, if necessary, to enter into a
7 licensing agreement with the Girl Scouts of the United States of
8 America for any licensing fees which may be required in order to use
9 the Girl Scouts of the United States of America logo or design. The
10 licensing agreement shall provide for a payment to the Girl Scouts
11 of Magic Empire Council, acting on behalf of all Oklahoma Girl Scout
12 councils, of not more than Twenty Dollars (\$20.00) for each license
13 plate issued;

14 28. Oklahoma City Memorial Marathon License ~~Plates~~ Plate - such
15 plates shall be designed and issued to any person wishing to
16 demonstrate support for the Oklahoma City Memorial Marathon. The
17 plate shall be designed in consultation with the Oklahoma City
18 Memorial Marathon. The Tax Commission shall be authorized to enter
19 into a licensing agreement with the Oklahoma City Memorial Marathon
20 for any licensing fees which may be required in order to use the
21 Oklahoma City Memorial Marathon logo or design. The licensing
22 agreement shall provide for a payment to the Oklahoma City Memorial
23 Marathon of not more than Twenty Dollars (\$20.00) for each license
24 plate issued;

1 29. Oklahoma Scenic Rivers License Plate - such plates shall be
2 designed to demonstrate support for the Oklahoma Scenic Rivers. The
3 plates shall be designed in consultation with the Oklahoma Scenic
4 Rivers Commission. Twenty-five Dollars (\$25.00) of the fee shall be
5 apportioned to the Oklahoma Scenic Rivers Commission;

6 30. Fight Cancer License Plate - such plates shall be designed
7 to demonstrate support for the Oklahoma Central Cancer Registry.
8 The plate shall contain the American Cancer Society logo. The
9 American Cancer Society logo shall be used in accordance with the
10 American Cancer Society's branding guidelines and shall only be
11 utilized to support the Oklahoma Central Cancer Registry. Twenty
12 Dollars (\$20.00) of the fee shall be apportioned to the Oklahoma
13 Central Cancer Registry Revolving Fund;

14 31. Animal Friendly License Plate - such plates shall be
15 designed and issued to any person wishing to demonstrate support for
16 controlling the overpopulation of dogs and cats through educational
17 and sterilization efforts. The plates shall be designed in
18 consultation with the Veterinary Medical Association. Twenty
19 Dollars (\$20.00) of the fee collected shall be designated by the
20 purchaser of the plate to be deposited in the Oklahoma Pet
21 Overpopulation Fund created in Section 2368.13 of Title 68 of the
22 Oklahoma Statutes or the Animal Friendly Revolving Fund created in
23 Section 1104.10 of this title;

1 32. Patriot License Plate - such plates shall be designed in
2 consultation with the Military Department of Oklahoma and issued to
3 any person wishing to demonstrate support for Oklahoma residents who
4 are members of the Oklahoma National Guard and deployed on active
5 duty. The plates shall be issued to any person in any combination
6 of numbers and letters from one to a maximum of seven, as for
7 personalized license plates. As provided in this section, a portion
8 of the fee collected shall be deposited in the Patriot License Plate
9 Revolving Fund created in Section 1104.11 of this title;

10 33. Global War on Terrorism License Plate - such plate shall be
11 designed in consultation with the Military Department of Oklahoma
12 and issued to any person wishing to demonstrate support for Oklahoma
13 residents who are members of the Armed Forces of the United States
14 or Oklahoma National Guard that have served in the Global War on
15 Terrorism. The plate shall be issued to any person in any
16 combination of numbers and letters from one to a maximum of six. As
17 provided in this section, a portion of the fee collected shall be
18 deposited in the 45th Infantry Division Museum Fund created in
19 Section 235.1 of Title 44 of the Oklahoma Statutes;

20 34. Boys and Girls Clubs of America Supporter License ~~Plates~~
21 Plate - such plates shall be designed and issued to any person
22 wishing to demonstrate support for the Boys and Girls Clubs of
23 America. The plates shall be issued to any person in any
24 combination of numbers and letters from one to a maximum of seven,

1 as for personalized license plates. The plate shall contain the
2 official Boys and Girls Clubs of America logo. The Tax Commission,
3 if necessary, may enter into a licensing agreement with the Boys and
4 Girls Clubs of America for any licensing fees which may be required
5 in order to use the Boys and Girls Clubs of America logo or design.
6 The licensing agreement shall provide for a payment to the Boys and
7 Girls Clubs of America of not more than Twenty Dollars (\$20.00) for
8 each license plate issued;

9 35. Oklahoma Quarter Horse License ~~Plates~~ Plate - such plates
10 shall be designed and issued to any person wishing to demonstrate
11 support for the American Quarter Horse in Oklahoma. The plate shall
12 be designed in consultation with the Oklahoma Quarter Horse
13 Association. As provided in this section, a portion of the fee
14 collected shall be deposited in the Oklahoma Quarter Horse Revolving
15 Fund created in Section 1104.12 of this title;

16 36. Oklahoma Association for the Deaf License Plate - such
17 plates shall be designed in consultation with the Oklahoma
18 Association for the Deaf and issued to any person wishing to
19 demonstrate support for Oklahoma residents who are deaf. The plates
20 shall be issued to any person in any combination of numbers and
21 letters from one to maximum of seven, as for personalized license
22 plates. As provided in this section, a portion of the fee collected
23 shall be deposited in the Oklahoma Association for the Deaf License
24 Plate Revolving Fund created in Section 1104.15 of this title;

1 37. Oklahoma City Zoo License Plate - such plates shall be
2 issued to any person wishing to demonstrate support for the Oklahoma
3 City Zoo. The license plates shall be designed in consultation with
4 the Oklahoma Zoological Society, Inc. As provided in this section,
5 an amount of the fee collected shall be deposited in the Oklahoma
6 Zoological Society Revolving Fund created in Section 1104.13 of this
7 title;

8 38. March of Dimes License Plate - such plates shall be issued
9 to persons wishing to demonstrate support for the March of Dimes
10 mission to improve the health of babies by preventing birth defects,
11 premature birth and infant mortality. The license plates shall be
12 designed in consultation with the Oklahoma Chapter March of Dimes.
13 As provided in this section, an amount of the fee collected shall be
14 deposited in the Oklahoma Prevent Birth Defects, Premature Birth and
15 Infant Mortality Fund established in Section 1104.14 of this title;

16 39. Support Our Troops Supporter License ~~Plates~~ Plate - such
17 plates shall be designed and issued to any person wishing to
18 demonstrate support for Support Our Troops Incorporated. The plates
19 shall be issued to any person in any combination of numbers and
20 letters from one to a maximum of six. The plate shall contain the
21 official Support Our Troops Incorporated logo which includes the
22 mark "Support Our Troops" across the bottom of the plate. The Tax

3 Support Our Troops Incorporated of Twenty-five Dollars (\$25.00) for
4 each license plate issued;

5 40. Folds of Honor Supporter License Plate - such plates shall
6 be designed and issued to any person wishing to demonstrate support
7 for Folds of Honor Incorporated, a nonprofit charitable organization
8 exempt from taxation pursuant to the provisions of the Internal
9 Revenue Code, 26 U.S.C., Section 501(c)(3), providing academic and
10 vocational training scholarships to dependents of military
11 servicemen and servicewomen who were either killed or wounded in
12 action due to military service in the war in Iraq or Afghanistan.
13 The plates shall be issued to any person in any combination of
14 numbers and letters from one to a maximum of six. The plate shall
15 be designed in consultation with Folds of Honor Incorporated and
16 shall contain the official Folds of Honor Incorporated logo which
17 includes the mark "Folds of Honor" across the bottom of the plate.
18 The Tax Commission, if necessary, may enter into a licensing

6 emotional and financial support for downed bikers. The license
7 plate shall be designed in consultation with the Central Oklahoma
8 Chapter of the Downed Bikers Association and shall contain any
9 official logo or design of the organization. The Tax Commission, if
10 necessary, may enter into a licensing agreement with the Downed
11 Bikers Association for any licensing fees which may be required in
12 order to use the organization's logo or design. The licensing
13 agreement shall provide for a payment to the Downed Bikers
14 Association of not more than Twenty Dollars (\$20.00) for each
15 license plate;

16 42. Armed Forces Veterans Motorcycle License Plate - such
17 plates shall be designed for use on a motorcycle in consultation
18 with A Brotherhood Aiming Toward Education of Oklahoma, Inc.
19 (ABATE), and issued to any honorably discharged former member of the
20 United States Armed Forces wishing to demonstrate support for the
21 45th Infantry Division Museum. Persons applying for such license
22 plate must show proof of past military service. As provided in this
23 section, a portion of the fee collected shall be deposited in the

1 45th Infantry Division Museum Fund created in Section 235.1 of Title
2 44 of the Oklahoma Statutes;

3 43. Buffalo Soldier License Plate - such plates shall be issued
4 to any person wishing to honor and celebrate the history and
5 contribution of the Buffalo Soldiers. The license plates shall be
6 designed in consultation with the Lawton-Fort Sill Chapter of the
7 Buffalo Soldiers 9th and 10th (Horse) Cavalry Association. As
8 provided in this section, an amount of the fee collected shall be
9 deposited in the Buffalo Soldier License Plate Revolving Fund
10 created in Section 1104.16 of this title;

11 44. Prevent Blindness Oklahoma License Plate - such plates
12 shall be issued to any person wishing to provide financial support
13 for vision screening of school age children in this state. The
14 license plates shall be designed in consultation with Prevent
15 Blindness Oklahoma. As provided in this section, an amount of the
16 fee collected shall be deposited in the Prevent Blindness Oklahoma
17 License Plate Revolving Fund created in Section 1104.17 of this
18 title;

19 45. Oklahoma State Capitol Restoration License Plate - such
20 plates shall be designed and issued to any person wishing to
21 demonstrate support for restoration of the Oklahoma State Capitol
22 building. The license plates shall be designed in consultation with
23 the Friends of the Capitol corporation, created pursuant to Section
24 15.4 of Title 73 of the Oklahoma Statutes and the State Capitol

1 Preservation Commission created pursuant to Section 4102 of Title 74
2 of the Oklahoma Statutes. As provided in this section, an amount of
3 the fee collected shall be deposited in the Oklahoma Friends of the
4 Capitol License Plate Revolving Fund established in Section 1104.18
5 of this title;

6 46. Eastern Red Cedar Tree License ~~Plates~~ Plate - such plates
7 shall be designed, subject to criteria to be presented to the Tax
8 Commission and issued to any person wishing to demonstrate support
9 for the removal of Eastern Red Cedar trees from lands in the state
10 and to develop marketable uses for the harvested trees. The license
11 plate shall be designed in consultation with the Eastern Red Cedar
12 Registry Board. Twenty-three Dollars (\$23.00) of the fee collected
13 shall be deposited in the Eastern Red Cedar Revolving Fund created

1 deposited in the Pancreatic Cancer Research License Plate Revolving
2 Fund created in Section 1104.19 of this title;

3 48. Alzheimer's Research License Plate - such plates shall be
4 issued to any person wishing to provide financial support for the
5 Oklahoma Chapter of the Alzheimer's Association. The license plates
6 shall be designed in consultation with the Oklahoma Chapter of the
7 Alzheimer's Association. As provided in this section, an amount of
8 the fee collected shall be deposited in the Alzheimer's Research
9 License Plate Revolving Fund created in Section 1104.20 of this
10 title;

11 49. Hospice and Palliative Care License Plate - such plates
12 shall be issued to any person wishing to provide financial support
13 for the Oklahoma Hospice and Palliative Care Association. The
14 license plates shall be designed in consultation with the Oklahoma
15 Hospice and Palliative Care Association. As provided in this
16 section, an amount of the fee collected shall be deposited in the
17 Hospice and Palliative Care License Plate Revolving Fund created in
18 Section 1104.21 of this title;

19 50. Juvenile Diabetes Research License Plate - such plates
20 shall be issued to any person wishing to provide financial support
21 for the Oklahoma Chapters of the Juvenile Diabetes Research
22 Foundation. The license plates shall be designed in consultation
23 with the Oklahoma Chapters of the Juvenile Diabetes Research
24 Foundation. As provided in this section, an amount of the fee

1 collected shall be deposited in the Juvenile Diabetes Research
2 License Plate Revolving Fund created in Section 1104.22 of this
3 title;

4 51. Deer Creek Schools Foundation License Plate - such plates
5 shall be issued to any person wishing to provide financial support
6 for the Deer Creek Schools Foundation. The license plates shall be
7 designed in consultation with the Deer Creek Schools Foundation.
8 The plates shall be issued to any person in any combination of
9 numbers and letters from one to a maximum of seven, as for
10 personalized license plates. As provided in this section, an amount
11 of the fee collected shall be deposited in the Deer Creek Schools
12 Foundation License Plate Revolving Fund created in Section 1104.23
13 of this title;

14 52. Lupus Awareness and Education License Plate - such plates
15 shall be issued to any person wishing to provide financial support
16 for the Lupus Foundation of Oklahoma. The license plates shall be
17 designed in consultation with the Lupus Foundation of Oklahoma. As
18 provided in this section, an amount of the fee collected shall be
19 deposited in the Oklahoma Lupus License Plate Revolving Fund created
20 in Section 1104.24 of this title. Subject to the provisions of
21 subsection A of this section, the Lupus Awareness and Education
22 License Plate is hereby reauthorized effective November 1, 2015;

23 53. Chiefs of Police License Plate - such plates shall be
24 issued to any person wishing to provide financial support for the

1 Oklahoma Association of Chiefs of Police for a vehicle or motorcycle
2 in any combination of numbers and letters from one to a maximum of
3 seven, as for personalized plates. The license plates shall be
4 designed in consultation with the Oklahoma Association of Chiefs of
5 Police. The license plate for a motorcycle may be of similar design
6 as space permits or a new design in order to meet the space
7 requirements of a motorcycle license plate. The Tax Commission
8 shall be authorized to enter into a licensing agreement with the
9 Oklahoma Association of Chiefs of Police for any licensing fees
10 which may be required in order to use the association's logo or
11 design. The licensing agreement shall provide for a payment to the
12 Oklahoma Association of Chiefs of Police of not more than Twenty
13 Dollars (\$20.00) for each license plate issued. Subject to the
14 provisions of subsection A of this section, the Chiefs of Police
15 License Plate is hereby reauthorized effective November 1, 2015;

16 54. Crossings Christian School License Plate - such plates
17 shall be designed and issued to any person wishing to demonstrate
18 support for Crossings Christian School located in Oklahoma City.
19 The license plates shall be designed in consultation with the
20 administration of Crossings Christian School. The Tax Commission
21 shall be authorized to enter into a licensing agreement with
22 Crossings Christian School for any licensing fees which may be
23 required in order to use the school's logo or design. The licensing
24 agreement shall provide for a payment to the Crossings Christian

1 School of not more than Twenty Dollars (\$20.00) for each license
2 plate issued;

3 55. Hilldale Education Foundation License ~~Plates~~ Plate - such
4 plates shall be designed and issued to any person wishing to
5 demonstrate support for the Hilldale Education Foundation. The
6 license plates shall be designed in consultation with the
7 administration of the Hilldale Education Foundation. The Tax
8 Commission shall be authorized to enter into a licensing agreement
9 with the Hilldale Education Foundation for any licensing fees which
10 may be required in order to use the foundation's logo or design.
11 The licensing agreement shall provide for a payment to the Hilldale
12 Education Foundation of not more than Twenty Dollars (\$20.00) for
13 each license plate issued;

14 56. Oklahoma Nurses License Plate - such plates shall be issued
15 to any person licensed pursuant to the Oklahoma Nursing Practice Act
16 and providing such documentation of current licensure as may be
17 required by the Oklahoma Tax Commission. The license plates shall
18 be designed in consultation with the Oklahoma Nurses Association.
19 As provided in this section, an amount of the fee collected shall be
20 deposited in the Oklahoma Nurses License Plate Revolving Fund
21 created in Section 1104.26 of this title;

22 57. Oklahoma Sports Hall of Fame License Plate - such plates
23 shall be issued to any person wishing to demonstrate support for the
24 Oklahoma Sports Hall of Fame. The license plates shall be designed

1 in consultation with the administration of the Oklahoma Sports Hall
2 of Fame. The Oklahoma Tax Commission shall be authorized to enter
3 into a licensing agreement with the Oklahoma Sports Hall of Fame for
4 any licensing fees which may be required in order to use the Hall of
5 Fame's logo or design. The licensing agreement shall provide for a
6 payment to the Oklahoma Sports Hall of Fame of not more than Twenty
7 Dollars (\$20.00) for each license plate issued;

8 58. Childhood Cancer Awareness License Plate - such plates
9 shall be issued to any person wishing to demonstrate support for the
10 Oklahoma Children's Cancer Association. The license plates shall be
11 designed in consultation with the administration of the Oklahoma
12 Children's Cancer Association. The Oklahoma Tax Commission shall be
13 authorized to enter into a licensing agreement with the Oklahoma
14 Children's Cancer Association for any licensing fees which may be
15 required in order to use the Oklahoma Children's Cancer
16 Association's logo or design. The licensing agreement shall provide
17 for a payment to the Oklahoma Children's Cancer Association of not
18 more than Twenty Dollars (\$20.00) for each license plate issued;

19 59. Oklahoma Educational Television Authority License Plate -
20 such plates shall be designed and issued to any person wishing to
21 demonstrate support for the Oklahoma Educational Television
22 Authority and such plates shall be designed in consultation with the
23 Authority. As provided in this section, an amount of the fee
24 collected shall be deposited in the Educational Television Authority

1 Revolving Fund created in Section 156 of Title 62 of the Oklahoma
2 Statutes; ~~and~~

3 60. Remembering Fallen Heroes License Plate - such plates shall
4 be designed and issued to any person wishing to demonstrate support
5 for Concerns of Police Survivors, Inc. Such plates shall be
6 designed in consultation with the Oklahoma chapter of Concerns of
7 Police Survivors, Inc. As provided in this section, an amount of
8 the fee collected shall be deposited in the Oklahoma Concerns of
9 Police Survivors License Plate Revolving Fund created in Section
10 1104.27 of this title;

11 61. Jenks Trojans License Plate - such plates shall be designed
12 and issued to any person wishing to demonstrate support for the
13 Jenks School District. The license plates shall be designed in
14 consultation with the administration of the Jenks School District.
15 The Tax Commission shall be authorized to enter into a licensing
16 agreement with the Jenks School District for any licensing fees
17 which may be required in order to use the school district's logo or
18 design. The licensing agreement shall provide for a payment to the
19 Jenks School District of not more than Twenty Dollars (\$20.00) for
20 each license plate issued; and

21 63. Bixby Spartans License Plate - such plates shall be
22 designed and issued to any person wishing to demonstrate support for
23 the Bixby School District. The license plates shall be designed in
24 consultation with the administration of the Bixby School District.

1 The Tax Commission shall be authorized to enter into a licensing
2 agreement with the Bixby School District for any licensing fees
3 which may be required in order to use the school district's logo or
4 design. The licensing agreement shall provide for a payment to the
5 Bixby School District of not more than Twenty Dollars (\$20.00) for
6 each license plate issued.

7 C. The fee for such plates shall be Thirty-five Dollars
8 (\$35.00) and shall be in addition to all other registration fees
9 provided by the Oklahoma Vehicle License and Registration Act. The
10 fee shall be apportioned as follows:

11 1. Twenty Dollars (\$20.00) or any other amount as provided in
12 this title of the fee shall be apportioned as provided or deposited
13 in a fund as specified within the paragraph authorizing the special
14 license plate;

15 2. Eight Dollars (\$8.00) of the fee shall be deposited in the
16 Oklahoma Tax Commission Reimbursement Fund to be used for the
17 administration of the Oklahoma Vehicle License and Registration Act;

19 3. Any remaining amounts of the fee shall be apportioned as
20 provided in Section 1104 of this title.
