15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. NEW LAW A new section of law to be codified
17	in the Oklahoma Statutes as Section 601 of Title 75, unless there is
18	created a duplication in numbering, reads as follows:

21	SECTION 2. NEW LAW A new section of law to be codified
22	in the Oklahoma Statutes as Section 602 of Title 75, unless there is

A. There is hereby created the Rules and Regulations Review Commission which shall consist of:

- 1. Three members appointed by the Governor, at least one of whom shall be the president, owner, chief executive officer or chief financial officer of an Oklahoma-based company;
- 2. Three members appointed by the President Pro Tempore of the Oklahoma State Senate, at least one of whom shall be a business efficiency expert;
- 3. Three members appointed by the Speaker of the Oklahoma House of Representatives, at least one of whom shall be a business efficiency expert; and
- 4. The Secretary of State, or his or her designee who is an employee of the Secretary of State, who shall be an ex officio and nonvoting member.
- B. No person shall be appointed to the Commission who at the time of his or her appointment is an elected official. Any person who is appointed to the Commission who subsequently becomes an elected official during his or her term on the Commission shall be required to vacate his or her position on the Commission.
- C. The Secretary of State shall provide staff and administrative support to the Commission. The Attorney General shall provide legal advice on any matter related to the powers and duties of the Commission.

- D. The Rules and Regulations Review Commission shall not be subject to the Oklahoma Open Meeting Act.
- SECTION 3. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 603 of Title 75, unless there is created a duplication in numbering, reads as follows:
- A. The Rules and Regulations Review Commission shall conduct an independent review of all rules and regulations currently filed in the Oklahoma Administrative Code. The results of the review may be used by the Legislature to implement the best policy-making practices for government services to run in the most cost-effective way.
- B. By December 31 of each year, the Commission shall issue an annual report on the status of implementation of the review recommendations. The Commission may also include its comments or recommendations based on any review in this report.
- C. Bills and resolutions introduced to implement any specific recommendation of this report shall not be subject to filing deadlines set by the Legislature.
- SECTION 4. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
