HOUSE BILL 3086

AS INTRODUCED

An Act relating to the Office of Juvenile Affairs; amending 10A O.S. 2011, Section 2-7-202, as last amended by Section 5, Chapter 15, O.S.L. 2013 (10A O.S. Supp. 2017, Section 2-7-202), which relates to Office administration and employees; designating employees hired at the Southwest Oklahoma Juvenile Center after specified date as unclassified; mandating term-limited appointment; permitting transfer of employee if services continue; excepting current employees; amending 74 O.S. 2011, Section 840-5.5, as last amended by Section 1, Chapter 177, O.S.L. 2017 (74 O.S. Supp. 2017, Section 840-5.5), which relates to the Oklahoma Personnel Act; exempting specified Office employees from classified service; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 10A O.S. 2011, Section 2-7-202, as last amended by Section 5, Chapter 15, O.S.L. 2013 (10A O.S. Supp. 2017, Section 2-7-202), is amended to read as follows:

Section 2-7-202. A. There is hereby created the Office of Juvenile Affairs which shall be responsible for programs and services for juveniles alleged or adjudicated to be delinquent or in

1 need of supervision. Within the Office of Juvenile Affairs there is  
2 hereby created:

3 1. The Division of Institutional Services which shall be  
4 responsible for the institutions operated by or contracted for by  
5 the Office of Juvenile Affairs;

6 2. The Division of Community-based Youth Services which shall  
7 be responsible for contracting with, monitoring, evaluation and  
8 support of community-based Youth Services Agencies;

9 3. The Division of Juvenile and Treatment Services which shall  
10 be responsible for intake, probation and parole services,  
11 supervision and placement of juveniles and the contracting for,  
12 monitoring and evaluation of residential and treatment programs  
13 other than institutions and community-based Youth Services Agencies;  
14 and

15 4. Such other divisions specifically established by the  
16 Executive Director of the Office of Juvenile Affairs, with the  
17 approval of the Board.

18 The Executive Director of the Office of Juvenile Affairs, with  
19 the approval of the Board, shall appoint a Director of the Division  
20 of Institutional Services, a Director of the Division of Community-  
21 based Youth Services, and a Director of the Division of Juvenile and  
22 Treatment Services to serve as the administrative head of each  
23 division, respectively. The Division Directors shall have at least  
24 six (6) years of experience in the same or similar programs or

1 facilities as they are to supervise and a baccalaureate degree or  
2 higher level of education.

3 B. Suitable office space shall be provided by the Office of  
4 Management and Enterprise Services to the Office of Juvenile  
5 Affairs, to the extent necessary for the Office to implement its  
6 jurisdictional duties provided by the Oklahoma Juvenile Code, and  
7 the Office may incur necessary expenses for office rent.

8 C. Effective July 1, 1995, the Office of Juvenile Affairs shall  
9 be a Merit System agency and all employees of the Office of Juvenile  
10 Affairs shall be classified employees who are subject to the  
11 Oklahoma Personnel Act and the Merit System of Personnel  
12 Administration, except as otherwise provided by law. Effective  
13 January 1, 2019, employees hired for service at the Southwest  
14 Oklahoma Juvenile Center in Manitou shall be considered unclassified  
15 and employed in a term-limited appointment. If state services  
16 continue at the facility after the designated term, the employee may  
17 be transferred into a non-term-limited position. Current employees  
18 and employees hired prior to January 1, 2019, shall not be subject  
19 to this provision.

20 D. Effective July 1, 1995, within its jurisdictional areas of  
21 responsibility, the Office of Juvenile Affairs, acting through the  
22 Executive Director, or persons authorized by law, rule or designated  
23 by the Executive Director to perform such acts, shall have the power  
24 and duty to:

- 1        1. Advise, consult, cooperate and enter into agreements with  
2 agencies of the state, municipalities and counties, other states and  
3 the federal government, and other persons;
- 4        2. Enter into agreements for, accept, administer and use,  
5 disburse and administer grants of money, personnel and property from  
6 the federal government or any department or agency thereof, or from  
7 any state or state agency, or from any other source, to promote and  
8 carry on in this state any program within its jurisdictional area of  
9 responsibility;
- 10       3. Require the establishment and maintenance of records and  
11 reports;
- 12       4. Establish a system of training for personnel in order to  
13 assure uniform statewide application of law and rules;
- 14       5. Enforce the provisions of the Oklahoma Juvenile Code and  
15 rules promulgated thereunder and orders issued pursuant thereto;
- 16       6. Charge and receive fees pursuant to fee schedules  
17 promulgated by the Board of Juvenile Affairs;
- 18       7. Conduct studies, research and planning of programs and  
19 functions, pursuant to the authority granted by the Oklahoma  
20 Juvenile Code;
- 21       8. Enter into interagency agreements;
- 22       9. Provide administrative and support services to the Board of  
23 Juvenile Affairs as necessary to assist the Board in the performance  
24 of their duties;

1        10. Establish and maintain such facilities and institutions as  
2 are necessary or convenient for the operation of programs for  
3 children under the jurisdiction of the Office of Juvenile Affairs;

4        11. Lease, from time to time, any real property which the Board  
5 of Juvenile Affairs shall determine advisable to more fully carry  
6 into effect the operation of the Office of Juvenile Affairs in  
7 accordance with applicable state statutes. All such leases for real  
8 property shall be subject to the provisions of Section 63 of Title  
9 74 of the Oklahoma Statutes;

10       12. Purchase or lease any equipment, supplies or materials  
11 pursuant to The Oklahoma Central Purchasing Act;

12       13. Contract for professional services;

13       14. Acquire, construct, extend, and operate any and all  
14 facilities of all kinds which in the judgment of the Executive  
15 Director and the approval of the Legislature shall be necessary or  
16 convenient to carry out the duties of the Office of Juvenile  
17 Affairs, as authorized by law; and

18       15. Exercise all incidental powers which are necessary and  
19 proper to implement and administer the purposes of the Oklahoma  
20 Juvenile Code.

21       E. The Office of Juvenile Affairs shall maintain a fair, simple  
22 and expeditious system for resolution of grievances of all persons  
23 committed to the Office of Juvenile Affairs regarding the substance  
24 or application of any written or unwritten policy, rule of the Board

1 of Juvenile Affairs or of an agent or contractor of the Office of  
2 Juvenile Affairs or any decision, behavior or action by an employee,  
3 agent or contractor or by any other person committed to the Office  
4 of Juvenile Affairs.

5 F. Effective November 1, 2012, the Office of Juvenile Affairs  
6 shall establish a system of certification in accordance with the  
7 Oklahoma Child Care Facilities Licensing Act for the shelters  
8 managed and operated by the Department of Human Services pursuant to  
9 the requirements of Section 1-9-111 of this title. The Office of  
10 Juvenile Affairs shall certify shelters pursuant to the requirements  
11 of existing rules as established by the Oklahoma Commission on  
12 Children and Youth until such time the Office of Juvenile Affairs  
13 has promulgated rules for the certification of shelters.

14 SECTION 2. AMENDATORY 74 O.S. 2011, Section 840-5.5, as  
15 last amended by Section 1, Chapter 177, O.S.L. 2017 (74 O.S. Supp.  
16 2017, Section 840-5.5), is amended to read as follows:

17 Section 840-5.5 A. The following offices, positions, and  
18 personnel shall be in the unclassified service and shall not be  
19 placed under the classified service:

20 1. Persons chosen by popular vote or appointment to fill an  
21 elective office, and their employees, except the employees of the  
22 Corporation Commission, the State Department of Education and the  
23 Department of Labor;  
24

1        2. Members of boards and commissions, and heads of agencies;  
2 also one principal assistant or deputy and one executive secretary  
3 for each state agency;

4        3. All judges, elected or appointed, and their employees;

5        4. Persons employed with one-time, limited duration, federal or  
6 other grant funding that is not continuing or indefinitely  
7 renewable. The length of the unclassified employment shall not  
8 exceed the period of time for which that specific federal funding is  
9 provided;

10       5. All officers and employees of The Oklahoma State System of  
11 Higher Education, State Board of Education and Oklahoma Department  
12 of Career and Technology Education;

13       6. Persons employed in a professional or scientific capacity to  
14 make or conduct a temporary and special inquiry, investigation, or  
15 examination on behalf of the Legislature or a committee thereof or  
16 by authority of the Governor. These appointments and authorizations  
17 shall terminate on the first day of the regular legislative session  
18 immediately following the appointment, if not terminated earlier.  
19 However, nothing in this paragraph shall prevent the reauthorization  
20 and reappointment of any such person. Any such appointment shall be  
21 funded from the budget of the appointing authority;

22       7. Election officials and employees;

23       8. Temporary employees employed to work less than one thousand  
24 (1,000) hours in any twelve-month period, and seasonal employees

1 employed by the Oklahoma Tourism and Recreation Department pursuant  
2 to Section 2241 of this title who work less than one thousand six  
3 hundred (1,600) hours in any twelve-month period;

4 9. Department of Public Safety employees occupying the  
5 following offices or positions:

- 6 a. administrative aides to the Commissioner,
- 7 b. executive secretaries to the Commissioner,
- 8 c. the Governor's representative of the Oklahoma Highway  
9 Safety Office who shall be appointed by the Governor,
- 10 d. Highway Patrol Colonel,
- 11 e. Highway Patrol Lieutenant Colonel,
- 12 f. Director of Finance,
- 13 g. noncommissioned pilots,
- 14 h. Information Systems Administrator,
- 15 i. Law Enforcement Telecommunications System Specialist,
- 16 j. Director of Driver Compliance,
- 17 k. Director of Transportation Division,
- 18 l. Director of the Oklahoma Highway Safety Office,
- 19 m. Civil Rights Administrator,
- 20 n. Budget Analyst,
- 21 o. Comptroller,
- 22 p. Chaplain,
- 23 q. Helicopter Mechanic,
- 24 r. Director of Safety Compliance,

1           s.    Human Resources Director,  
2           t.    Administrator of Department Services, and  
3           u.    a maximum of seven positions for the purpose of  
4                administering programs in the Oklahoma Highway Safety  
5                Office, within full-time employee limitations of the  
6                Department, employed with federal funding that is  
7                continuing or indefinitely renewable. The  
8                authorization for such positions shall be terminated  
9                if the federal funding for positions is discontinued;

10 provided, any person appointed to a position prescribed in  
11 subparagraph d or e of this paragraph shall have a right of return  
12 to the classified commissioned position without any loss of rights,  
13 privileges or benefits immediately upon completion of the duties in  
14 the unclassified commissioned position;

15       10. Professional trainees only during the prescribed length of  
16 their course of training or extension study;

17       11. Students who are employed on a part-time basis, which shall  
18 be seventy-five percent (75%) of a normal forty-hour work week or  
19 thirty (30) hours per week, or less, or on a full-time basis if the  
20 employment is pursuant to a cooperative education program such as  
21 that provided for under Title I IV-D of the Higher Education Act of  
22 1965 (20 U.S.C. 1087a-1087c), as amended, and who are regularly  
23 enrolled in:

- a. an institution of higher learning within The Oklahoma State System of Higher Education,
- b. an institution of higher learning qualified to become coordinated with The Oklahoma State System of Higher Education. For purposes of this section, a student shall be considered a regularly enrolled student if the student is enrolled in a minimum of five (5) hours of accredited graduate courses or a minimum of ten (10) hours of accredited undergraduate courses; provided, however, the student shall only be required to be enrolled in a minimum of six (6) hours of accredited undergraduate courses during the summer, or
- c. high school students regularly enrolled in a high school in Oklahoma and regularly attending classes during such time of enrollment;

12. The spouses of personnel who are employed on a part-time basis to assist or work as a relief for their spouses in the Oklahoma Tourism and Recreation Department;

13. Service substitute attendants who are needed to replace museum and site attendants who are unavoidably absent. Service substitutes may work as part-time or full-time relief for absentees for a period of not more than four (4) weeks per year in the Oklahoma Historical Society sites and museums; such substitutes will

1 not count towards the agency's full-time-equivalent (FTE) employee  
2 limit;

3 14. Employees of the Oklahoma House of Representatives, the  
4 State Senate, or the Legislative Service Bureau;

5 15. Corporation Commission personnel occupying the following  
6 offices and positions:

- 7 a. Administrative aides, and executive secretaries to the  
8 Commissioners,
- 9 b. Directors of all the divisions, personnel managers and  
10 comptrollers,
- 11 c. General Counsel,
- 12 d. Public Utility Division Chief Engineer,
- 13 e. Public Utility Division Chief Accountant,
- 14 f. Public Utility Division Chief Economist,
- 15 g. Public Utility Division Deputy Director,
- 16 h. Secretary of the Commission,
- 17 i. Deputy Conservation Director,
- 18 j. Manager of Pollution Abatement,
- 19 k. Manager of Field Operations,
- 20 l. Manager of Technical Services,
- 21 m. Public Utility Division Chief of Telecommunications,

16. At the option of the employing agency, the Supervisor, Director, or Educational Coordinator in any other state agency having a primary responsibility to coordinate educational programs operated for children in state institutions;

17. Department of Mental Health and Substance Abuse Services personnel occupying the following offices and positions at each facility:

- a. Director of Facility,

B. If an agency has the authority to employ personnel in the following offices and positions, the appointing authority shall have the discretion to appoint personnel to the unclassified service:

1. Licensed medical doctors, osteopathic physicians, dentists, psychologists, and nurses;
2. Certified public accountants;
3. Licensed attorneys;
4. Licensed veterinarians; and
5. Licensed pharmacists.

C. Effective July 1, 1996, authorization for unclassified offices, positions, or personnel contained in a bill or joint resolution shall terminate June 30 of the ensuing fiscal year after the authorization unless the authorization is codified in the Oklahoma Statutes or the termination is otherwise provided in the legislation.

1       D. The appointing authority of agencies participating in the  
2 statewide information systems project may establish unclassified  
3 positions and appoint unclassified employees to the project as  
4 needed. Additional unclassified positions may be established, if  
5 required, to appoint an unclassified employee to perform the duties  
6 of a permanent classified employee who is temporarily absent from a  
7 classified position as a result of assignment to this project. All  
8 unclassified appointments under this authority shall expire no later
