6 AS INTRODUCED

7 An Act relating to public health; amending 63 O.S.
8 2011, Section 1-103, which relates to the composition
9 of the State Board of Health; requiring one member to
possess experience in business or accounting; and
providing an effective date.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY 63 O.S. 2011, Section 1-103, is
14 amended to read as follows:

15 Section 1-103. A. 1. There is hereby created the State Board
16 of Health, which shall consist of nine (9) members appointed by the
17 Governor and confirmed by the Senate for regular terms of nine (9)
18 years, except as hereinafter otherwise indicated.

19 2. Not less than four members shall hold a current license to
20 practice medicine in this state pursuant to the Oklahoma Allopathic
21 Medical and Surgical Licensure and Supervision Act and the Oklahoma
22 Osteopathic Medicine Act. At least one physician member shall be a
23 person licensed to practice medicine in this state by the State
24 Board of Osteopathic Examiners. Physician members licensed by the

1 State Board of Medical Licensure and Supervision shall be members of
2 the Oklahoma State Medical Association. One physician member shall
3 be a diplomate of the American Board of Psychiatry and Neurology or
4 be similarly qualified.

5 3. Not less than one member shall possess at least five (5)
6 years of professional work experience in business or accounting.

7 B. 1. The term of office of one member shall expire on June
8 30, 1964, and each nine (9) years thereafter, and such member shall
9 be a resident of one of the following counties and shall have been a
10 resident of one or more of such counties for not less than five (5)
11 years immediately preceding such member's appointment: Creek,
12 Lincoln, Okfuskee, Seminole, Pottawatomie, Pontotoc, Hughes,
13 Johnston, and Coal.

14 2. The term of office of one member shall expire on June 30,
15 1965, and each nine (9) years thereafter, and such member shall be a
16 resident of one of the following counties and shall have been a
17 resident of one or more of such counties for not less than five (5)
18 years immediately preceding such member's appointment: Blaine,
19 Kingfisher, Canadian, Caddo, Grady, Comanche, Stephens, Jefferson,
20 and Cotton.

21 3. The term of office of one member shall expire on June 30,
22 1966, and each nine (9) years thereafter, and such member shall be a
23 resident of one of the following counties and shall have been a
24 resident of one or more of such counties for not less than five (5)

1 years immediately preceding such member's appointment: Le Flore,
2 Latimer, Pittsburg, Atoka, Pushmataha, McCurtain, Choctaw, Bryan,
3 Marshall, Carter, and Love.

4 4. The term of office of one member shall expire on June 30,
5 1967, and each nine (9) years thereafter, and such member shall be a
6 resident of one of the following counties and shall have been a
7 resident of one or more of such counties for not less than five (5)
8 years immediately preceding such member's appointment: Cimarron,
9 Texas, Beaver, Harper, Woodward, Woods, Major, Alfalfa, Grant,
10 Garfield, Kay, and Noble.

11 5. The term of office of one member shall expire on June 30,
12 1968, and each nine (9) years thereafter, and such member shall be a
13 resident of one of the following counties and shall have been a
14 resident of one or more of such counties for not less than five (5)
15 years immediately preceding such member's appointment: Adair,
16 Sequoyah, Cherokee, Wagoner, Muskogee, Haskell, McIntosh, and
17 Okmulgee.

18 6. The term of office of one member shall expire on June 30,
19 1969, and each nine (9) years thereafter, and such member shall be a
20 resident of one of the following counties and shall have been a
21 resident of one or more of such counties for not less than five (5)
22 years immediately preceding such member's appointment: Ottawa,
23 Delaware, Craig, Mayes, Nowata, Rogers, Washington, Tulsa, Pawnee,
24 and Osage.

1 7. The term of office of one member shall expire on June 30,
2 1970, and each nine (9) years thereafter, and such member shall be a
3 resident of one of the following counties and shall have been a
4 resident of one or more of such counties for not less than five (5)
5 years immediately preceding such member's appointment: Logan,
6 Oklahoma, Cleveland, McClain, Garvin, Murray, and Payne.

7 8. The term of office of one member shall expire on June 30,
8 1971, and each nine (9) years thereafter, and such member shall be a
9 resident of one of the following counties and shall have been a
10 resident of one or more of such counties for not less than five (5)
11 years immediately preceding such member's appointment: Ellis, Dewey,
12 Roger Mills, Custer, Beckham, Washita, Kiowa, Greer, Jackson,
13 Harmon, and Tillman.

14 9. The term of office of one member shall expire on June 30,
15 1972, and each nine (9) years thereafter, and such member shall be
16 appointed from the State of Oklahoma at large, and shall have been a
17 resident of the state for not less than five (5) years immediately
18 preceding such member's appointment.

19 SECTION 2. This act shall become effective November 1, 2018.
