HOUSE BILL 3140

AS INTRODUCED

An Act relating to state government; amending 74 O.S. 2011, Section 250.4, as last amended by Section 1, Chapter 338, O.S.L. 2015 (74 O.S. Supp. 2017, Section 250.4), which relates to salaries of state officers modifying salaries; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 74 O.S. 2011, Section 250.4, as last amended by Section 1, Chapter 338, O.S.L. 2015 (74 O.S. Supp. 2017, Section 250.4), is amended to read as follows:

Section 250.4 Pursuant to provisions of the Constitution of the State of Oklahoma from and after the beginning date of a term of office which commences in, or after, January ~~2016~~ 2019, the following officers of the State of Oklahoma shall be annually compensated for their services, payable monthly, as follows:

1. The Governor shall receive a salary ~~of One Hundred Forty seven Thousand Dollars (\$147,000.00)~~ equal to three times the amount of the base pay for members of the Legislature;

1 2. The Lieutenant Governor shall receive a salary ~~of One~~
2 ~~Hundred Fourteen Thousand Seven Hundred Thirteen Dollars~~
3 ~~(\$114,713.00)~~ equal to eighty percent (80%) of the salary of the
4 Governor;

5 3. The Attorney General shall receive a salary ~~of One Hundred~~
6 ~~Thirty-two Thousand Eight Hundred Twenty-five Dollars (\$132,825.00)~~
7 equal to the salary of the Governor;

8 4. The State Superintendent of Public Instruction shall receive
9 a salary ~~of One Hundred Twenty-four Thousand Three Hundred Seventy-~~
10 ~~three Dollars (\$124,373.00)~~ equal to the salary of the Governor;

11 5. Each member of the Corporation Commission shall receive a
12 salary ~~of One Hundred Fourteen Thousand Seven Hundred Thirteen~~
13 ~~Dollars (\$114,713.00)~~ equal to the salary of the Governor;

14 6. The State Treasurer shall receive a salary ~~of One Hundred~~
15 ~~Fourteen Thousand Seven Hundred Thirteen Dollars (\$114,713.00)~~ equal
16 to the salary of the Governor;

17 7. The State Auditor and Inspector shall receive a salary ~~of~~
18 ~~One Hundred Fourteen Thousand Seven Hundred Thirteen Dollars~~
19 ~~(\$114,713.00)~~ equal to the salary of the Governor;

20 8. The State Insurance Commissioner shall receive a salary ~~of~~
21 ~~One Hundred Fourteen Thousand Seven Hundred Thirteen Dollars~~
22 ~~(\$114,713.00)~~ equal to the salary of the Governor; and

1 9. The Commissioner of Labor shall receive a salary ~~of One~~
2 ~~Hundred Five Thousand Fifty-three Dollars (\$105,053.00)~~ equal to the
3 salary of the Governor.

4 SECTION 2. This act shall become effective November 1, 2018.
