7 An Act relating to budgets; amending 11 O.S. 2011,
8 Section 17-208, which relates to public hearing on
municipal proposed budget; requiring proposed budget
9 be published on the municipality's website;
increasing time requirement for certain publications;
10 amending 19 O.S. 2011, Section 1412, which relates to
public hearing on county proposed budget; requiring
proposed budget be published on the county's website;
11 increasing time requirement for certain publications;
amending 70 O.S. 2011, Section 5-128.1, which relates
12 to school district budget and request for
appropriated funds; requiring school district to
13 publish budget and request for appropriated funds
prior to certain filing; and providing an effective
14 date.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. AMENDATORY 11 O.S. 2011, Section 17-208, is
19 amended to read as follows:

20 Section 17-208. The municipal governing body shall hold a
21 public hearing on the proposed budget no later than fifteen (15)
22 days prior to the beginning of the budget year. Notice of the date,
23 time and place of the hearing, together with the proposed budget
24 summary, shall be published on the municipality's website and in a

1 newspaper of general circulation in the municipality not less than
2 ~~five (5)~~ seven (7) days before the date of the hearing. The
3 municipal clerk shall make available a sufficient number of copies
4 of the proposed budget as the governing body shall determine and
5 have them available for review or for distribution or sale at the
6 office of the municipal clerk. ~~Whenever the total operating budget,~~
7 ~~not including debt service, does not exceed Twelve Thousand Dollars~~
8 ~~(\$12,000.00) per year, the proposed budget summary and notice may be~~
9 ~~posted at the governing body's principal headquarters in lieu of~~
10 ~~publication in a newspaper.~~ At the public hearing on the budget any
11 person may present to the governing body comments, recommendations
12 or information on any part of the proposed budget.

13 SECTION 2. AMENDATORY 19 O.S. 2011, Section 1412, is
14 amended to read as follows:

15 Section 1412. The county budget board shall hold a public
16 hearing on the proposed budget no later than fifteen (15) days prior
17 to the beginning of the budget year. Notice of the date, time and
18 place of the hearing, together with the proposed budget summaries,
19 shall be published on the county's website and in a newspaper of
20 general circulation in the county not less than ~~five (5)~~ seven (7)
21 days before the date of the hearing. Affidavit and proof of
22 publication shall be attached to the budget when filed with the
23 county excise board and State Auditor and Inspector. The county
24 clerk shall make available a sufficient number of copies of the

1 proposed budgets as the county budget board shall determine and have
2 them available for review or for distribution or sale at the office
3 of the county clerk. At the public hearing on the budgets, any
4 person may present to the county budget board comments,
5 recommendations or information on any part of the proposed budget.

6 SECTION 3. AMENDATORY 70 O.S. 2011, Section 5-128.1, is
7 amended to read as follows:

8 Section 5-128.1 A. No later than October 1 of each year the
9 board of education of each school district shall file with the State
10 Board of Education an itemized expenditure budget and request for
11 state appropriated funds for the ensuing fiscal year, and an
12 estimate of the revenues from all sources to be received by the
13 district during the ensuing fiscal year.

14 B. The school district shall publish the itemized expenditure
15 budget and request for state appropriated funds on the school
16 district's website and in a newspaper of general circulation in the
17 school district not less than seven (7) days before the budget and
18 request are filed with the State Board of Education.

19 SECTION 4. This act shall become effective November 1, 2018.
