of the entity convoking the extraordinary session, including but not

limited to the appropriated resources of the government entity in

effect for the fiscal year during which the extraordinary session is convened.

- B. The requirements of subsection A of this section shall not be applicable with respect to costs related to full-time employees of either the Oklahoma House of Representatives or the Oklahoma State Senate or to any other cost which is regularly incurred during periods of time when the Legislature is not convened in extraordinary session.
- C. The Chief Clerk of the Oklahoma House of Representatives and the Secretary of the Oklahoma State Senate shall maintain an accurate accounting of the expenses of an extraordinary session convened in the manner described by subsection A of this section and shall submit statements for payment of such costs, respectively by each such chamber, to the Director of the Office of Management and Enterprise Services for payment from the fiscal resources of the applicable entity. Such statements shall be paid not later than thirty (30) days from the date as of which the statement is delivered or transmitted for payment.
  - SECTION 2. This act shall become effective July 1, 2018.
- 20 SECTION 3. It being immediately necessary for the preservation 21 of the public peace, health or safety, an emergency is hereby
