2 Oklahoma Health Care Authority, the J.D. McCarty
3 Center for Children with Developmental Disabilities,
4 the Department of Mental Health and Substance Abuse
5 Services, the Oklahoma State University Medical
6 Authority, the University Hospitals Authority, the
7 Oklahoma Department of Veterans Affairs, the Oklahoma
8 Commission on Children and Youth, the Office of
9 Disability Concerns, the Department of Human
10 Services, the Office of Juvenile Affairs, the State
11 Department of Rehabilitation Services, the Oklahoma
12 Department of Agriculture, Food, and Forestry, the
13 Oklahoma Department of Commerce, the Rural Economic
14 Action Plan Fund, the Oklahoma Conservation
15 Commission, the Corporation Commission, the
16 Department of Environmental Quality, the Oklahoma
17 Historical Society, the J.M. Davis Memorial
18 Commission, the Department of Labor, the Department
19 of Mines, the Oklahoma Tourism and Recreation
20 Department, the Oklahoma Water Resources Board, the
21 Alcoholic Beverage Laws Enforcement Commission, the
22 Department of Corrections, the Oklahoma State Bureau
23 of Investigation, the Council on Law Enforcement
24 Education and Training, the Board of Medicolegal
Investigations, the Oklahoma State Bureau of
Narcotics and Dangerous Drugs Control, the Department
of Public Safety, the Court of Criminal Appeals,
district attorneys and the District Attorneys
Council, the Supreme Court, the Oklahoma Indigent
Defense System and the Pardon and Parole Board;
stating amounts of the appropriations; stating
purposes and restrictions; reappropriating and
redesignating certain funds; reappropriating certain
funds; authorizing transfers; and repealing Sections
1 through 169, Chapter 371, O.S.L. 2017, which relate
to general appropriations for the expenses of various
agencies of the executive, legislative and judicial
departments of the state.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

1 SECTION 1. There is hereby appropriated to the Oklahoma
2 Education Lottery Trust Fund from any monies not otherwise
3 appropriated from the Special Cash Fund of the State Treasury, the
4 sum of Ten Million One Hundred Forty-four Thousand One Hundred
5 Seventy-one Dollars (\$10,144,171.00) or so much thereof as may be
6 necessary pursuant to the provisions of subsection E of Section 713
7 of Title 3A of the Oklahoma Statutes.

8 SECTION 2. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 General Revenue Fund of the State Treasury for the fiscal year
11 ending June 30, 2018, the sum of One Billion Thirty-six Million Four
12 Hundred Twenty-nine Thousand Four Hundred Thirty-seven Dollars
13 (\$1,036,429,437.00) or so much thereof as may be necessary for the
14 financial support of public schools.

15 SECTION 3. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Education Reform Revolving Fund created in Section 34.89 of Title 62
18 of the Oklahoma Statutes, the sum of Six Hundred Ninety-five Million
19 Four Hundred Seven Thousand One Hundred Thirty-eight Dollars
20 (\$695,407,138.00) or so much thereof as may be necessary for the
21 financial support of public schools.

22 SECTION 4. The State Board of Education is hereby authorized to
23 expend during the fiscal year ending June 30, 2018, from the Common
24 Education Technology Revolving Fund of the State Treasury, the sum

1 of Forty-seven Million Three Hundred Seventy-two Thousand Two
2 Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as
3 may be necessary for the financial support of public schools.

4 SECTION 5. There is hereby appropriated to the State Board of
5 Education from any monies not otherwise appropriated from the
6 Mineral Leasing Fund of the State Treasury for the fiscal year
7 ending June 30, 2018, the sum of Four Million Two Hundred Seventy-
8 five Thousand Dollars (\$4,275,000.00) or so much thereof as may be
9 necessary for the financial support of public schools.

10 SECTION 6. There is hereby appropriated to the State Board of
11 Education from any monies not otherwise appropriated from the
12 Mineral Leasing Fund of the State Treasury for the fiscal year
13 ending June 30, 2016, the sum of Two Million Six Hundred Twenty-four
14 Thousand Thirty-eight Dollars (\$2,624,038.00) or so much thereof as
15 may be necessary for the financial support of public schools.

16 SECTION 7. There is hereby appropriated to the State Board of
17 Education from any monies not otherwise appropriated from the
18 Oklahoma Education Lottery Trust Fund of the State Treasury for the
19 fiscal year ending June 30, 2018, the sum of Twenty-five Million
20 Nine Hundred Thirty-nine Thousand Nine Hundred Ten Dollars
21 (\$25,939,910.00) or so much thereof as may be necessary for the
22 financial support of public schools.

23 SECTION 8. There is hereby appropriated to the State Board of
24 Education from any monies not otherwise appropriated from the

1 Oklahoma Education Lottery Trust Fund of the State Treasury for the
2 fiscal year ending June 30, 2016, the sum of Five Million Four
3 Hundred Twenty-nine Thousand Eight Hundred Forty-four Dollars
4 (\$5,429,844.00) or so much thereof as may be necessary for the
5 financial support of public schools.

6 SECTION 9. Notwithstanding any other provision of law, the
7 State Board of Education is hereby authorized to expend during the
8 fiscal year ending June 30, 2018, from the School Consolidation
9 Assistance Fund (260 Fund), the sum of Two Million Five Hundred
10 Thousand Dollars (\$2,500,000.00) or so much thereof as may be
11 necessary for the financial support of public schools.

12 SECTION 10. There is hereby appropriated to the State Board of
13 Education from any monies not otherwise appropriated from the
14 General Revenue Fund of the State Treasury for the fiscal year
15 ending June 30, 2018, the sum of Ninety-two Million Seventy-four
16 Thousand Thirty-three Dollars (\$92,074,033.00) or so much thereof as
17 may be necessary for the support of public schools activities.

18 SECTION 11. There is hereby appropriated to the State Board of
19 Education from any monies not otherwise appropriated from the
20 General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2018, the sum of Two Hundred Ninety-nine Million
22 Three Hundred Twenty Thousand Three Hundred Forty Dollars
23 (\$299,320,340.00) or so much thereof as may be necessary for the
24 Certified Employee Health Benefit Allowance.

1 SECTION 12. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2018, the sum of One Hundred Sixty-three Million
5 Three Hundred Seventy-five Thousand Six Hundred Twenty-seven Dollars
6 (\$163,375,627.00) so much thereof as may be necessary for the
7 Support Personnel Health Benefit Allowance.

8 SECTION 13. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 General Revenue Fund of the State Treasury for the fiscal year
11 ending June 30, 2018, the sum of Fifteen Million Six Hundred Eighty-
12 one Thousand One Hundred Five Dollars (\$15,681,105.00) or so much
13 thereof as may be necessary for administrative and support functions
14 of the State Department of Education.

15 SECTION 14. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the
18 fiscal year ending June 30, 2018, the sum of Two Million Eight
19 Hundred Eighty-two Thousand Two Hundred Thirteen Dollars
20 (\$2,882,213.00) or so much thereof as may be necessary for transfer
21 to the School Consolidation Assistance Fund.

22 SECTION 15. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 Oklahoma Education Lottery Trust Fund of the State Treasury for the

1 fiscal year ending June 30, 2016, the sum of Six Hundred Three
2 Thousand Three Hundred Sixteen Dollars (\$603,316.00) or so much
3 thereof as may be necessary for transfer to the School Consolidation
4 Assistance Fund.

5 SECTION 16. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 Oklahoma Education Lottery Trust Fund of the State Treasury for the
8 fiscal year ending June 30, 2018, the sum of Two Million Eight
9 Hundred Eighty-two Thousand Two Hundred Thirteen Dollars
10 (\$2,882,213.00) or so much thereof as may be necessary for transfer
11 to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

12 SECTION 17. There is hereby appropriated to the State Board of
13 Education from any monies not otherwise appropriated from the
14 Oklahoma Education Lottery Trust Fund of the State Treasury for the
15 fiscal year ending June 30, 2016, the sum of Six Hundred Three
16 Thousand Three Hundred Sixteen Dollars (\$603,316.00) or so much
17 thereof as may be necessary for transfer to the Teachers' Retirement
18 System Dedicated Revenue Revolving Fund.

19 SECTION 18. There is hereby appropriated to the Oklahoma Arts
20 Council from any monies not otherwise appropriated from the General
21 Revenue Fund of the State Treasury for the fiscal year ending June
22 30, 2018, the sum of Two Million Seven Hundred Twenty-seven Thousand
23 Forty-two Dollars (\$2,727,042.00) or so much thereof as may be
24

1 necessary to perform the duties imposed upon the Oklahoma Arts
2 Council by law.

3 SECTION 19. There is hereby appropriated to the State Board of
4 Career and Technology Education from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2018, the sum of One Hundred Five
7 Million Four Hundred Thirty-eight Thousand Six Hundred Seventy-seven
8 Dollars (\$105,438,677.00) or so much thereof as may be necessary to
9 perform the duties imposed upon the State Board of Career and
10 Technology Education by law.

11 SECTION 20. There is hereby appropriated to the State Board of
12 Career and Technology Education from any monies not otherwise
13 appropriated from the Oklahoma Education Lottery Trust Fund of the
14 State Treasury for the fiscal year ending June 30, 2018, the sum of
15 Three Million One Hundred Seventy Thousand Four Hundred Thirty-three
16 Dollars (\$3,170,433.00) pursuant to paragraph 2 of subsection F of
17 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
18 the State Board of Career and Technology Education for the education
19 and general operating budgets of the institutions and for other
20 programs, construction, renovations or repairs administered by the
21 State Board of Career and Technology Education.

22 SECTION 21. There is hereby appropriated to the State Board of
23 Career and Technology Education from any monies not otherwise
24 appropriated from the Oklahoma Education Lottery Trust Fund of the

1 State Treasury for the fiscal year ending June 30, 2016, the sum of
2 Six Hundred Sixty-three Thousand Six Hundred Forty-eight Dollars
3 (\$663,648.00) pursuant to paragraph 2 of subsection F of Section 713
4 of Title 3A of the Oklahoma Statutes for allocation by the State
5 Board of Career and Technology Education for the education and
6 general operating budgets of the institutions and for other
7 programs, construction, renovations or repairs administered by the
8 State Board of Career and Technology Education.

9 SECTION 22. Notwithstanding any other provision of law, the
10 State Board of Career and Technology Education is hereby authorized
11 to expend during the fiscal year ending June 30, 2018, from the
12 State Board of Career and Technology Education Revolving Fund (200
13 Fund), the sum of Five Hundred Thousand Dollars (\$500,000.00) or so
14 much thereof as may be necessary to perform the duties imposed upon
15 the State Board of Career and Technology Education by law.

16 SECTION 23. There is hereby appropriated to the Office of
17 Educational Quality and Accountability from any monies not otherwise
18 appropriated from the General Revenue Fund of the State Treasury for
19 the fiscal year ending June 30, 2018, the sum of One Million Ninety-
20 two Thousand Five Hundred Ninety-nine Dollars (\$1,092,599.00) or so
21 much thereof as may be necessary to perform the duties imposed upon
22 the Office of Educational Quality and Accountability by law.

23 SECTION 24. There is hereby appropriated to the Office of
24 Educational Quality and Accountability from any monies not otherwise

1 appropriated from the Special Cash Fund of the State Treasury the
2 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much
3 thereof as may be necessary to perform the duties imposed upon the
4 Office of Educational Quality and Accountability by law.

5 SECTION 25. There is hereby appropriated to the Oklahoma
6 Educational Television Authority from any monies not otherwise
7 appropriated from the General Revenue Fund of the State Treasury for
8 the fiscal year ending June 30, 2018, the sum of Two Million Six
9 Hundred Thirty-four Thousand One Hundred Eleven Dollars
10 (\$2,634,111.00) or so much thereof as may be necessary to perform
11 the duties imposed upon the Oklahoma Educational Television
12 Authority by law.

13 SECTION 26. There is hereby appropriated to the Oklahoma State
14 Regents for Higher Education from any monies not otherwise
15 appropriated from the General Revenue Fund of the State Treasury for
16 the fiscal year ending June 30, 2018, the sum of Six Hundred Twenty-
17 nine Million Four Hundred Sixty-three Thousand Five Hundred Six
18 Dollars (\$629,463,506.00) or so much thereof as may be necessary for
19 allocation by the Oklahoma State Regents for Higher Education
20 pursuant to the provisions of Article XIII-A of the Oklahoma
21 Constitution for the education and general operating budgets of the
22 institutions and for other programs, construction, renovations or
23 repairs administered by the Oklahoma State Regents for Higher
24 Education. Of those funds appropriated, the sum of Three Million

1 Thirteen Thousand One Hundred Thirty-nine Dollars (\$3,013,139.00)
2 shall be transferred to the Oklahoma Tuition Equalization Grant
3 Trust Fund to implement the provisions of the Oklahoma Tuition
4 Equalization Grant Act.

5 SECTION 27. The Oklahoma State Regents for Higher Education are
6 hereby authorized to expend during the fiscal year ending June 30,
7 2018, the sum of Forty-seven Million Three Hundred Seventy-two
8 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
9 Higher Education Capital Revolving Fund of the State Treasury for
10 allocation by the Oklahoma State Regents for Higher Education
11 pursuant to the provisions of Article XIII-A of the Oklahoma
12 Constitution for the education and general operating budgets of the
13 institutions and for other programs, construction, renovations or
14 repairs administered by the Oklahoma State Regents for Higher
15 Education.

16 SECTION 28. The Oklahoma State Regents for Higher Education are
17 hereby authorized to expend during the fiscal year ending June 30,
18 2018, the sum of Forty-seven Million Three Hundred Seventy-two
19 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
20 Oklahoma Student Aid Revolving Fund of the State Treasury for
21 allocation by the Oklahoma State Regents for Higher Education
22 pursuant to the provisions of Article XIII-A of the Oklahoma
23 Constitution for the education and general operating budgets of the
24 institutions and for other programs, construction, renovations or

1 repairs administered by the Oklahoma State Regents for Higher
2 Education.

3 SECTION 29. There is hereby appropriated to the Oklahoma State
4 Regents for Higher Education from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2018, the sum Nine Hundred Forty-
7 five Thousand Eighty-seven Dollars (\$945,087.00) or so much thereof
8 as may be necessary for expenditures for concurrent enrollment
9 pursuant to Section 628.13 of Title 70 of the Oklahoma Statutes.

10 SECTION 30. There is hereby appropriated to the Oklahoma State
11 Regents for Higher Education from any monies not otherwise
12 appropriated from the Oklahoma Education Lottery Trust Fund of the
13 State Treasury for the fiscal year ending June 30, 2018, the sum of
14 Twenty-two Million Seven Hundred Sixty-nine Thousand Four Hundred
15 Seventy-seven Dollars (\$22,769,477.00) pursuant to paragraph 2 of
16 subsection F of Section 713 of Title 3A of the Oklahoma Statutes for
17 allocation by the Oklahoma State Regents for Higher Education
18 pursuant to the provisions of Article XIII-A of the Oklahoma
19 Constitution for construction, renovations or repairs administered
20 by the Oklahoma State Regents for Higher Education or for any other
21 purpose authorized by paragraph 2 of subsection F of Section 713 of
22 Title 3A of the Oklahoma Statutes.

23 SECTION 31. There is hereby appropriated to the Oklahoma State
24 Regents for Higher Education from any monies not otherwise

1 appropriated from the Oklahoma Education Lottery Trust Fund of the
2 State Treasury for the fiscal year ending June 30, 2016, the sum of
3 Four Million Seven Hundred Sixty-six Thousand One Hundred Ninety-
4 seven Dollars (\$4,766,197.00) pursuant to paragraph 2 of subsection
5 F of Section 713 of Title 3A of the Oklahoma Statutes for allocation
6 by the Oklahoma State Regents for Higher Education pursuant to the
7 provisions of Article XIII-A of the Oklahoma Constitution for
8 construction, renovations or repairs administered by the Oklahoma
9 State Regents for Higher Education or for any other purpose
10 authorized by paragraph 2 of subsection F of Section 713 of Title 3A
11 of the Oklahoma Statutes.

12 SECTION 32. There is hereby appropriated to the Oklahoma State
13 Regents for Higher Education from any monies not otherwise
14 appropriated from the General Revenue Fund of the State Treasury for
15 the fiscal year ending June 30, 2018, the sum of Three Million Five
16 Hundred Sixty-six Thousand Four Hundred Ninety-one Dollars
17 (\$3,566,491.00) or so much thereof as may be necessary for the
18 general operating budget of the Administrative Offices of the
19 Oklahoma State Regents for Higher Education.

20 SECTION 33. There is hereby appropriated to the Commissioners
21 of the Land Office from any monies not otherwise appropriated from
22 the Commissioners of the Land Office Fund of the State Treasury for
23 the fiscal year ending June 30, 2018, the sum of Eight Million Five
24 Hundred Thirty-eight Thousand Six Hundred Dollars (\$8,538,600.00) or

1 so much thereof as may be necessary to perform the duties imposed
2 upon the Commissioners of the Land Office by law.

3 SECTION 34. There is hereby appropriated to the Oklahoma
4 Department of Libraries from any monies not otherwise appropriated
5 from the General Revenue Fund of the State Treasury for the fiscal
6 year ending June 30, 2018, the sum of Four Million Two Hundred
7 Seventy-nine Thousand Eight Hundred Forty-three Dollars
8 (\$4,279,843.00) or so much thereof as may be necessary to perform
9 the duties imposed upon the Oklahoma Department of Libraries by law.

10 SECTION 35. There is hereby appropriated to the Physician
11 Manpower Training Commission from any monies not otherwise
12 appropriated from the General Revenue Fund of the State Treasury for
13 the fiscal year ending June 30, 2018, the sum of Two Million Eight
14 Hundred Thirty-four Thousand Thirty-four Dollars (\$2,834,034.00) or
15 so much thereof as may be necessary to perform the duties imposed
16 upon the Physician Manpower Training Commission by law.

17 SECTION 36. There is hereby appropriated to the Physician
18 Manpower Training Commission from any monies not otherwise
19 appropriated from the Special Cash Fund of the State Treasury the
20 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much
21 thereof as may be necessary to perform the duties imposed upon the
22 Physician Manpower Training Commission by law.

23 SECTION 37. There is hereby appropriated to the Board of
24 Trustees of the Oklahoma School of Science and Mathematics from any

1 monies not otherwise appropriated from the General Revenue Fund of
2 the State Treasury for the fiscal year ending June 30, 2018, the sum
3 of Six Million One Hundred Twenty-one Thousand Seven Hundred Nine
4 Dollars (\$6,121,709.00) or so much thereof as may be necessary to
5 perform the duties imposed upon the Board of Trustees of the
6 Oklahoma School of Science and Mathematics by law.

7 SECTION 38. There is hereby appropriated to the Oklahoma Center
8 for the Advancement of Science and Technology from any monies not
9 otherwise appropriated from the General Revenue Fund of the State
10 Treasury for the fiscal year ending June 30, 2018, the sum of
11 Thirteen Million Ninety-five Thousand Six Hundred Eighty-one Dollars
12 (\$13,095,681.00) or so much thereof as may be necessary to perform
13 the duties imposed upon the Oklahoma Center for the Advancement of
14 Science and Technology by law. Of those funds appropriated, the sum
15 of Five Million One Hundred Twenty Thousand Two Hundred Eighty
16 Dollars (\$5,120,280.00) shall be deposited in the Research Support
17 Revolving Fund, created pursuant to Section 5060.11 of Title 74 of
18 the Oklahoma Statutes. Of those funds appropriated, the sum of Two
19 Million Eight Hundred Sixteen Thousand One Hundred Fifty-four
20 Dollars (\$2,816,154.00) shall be deposited in the Seed-capital
21 Revolving Fund, created pursuant to Section 5060.21 of Title 74 of
22 the Oklahoma Statutes.

23 GENERAL GOVERNMENT AND TRANSPORTATION
24

1 SECTION 39. There is hereby appropriated to the Office of the
2 Attorney General from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2018, the sum of Eight Million Nine Hundred Forty-

23 Ninety-three Dollars (\$6,460,293.00) or so much thereof as may be

1 necessary to perform the duties imposed upon the Supreme Court or
2 Court of Civil Appeals by law.

3 SECTION 142. The Supreme Court is hereby authorized to expend
4 during the fiscal year ending June 30, 2018, from the State Judicial
5 Revolving Fund of the State Treasury, the sum of Seven Million
6 Dollars (\$7,000,000.00) or so much thereof as may be necessary for
7 the financial support of the Supreme Court or Court of Civil
8 Appeals.

9 SECTION 143. Notwithstanding any other provision of law, the
10 Supreme Court is hereby authorized to expend during the fiscal year
11 ending June 30, 2018, from the Supreme Court Administration Fund

10 Dollars (\$5,000,000.00) or so much thereof as may be necessary to
11 perform the duties imposed upon the Department of Public Safety by
12 law.

13 SECTION 169. There is hereby appropriated to the State
14 Department of Health from any monies not otherwise appropriated from
15 the General Revenue Fund of the State Treasury for the fiscal year
16 ending June 30, 2017, the sum of Thirty Million Dollars
17 (\$30,000,000.00) or so much thereof as may be necessary to perform
18 the duties imposed upon the State Department of Health by law.

19 SECTION 170. Sections 1 through 169, Chapter 371, O.S.L. 2017,
20 are hereby repealed.
