15 Commission, the Corporation Commission, the
16 Department of Environmental Quality, the Oklahoma

18 Commission, the Department of Labor, the Department
19 of Mines, the Oklahoma Tourism and Recreation
20 Department, the Oklahoma Water Resources Board, the
21 Alcoholic Beverage Laws Enforcement Commission, the
22 Department of Corrections, the Oklahoma State Bureau
23 of Investigation, the Council on Law Enforcement
24 Education and Training, the Board of Medicolegal
Investigations, the Oklahoma State Bureau of
Narcotics and Dangerous Drugs Control, the Department
of Public Safety, the Court of Criminal Appeals,
district attorneys and the District Attorneys
Council, the Supreme Court, the Oklahoma Indigent
Defense System and the Pardon and Parole Board;
stating amounts of the appropriations; stating
purposes and restrictions; reappropriating and
redesignating certain funds; reappropriating certain
funds; authorizing transfers; repealing Sections 1
through 169, Chapter 371, O.S.L. 2017, which relate
to general appropriations for the expenses of various
agencies of the executive, legislative and judicial
departments of state; and repealing Sections 76, 82,
91, 146 and 169 of Enrolled House Bill No. 1019 of
the 1st Extraordinary Session of the 56th Oklahoma
Legislature, which relate to general appropriations
for the expenses of various agencies of the executive
departments of the state.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 EDUCATION

3 SECTION 1. There is hereby appropriated to the Oklahoma
4 Education Lottery Trust Fund from any monies not otherwise
5 appropriated from the Special Cash Fund of the State Treasury, the
6 sum of Ten Million One Hundred Forty-four Thousand One Hundred
7 Seventy-one Dollars (\$10,144,171.00) or so much thereof as may be
8 necessary pursuant to the provisions of subsection E of Section 713
9 of Title 3A of the Oklahoma Statutes.

10 SECTION 2. There is hereby appropriated to the State Board of
11 Education from any monies not otherwise appropriated from the
12 General Revenue Fund of the State Treasury for the fiscal year
13 ending June 30, 2018, the sum of One Billion Twenty-one Million
14 Seventy-two Thousand Two Hundred Sixty-seven Dollars
15 (\$1,021,072,267.00) or so much thereof as may be necessary for the
16 financial support of public schools.

17 SECTION 3. There is hereby appropriated to the State Board of
18 Education from any monies not otherwise appropriated from the
19 Education Reform Revolving Fund created in Section 34.89 of Title 62
20 of the Oklahoma Statutes, the sum of Six Hundred Ninety-five Million
21 Four Hundred Seven Thousand One Hundred Thirty-eight Dollars
22 (\$695,407,138.00) or so much thereof as may be necessary for the
23 financial support of public schools.

1 SECTION 4. The State Board of Education is hereby authorized to
2 expend during the fiscal year ending June 30, 2018, from the Common
3 Education Technology Revolving Fund of the State Treasury, the sum
4 of Forty-seven Million Three Hundred Seventy-two Thousand Two
5 Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as
6 may be necessary for the financial support of public schools.

7 SECTION 5. There is hereby appropriated to the State Board of
8 Education from any monies not otherwise appropriated from the
9 Mineral Leasing Fund of the State Treasury for the fiscal year
10 ending June 30, 2018, the sum of Four Million Two Hundred Seventy-
11 five Thousand Dollars (\$4,275,000.00) or so much thereof as may be
12 necessary for the financial support of public schools.

13 SECTION 6. There is hereby appropriated to the State Board of
14 Education from any monies not otherwise appropriated from the
15 Mineral Leasing Fund of the State Treasury for the fiscal year
16 ending June 30, 2016, the sum of Two Million Six Hundred Twenty-four
17 Thousand Thirty-eight Dollars (\$2,624,038.00) or so much thereof as
18 may be necessary for the financial support of public schools.

19 SECTION 7. There is hereby appropriated to the State Board of
20 Education from any monies not otherwise appropriated from the
21 Oklahoma Education Lottery Trust Fund of the State Treasury for the
22 fiscal year ending June 30, 2018, the sum of Twenty-five Million
23 Nine Hundred Thirty-nine Thousand Nine Hundred Ten Dollars

1 (\$25,939,910.00) or so much thereof as may be necessary for the
2 financial support of public schools.

3 SECTION 8. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the
6 fiscal year ending June 30, 2016, the sum of Five Million Four
7 Hundred Twenty-nine Thousand Eight Hundred Forty-four Dollars
8 (\$5,429,844.00) or so much thereof as may be necessary for the
9 financial support of public schools.

10 SECTION 9. Notwithstanding any other provision of law, the
11 State Board of Education is hereby authorized to expend during the
12 fiscal year ending June 30, 2018, from the School Consolidation
13 Assistance Fund (260 Fund), the sum of Two Million Five Hundred
14 Thousand Dollars (\$2,500,000.00) or so much thereof as may be
15 necessary for the financial support of public schools.

16 SECTION 10. There is hereby appropriated to the State Board of
17 Education from any monies not otherwise appropriated from the
18 General Revenue Fund of the State Treasury for the fiscal year
19 ending June 30, 2018, the sum of Ninety-one Million Three Hundred
20 Nineteen Thousand Twenty-six Dollars (\$91,319,026.00) or so much
21 thereof as may be necessary for the support of public schools
22 activities.

23 SECTION 11. There is hereby appropriated to the State Board of
24 Education from any monies not otherwise appropriated from the

1 General Revenue Fund of the State Treasury for the fiscal year
2 ending June 30, 2018, the sum of Two Hundred Ninety-nine Million
3 Three Hundred Twenty Thousand Three Hundred Forty Dollars
4 (\$299,320,340.00) or so much thereof as may be necessary for the
5 Certified Employee Health Benefit Allowance.

6 SECTION 12. There is hereby appropriated to the State Board of
7 Education from any monies not otherwise appropriated from the
8 General Revenue Fund of the State Treasury for the fiscal year
9 ending June 30, 2018, the sum of One Hundred Sixty-three Million
10 Three Hundred Seventy-five Thousand Six Hundred Twenty-seven Dollars
11 (\$163,375,627.00) so much thereof as may be necessary for the
12 Support Personnel Health Benefit Allowance.

13 SECTION 13. There is hereby appropriated to the State Board of
14 Education from any monies not otherwise appropriated from the
15 General Revenue Fund of the State Treasury for the fiscal year
16 ending June 30, 2018, the sum of Fifteen Million Five Hundred Fifty-
17 two Thousand Five Hundred Twenty Dollars (\$15,552,520.00) or so much
18 thereof as may be necessary for administrative and support functions
19 of the State Department of Education.

20 SECTION 14. There is hereby appropriated to the State Board of
21 Education from any monies not otherwise appropriated from the
22 Oklahoma Education Lottery Trust Fund of the State Treasury for the
23 fiscal year ending June 30, 2018, the sum of Two Million Eight
24 Hundred Eighty-two Thousand Two Hundred Thirteen Dollars

1 (\$2,882,213.00) or so much thereof as may be necessary for transfer
2 to the School Consolidation Assistance Fund.

3 SECTION 15. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the
6 fiscal year ending June 30, 2016, the sum of Six Hundred Three
7 Thousand Three Hundred Sixteen Dollars (\$603,316.00) or so much
8 thereof as may be necessary for transfer to the School Consolidation
9 Assistance Fund.

10 SECTION 16. There is hereby appropriated to the State Board of
11 Education from any monies not otherwise appropriated from the
12 Oklahoma Education Lottery Trust Fund of the State Treasury for the
13 fiscal year ending June 30, 2018, the sum of Two Million Eight
14 Hundred Eighty-two Thousand Two Hundred Thirteen Dollars
15 (\$2,882,213.00) or so much thereof as may be necessary for transfer
16 to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

17 SECTION 17. There is hereby appropriated to the State Board of
18 Education from any monies not otherwise appropriated from the
19 Oklahoma Education Lottery Trust Fund of the State Treasury for the
20 fiscal year ending June 30, 2016, the sum of Six Hundred Three
21 Thousand Three Hundred Sixteen Dollars (\$603,316.00) or so much
22 thereof as may be necessary for transfer to the Teachers' Retirement
23 System Dedicated Revenue Revolving Fund.

1 SECTION 18. There is hereby appropriated to the Oklahoma Arts
2 Council from any monies not otherwise appropriated from the General
3 Revenue Fund of the State Treasury for the fiscal year ending June
4 30, 2018, the sum of Two Million Seven Hundred Seventy-six Thousand
5 Six Hundred Thirty-nine Dollars (\$2,776,639.00) or so much thereof
6 as may be necessary to perform the duties imposed upon the Oklahoma
7 Arts Council by law.

8 SECTION 19. There is hereby appropriated to the State Board of
9 Career and Technology Education from any monies not otherwise
10 appropriated from the General Revenue Fund of the State Treasury for
11 the fiscal year ending June 30, 2018, the sum of One Hundred Seven
12 Million Four Hundred Thirty-five Thousand One Hundred Thirty-seven
13 Dollars (\$107,435,137.00) or so much thereof as may be necessary to
14 perform the duties imposed upon the State Board of Career and
15 Technology Education by law.

16 SECTION 20. There is hereby appropriated to the State Board of
17 Career and Technology Education from any monies not otherwise
18 appropriated from the Oklahoma Education Lottery Trust Fund of the
19 State Treasury for the fiscal year ending June 30, 2018, the sum of
20 Three Million One Hundred Seventy Thousand Four Hundred Thirty-three
21 Dollars (\$3,170,433.00) pursuant to paragraph 2 of subsection C of
22 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
23 the State Board of Career and Technology Education for the education
24 and general operating budgets of the institutions and for other

1 programs, construction, renovations or repairs administered by the
2 State Board of Career and Technology Education.

3 SECTION 21. There is hereby appropriated to the State Board of
4 Career and Technology Education from any monies not otherwise
5 appropriated from the Oklahoma Education Lottery Trust Fund of the
6 State Treasury for the fiscal year ending June 30, 2016, the sum of
7 Six Hundred Sixty-three Thousand Six Hundred Forty-eight Dollars
8 (\$663,648.00) pursuant to paragraph 2 of subsection C of Section 713
9 of Title 3A of the Oklahoma Statutes for allocation by the State
10 Board of Career and Technology Education for the education and
11 general operating budgets of the institutions and for other
12 programs, construction, renovations or repairs administered by the
13 State Board of Career and Technology Education.

14 SECTION 22. Notwithstanding any other provision of law, the
15 State Board of Career and Technology Education is hereby authorized
16 to expend during the fiscal year ending June 30, 2018, from the
17 State Board of Career and Technology Education Revolving Fund (200
18 Fund), the sum of Five Hundred Thousand Dollars (\$500,000.00) or so
19 much thereof as may be necessary to perform the duties imposed upon
20 the State Board of Career and Technology Education by law.

21 SECTION 23. There is hereby appropriated to the Office of
22 Educational Quality and Accountability from any monies not otherwise
23 appropriated from the General Revenue Fund of the State Treasury for
24 the fiscal year ending June 30, 2018, the sum of One Million One

1 Hundred Twelve Thousand Four Hundred Sixty-nine Dollars
2 (\$1,112,469.00) or so much thereof as may be necessary to perform
3 the duties imposed upon the Office of Educational Quality and
4 Accountability by law.

5 SECTION 24. There is hereby appropriated to the Office of
6 Educational Quality and Accountability from any monies not otherwise
7 appropriated from the Special Cash Fund of the State Treasury the
8 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much
9 thereof as may be necessary to perform the duties imposed upon the
10 Office of Educational Quality and Accountability by law.

11 SECTION 25. There is hereby appropriated to the Oklahoma
12 Educational Television Authority from any monies not otherwise
13 appropriated from the General Revenue Fund of the State Treasury for
14 the fiscal year ending June 30, 2018, the sum of Two Million Six
15 Hundred Eighty-two Thousand Eighteen Dollars (\$2,682,018.00) or so
16 much thereof as may be necessary to perform the duties imposed upon
17 the Oklahoma Educational Television Authority by law.

18 SECTION 26. There is hereby appropriated to the Oklahoma State
19 Regents for Higher Education from any monies not otherwise
20 appropriated from the General Revenue Fund of the State Treasury for
21 the fiscal year ending June 30, 2018, the sum of Six Hundred Forty-
22 one Million Nine Hundred Ninety-two Thousand Six Hundred Three
23 Dollars (\$641,992,603.00) or so much thereof as may be necessary for
24 allocation by the Oklahoma State Regents for Higher Education

pursuant to the provisions of Article XIII-a of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education. Of those funds appropriated, the sum of Two Million Nine Hundred Ninety-four Thousand One Hundred Fifty-six Dollars (\$2,994,156.00) shall be transferred to the Oklahoma Tuition Equalization Grant Trust Fund to implement the provisions of the Oklahoma Tuition Equalization Grant Act.

SECTION 27. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2018, the sum of Forty-seven Million Three Hundred Seventy-two Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the Higher Education Capital Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-a of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 28. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2018, the sum of Forty-seven Million Three Hundred Seventy-two Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the

Oklahoma Student Aid Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-a of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 29. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2018, the sum Nine Hundred Sixty-four Thousand Eight Hundred Twenty-three Dollars (\$964,823.00) or so much thereof as may be necessary for expenditures for concurrent enrollment pursuant to Section 628.13 of Title 70 of the Oklahoma Statutes.

SECTION 30. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2018, the sum of Twenty-two Million Seven Hundred Sixty-nine Thousand Four Hundred Seventy-seven Dollars (\$22,769,477.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-a of the Oklahoma

1 Constitution for construction, renovations or repairs administered
2 by the Oklahoma State Regents for Higher Education or for any other
3 purpose authorized by paragraph 2 of subsection C of Section 713 of
4 Title 3A of the Oklahoma Statutes.

5 SECTION 31. There is hereby appropriated to the Oklahoma State
6 Regents for Higher Education from any monies not otherwise
7 appropriated from the Oklahoma Education Lottery Trust Fund of the
8 State Treasury for the fiscal year ending June 30, 2016, the sum of
9 Four Million Seven Hundred Sixty-six Thousand One Hundred Ninety-
10 seven Dollars (\$4,766,197.00) pursuant to paragraph 2 of subsection
11 C of Section 713 of Title 3A of the Oklahoma Statutes for allocation
12 by the Oklahoma State Regents for Higher Education pursuant to the
13 provisions of Article XIII-a of the Oklahoma Constitution for
14 construction, renovations or repairs administered by the Oklahoma
15 State Regents for Higher Education or for any other purpose
16 authorized by paragraph 2 of subsection C of Section 713 of Title 3A
17 of the Oklahoma Statutes.

18 SECTION 32. There is hereby appropriated to the Oklahoma State
19 Regents for Higher Education from any monies not otherwise
20 appropriated from the General Revenue Fund of the State Treasury for
21 the fiscal year ending June 30, 2018, the sum of Three Million Six
22 Hundred Forty Thousand Nine Hundred Sixty-nine Dollars
23 (\$3,640,969.00) or so much thereof as may be necessary for the
24

1 general operating budget of the Administrative Offices of the
2 Oklahoma State Regents for Higher Education.

3 SECTION 33. There is hereby appropriated to the Commissioners
4 of the Land Office from any monies not otherwise appropriated from
5 the Commissioners of the Land Office Fund of the State Treasury for
6 the fiscal year ending June 30, 2018, the sum of Eight Million Five
7 Hundred Thirty-eight Thousand Six Hundred Dollars (\$8,538,600.00) or
8 so much thereof as may be necessary to perform the duties imposed
9 upon the Commissioners of the Land Office by law.

10 SECTION 34. There is hereby appropriated to the Oklahoma
11 Department of Libraries from any monies not otherwise appropriated
12 from the General Revenue Fund of the State Treasury for the fiscal
13 year ending June 30, 2018, the sum of Four Million Three Hundred
14 Fifty-seven Thousand Six Hundred Eighty-two Dollars (\$4,357,682.00)
15 or so much thereof as may be necessary to perform the duties imposed
16 upon the Oklahoma Department of Libraries by law.

17 SECTION 35. There is hereby appropriated to the Physician
18 Manpower Training Commission from any monies not otherwise
19 appropriated from the General Revenue Fund of the State Treasury for
20 the fiscal year ending June 30, 2018, the sum of Two Million Eight
21 Hundred Ninety-two Thousand Eight Hundred Fifty-two Dollars
22 (\$2,892,852.00) or so much thereof as may be necessary to perform
23 the duties imposed upon the Physician Manpower Training Commission
24 by law.

1 SECTION 36. There is hereby appropriated to the Physician
2 Manpower Training Commission from any monies not otherwise
3 appropriated from the Special Cash Fund of the State Treasury the
4 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much
5 thereof as may be necessary to perform the duties imposed upon the
6 Physician Manpower Training Commission by law.

7 SECTION 37. There is hereby appropriated to the Board of
8 Trustees of the Oklahoma School of Science and Mathematics from any
9 monies not otherwise appropriated from the General Revenue Fund of
10 the State Treasury for the fiscal year ending June 30, 2018, the sum
11 of Six Million Eighty-two Thousand Three Hundred Ninety-seven
12 Dollars (\$6,082,397.00) or so much thereof as may be necessary to
13 perform the duties imposed upon the Board of Trustees of the
14 Oklahoma School of Science and Mathematics by law.

15 SECTION 38. There is hereby appropriated to the Oklahoma Center
16 for the Advancement of Science and Technology from any monies not
17 otherwise appropriated from the General Revenue Fund of the State
18 Treasury for the fiscal year ending June 30, 2018, the sum of
19 Thirteen Million Three Hundred Thirty-three Thousand Eight Hundred
20 Fifty-five Dollars (\$13,333,855.00) or so much thereof as may be
21 necessary to perform the duties imposed upon the Oklahoma Center for
22 the Advancement of Science and Technology by law. Of those funds
23 appropriated, the sum of Five Million Three Hundred Thirty-three
24 Thousand Five Hundred Forty-two Dollars (\$5,333,542.00) shall be

1 deposited in the Research Support Revolving Fund, created pursuant
2 to Section 5060.11 of Title 74 of the Oklahoma Statutes. Of those
3 funds appropriated, the sum of Two Million Nine Hundred Thirty-three
4 Thousand Four Hundred Forty-eight Dollars (\$2,933,448.00) shall be
5 deposited in the Seed-Capital Revolving Fund, created pursuant to
6 Section 5060.21 of Title 74 of the Oklahoma Statutes.

7 GENERAL GOVERNMENT AND TRANSPORTATION

8 SECTION 39. There is hereby appropriated to the Office of the
9 Attorney General from any monies not otherwise appropriated from the
10 General Revenue Fund of the State Treasury for the fiscal year
11 ending June 30, 2018, the sum of Nine Million One Hundred Ten
12 Thousand Twenty-one Dollars (\$9,110,021.00) or so much thereof as

16 (\$15,854,326.00) or so much thereof as may be necessary to perform
17 the duties imposed upon the Oklahoma Indigent Defense System by law.

18 SECTION 142. There is hereby appropriated to the Pardon and
19 Parole Board from any monies not otherwise appropriated from the
20 General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2018, the sum of Two Million One Hundred Sixty-seven
22 Thousand Eight Hundred Six Dollars (\$2,167,806.00) or so much
23 thereof as may be necessary to perform the duties imposed upon the

16 of Enrolled House Bill No. 1019 of the 1st Extraordinary Session of
17 the 56th Oklahoma Legislature, are hereby repealed.
