From the funds appropriated to the Department of Mental Health and Substance Abuse Services in Enrolled Senate Bill 20 21 No. 1600 of the 2nd Session of the 56th Oklahoma Legislature, a sum 22 of not less than Two Million Dollars (\$2,000,000.00) shall be used 23 in conjunction with funding described in Section 3 of this act 24 towards restoring psychiatric inpatient, substance abuse

residential, psychologist and agency-based therapy provider rates by three percent (3%).

SECTION 2. From the funds appropriated to the Department of Mental Health and Substance Abuse Services in Enrolled Senate Bill No. 1600 of the 2nd Session of the 56th Oklahoma Legislature, the sum of Four Million Dollars (\$4,000,000.00) shall be used for needs assessments.

SECTION 3. Any increase in federal funding related to an increase in the Federal Medical Assistance Percentage (FMAP) match rate shall be expended by the Department of Mental Health and Substance Abuse Services with priority given to addressing the agency's maintenance needs first, which shall mean maintaining current levels of services, addressing provider rates as described in Section 1 of this act and addressing caps in therapy and case management services imposed during the preceding twenty-four-month period.

SECTION 4. The Commissioner of the Department of Mental Health and Substance Abuse Services may request through the Director of the Office of Management and Enterprise Services the early transfer by the Oklahoma Tax Commission of tax collections to the General Revenue Fund for the purpose of early allocation to the Department's disbursing funds to alleviate cash-flow problems.

SECTION 5. Appropriations made by Enrolled Senate Bill No. 1600 of the 2nd Session of the 56th Oklahoma Legislature, not including
