9 AS INTRODUCED

10 An Act relating to the Oklahoma Education Lottery  
11 Trust Fund; making appropriation to the Oklahoma  
Education Lottery Trust Fund; and declaring an  
12 emergency.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. There is hereby appropriated to the Oklahoma  
16 Education Lottery Trust Fund from any monies not otherwise  
17 appropriated from the Unclaimed Property Fund (711 Fund) the sum of  
18 Nineteen Million Eight Hundred Ninety-two Thousand Seven Hundred  
19 Forty-four Dollars (\$19,892,744.00) or so much thereof as may be  
20 necessary pursuant to the provisions of subsection E of Section 713  
21 of Title 3A of the Oklahoma Statutes.

22 SECTION 2. It being immediately necessary for the preservation  
23 of the public peace, health or safety, an emergency is hereby  
24

1 declared to exist, by reason whereof this act shall take effect and  
2 be in full force from and after its passage and approval.
