COMMITTEE SUBSTITUTE

An Act relating to public finance; stating intent of
the Legislature; recodifying certain provisions
relating to Master Settlement Agreement compliance;
providing for noncodification.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law not to be
codified in the Oklahoma Statutes reads as follows:

It is the intent of the Legislature with this act to recodify
the recodification sections, specified in this act, in Enrolled
Senate Bill No. 383 of the 2nd Session of the 55th Oklahoma
Legislature. The result shall be for those sections of law to
remain codified with the respective numbering in Title 37 of the
Oklahoma Statutes for the purpose of maintaining accuracy of the
exhibits citing references to the aforementioned sections of law as

1 part of the Master Settlement Agreement and the Non-Participating
2 Manufacturer Adjustment Arbitration Settlement Agreement.

3 SECTION 2. RECODIFICATION 37 O.S. 2011, Section 600.21,
4 as recodified by Section 185, Chapter 366, O.S.L. 2016, shall be
5 recodified as Section 600.21 of Title 37 of the Oklahoma Statutes,
6 unless there is created a duplication in numbering.

7 SECTION 3. RECODIFICATION 37 O.S. 2011, Section 600.22,
8 as recodified by Section 186, Chapter 366, O.S.L. 2016, shall be
9 recodified as Section 600.22 of Title 37 of the Oklahoma Statutes,
10 unless there is created a duplication in numbering.

11 SECTION 4. RECODIFICATION 37 O.S. 2011, Section 600.23,
12 as recodified by Section 187, Chapter 366, O.S.L. 2016 shall be
13 recodified as Section 600.23 of Title 37 of the Oklahoma Statutes,
14 unless there is created a duplication in numbering.
