11 An Act relating to the Oklahoma Department of  
12 Agriculture, Food, and Forestry; requiring that  
portions of certain appropriated funds be used for  
13 certain purposes; providing an effective date; and  
declaring an emergency.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. From the funds appropriated to the Oklahoma  
18 Department of Agriculture, Food, and Forestry in Enrolled Senate  
19 Bill No. 1600 of the 2nd Session of the 56th Oklahoma Legislature,  
20 the sum of Three Million Four Hundred Thousand Nine Hundred Ninety-  
21 one Dollars (\$3,400,991.00) shall be used to provide for the Rural  
22 Fire Operational Assistance Grants.

23 SECTION 2. From the funds appropriated to the Oklahoma  
24 Department of Agriculture, Food, and Forestry in Enrolled Senate

1 Bill No. 1600 of the 2nd Session of the 56th Oklahoma Legislature,  
2 the sum of Three Hundred Twenty-five Thousand Dollars (\$325,000.00)  
3 shall be used to provide for the 80/20 Reimbursable Grant program.

4 SECTION 3. From the funds appropriated to the Oklahoma  
5 Department of Agriculture, Food, and Forestry in Enrolled Senate  
6 Bill No. 1600 of the 2nd Session of the 56th Oklahoma Legislature,  
7 the sum of Three Hundred Forty-three Thousand Three Hundred Twenty-  
8 five Dollars (\$343,325.00) shall be used to provide for the Made in  
9 Oklahoma program.

10 SECTION 4. This act shall become effective July 1, 2018.

11 SECTION 5. It being immediately necessary for the preservation  
12 of the public peace, health or safety, an emergency is hereby  
13 declared to exist, by reason whereof this act shall take effect and  
14 be in full force from and after its passage and approval.
