11 An Act relating to the Constitutional Reserve Fund;
12 making an appropriation; stating purpose; and
13 declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. There is hereby appropriated to the Department of
17 Mental Health and Substance Abuse Services from any monies not
18 otherwise appropriated from the Constitutional Reserve Fund of the
19 State Treasury the sum of Twenty-three Million Three Hundred Thirty-
20 eight Thousand One Hundred Seventy Dollars (\$23,338,170.00) or so
21 much thereof as may be necessary to perform the duties imposed upon
22 the Department of Mental Health and Substance Abuse Services by law.

23 SECTION 2. It being immediately necessary for the preservation
24 of the public peace, health or safety, an emergency is hereby

1 declared to exist, by reason whereof this act shall take effect and
2 be in full force from and after its passage and approval.
