15	SECTION 1. There is hereby appropriated to the Oklahoma Health
16	Care Authority from any monies not otherwise appropriated from the
17	General Revenue Fund of the State Treasury for the fiscal year
18	ending June 30, 2018, the sum of Seventeen Million Seven Hundred
19	Eleven Thousand Six Hundred Ninety-seven Dollars (\$17,711,697.00) or
20	so much thereof as may be necessary to perform the duties imposed
21	upon the Oklahoma Health Care Authority by law.
22	SECTION 2. It being immediately necessary for the preservation
