COMMITTEE SUBSTITUTE

An Act relating to appropriations; making an  
appropriation to the Oklahoma Health Care Authority;  
stating purpose; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. There is hereby appropriated to the Oklahoma Health  
Care Authority from any monies not otherwise appropriated from the  
General Revenue Fund of the State Treasury for the fiscal year  
ending June 30, 2017, the sum of Twenty-nine Million Four Hundred  
Ninety Thousand Dollars (\$29,490,000.00) or so much thereof as may  
be necessary to perform the duties imposed upon the Oklahoma Health  
Care Authority by law.

SECTION 2. It being immediately necessary for the preservation  
of the public peace, health or safety, an emergency is hereby

1 declared to exist, by reason whereof this act shall take effect and  
2 be in full force from and after its passage and approval.
